Minutes:

A Bill for an Act to amend and reenact section 4-14.1-05 of the North Dakota Century Code, relating to compensation of members of the agricultural products utilization commission.

1A:2012: Chairman Nicholas: We will open the hearing on HB1095.

I believe Mr. Gaebe is here and will give us some testimony on 1095.

1A:2030: Mr. Gaebe: Thank you Chairman Nicholas. My name is Lance Gaebe. I work with the executive director of Agriculture Products Utilization Commission which is presenting this bill I guess you guys are presenting requested Agriculture Products Utilization Commission. I'm the sole employee of that commission, it is covered by state statues for two primary purposes One is to disperse the ethanol program. Ethanol production program expenses grants which amounts to about \$1.500.000.00 for Ethanol for ethanol production and probable we are better know for dispersing grants. I did not provide any written testimony for you this morning because the Bill is self explanatory. Really because of an audit that happened three weeks after

I started this spring. There are nine members on the commission, five of whom are appointed by the Governor, one appointed by the Agriculture Commissioner and the three other are statutory members are President of N.D.S.U., the Agriculture Commissioner and director of (??) but the other six are entitled to receive compensation of a per-deim of fifty dollars per day for meeting attended and the chairman was receiving and additional one hundred dollars per day and what happened in the audit we realized that the other members were meeting with the Governor etc., the other members were not receiving per-deim. In the write up as to the audit we decided to raise the compensation to the level other commission members receive. You will note there is a FISCAL NOTE attached to this bill. This is the first FISCAL NOTE that I have ever prepared and I hope it is somewhat understandable but really it's fairly minor cost to make this increase. That is why the Agricultural Commission is getting this Bill rather then the Appropriations Committee. I will be happy to respond to any questions.

<u>Chairman Nicholas:</u> What is your total budget? What are your grants? What are you bringing in. I know that is not pertinent to the Bill.

Mr. Gaebe: Our appropriations authority is we have the authority to grant three million dollars but our collections are not up to what are appropriations. We have the authority to collect nine hundred and ninety five thousand dollars from the Agricultural Fuel Tax Fund. That fund is declining. We will collect about six hundred and—thirty five thousand. We also have the authority to receive five hundred thousand in grants. We have only been able to quality for one hundred thousand so we are collecting substantially less then we are authorized to receive. So, the short answer to your question is that we are able to provide slightly less then—a million dollars in grants.

The appointed Commission members are currently authorized to receive \$50 per diem per meeting attended, the chair is entitled to an additional \$100 per meeting. The changes suggested in this bill would create two changes 1) the per diem for commission members is increased by \$12.50 per day and 2) that per diem can be disbursed for time spent on other official business of the commission outside of meetings. The section will slightly increase the administrative expense of the APUC, but will not hinder its ability to remain under the 10% adminstrative expense cap required in NDCC 4-14.1-06. The expense will be part of the operating budget of the commission.

The commission meets quarterly for two days and holds a one day organizational meeting annually. These nine days multiplied by \$50 multiplied by the two years in the bienium for the five members entitled to receive this per diem yields \$4500 current expenditure. Likewise the chair is entitled to an additional \$100, hilarily calculated yields \$2700.

he proposed change would increase the cost to \$5625 for the five members and to \$2925 for the chair.

$$5625 + 2925 = 8550$$

$$4500 + 2700 = 7200$$

$$8550 - 7200 = 1350$$

In addition, the proposed change would compensate members for business conducted outside of meetings, an estimate of twenty yearly incidences of commissioners participating in official APUC business was used to calculate the additional \$2500 potential expenditure.
