Minutes: Chairman Krebsbach orched the hearing on HB 1124 which relates to review and adjustment of rates for legal notices by the office of management and budget. Appearing before the committee to explain the bill was Linda Engmann, Director of Central Services Division of OMB. A copy of her written testimony is attached. Chairman Krebsbach inquired if election of a paper is done annually or biennially. Ms. Engmann indicated that every newspaper submits what their legal rate will be for legal publications so it is every newspaper. We approve or disapprove the rates based on what we feel is acceptable or not. Generally the recommendations of the newspapers and the newspaper association are consistent standard rates. There were no further questions. Jack McDonald representing the North Dakota Newspaper Association indicated that his group supports HB 1124 and recommends a Do Pass. Senator C. Nelson inquired how he interprets the phrase as soon as practicable. Mr. McDonald he believes it means as soon as they are able to do it. It's kind of the same thing as when they say a reasonable time in some other statutes and he thinks you look at that as what it says. In this case what

actually happens is that the newspaper association gathers newspapers and submits them to the office of management and budget and then they determine in there what the size of their columns are. They do not submit anything unless something changes in there and then they submit a new application. In this case sometimes the submissions do not all come in at once. They submit some and then submit others. OMB then issues a rate all at one time. It never has been determined that there is a 15 days that make the completion. It has never been followed so it does work out to be as soon as possible. There have been no problems. He believes it is just a matter of getting rid of the absolute deadline. Senator C. Nelson inquired about how far into the future does he see not publishing things in newspapers but instead having a lot of things done on electronic media. Mr. McDonald indicated while that is happening right now he doesn't see it going away in the near future as long we do have newspapers, for a couple of reasons. One of the problems of electronic publishing is that you don't know who does see it and who doesn't see it, who has that available to them. Right now the newspaper association does have a web page that they put up all legal notices on. He doesn't know if the actual electronic publishing will ever entirely supplant publishing in a newspaper, but it will go hand in hand. Newspapers still have the greater coverage of legal notices. The legal notice rates are the same throughout the state. This statute sets the rates. Senator Wardner inquired if Administrative Rules are under this statute as well. Mr. McDonald indicated they are. Senator Dever inquired about how often legal rates change. He was of the impression that they changed annually. Mr. McDonald indicated they do not change annually. Rather they change about once every 3 to 4 years. There was no further testimony in support of, in neutral position on, or in opposition to HB 1124. Chairman Krebsbach closed the hearing at this time. Discussion on HB 1124 was opened. A motion for a Do Pass was made by Senator C. Nelson, seconded by Senator Kilzer. Roll Call

#### TESTIMONY

Chairman Klein and members of the committee, my name is Linda Engmann. I am the director of Central Services Division of the Office of Management and Budget.

This bill allows OMB to award certificates for legal rates to newspapers in the state as soon after as is practicable after the 15 day requirement. Sometimes circumstances do not allow the issuing of the certificates within the 15 days such as incomplete samples from the newspapers or errors in computing the rate that need to be resolved. We would not want to be in violation of statute because the certificates were issued on the 16<sup>th</sup>, 17<sup>th</sup> or 18<sup>th</sup> day.

This bill also changes the requirement for OMB to review the legal rates biennially rather than annually. Legal rates generally don't change annually.

I'm Roger Bailey. I'm appearing today on behalf of the members of the North Dakota Newspaper Association.

The newspapers of North Dakota support HB 1124 as requested by the Office of Management and Budget.

Reviewing state public notice advertising rates biennially rather than annually will match the state's two-year budget cycle.

As you may be aware, public notice rates – sometimes called "legal" rates – are not set by the newspapers but are determined by the Office of Management and Budget. The perline base rate is the same for all newspapers no matter their location or circulation. The newspapers of North Dakota have appreciated the cooperative efforts of the Office of Management and Budget in the past and we look forward to working with OMB in the future.
