Minutes:Rep. Weisz - Chairman opened the hearing on House Bill 1147; A BILL RELATING TO USE OF PERSONAL MOTOR VEHICLES BY STATE EMPLOYEES.

Shelia Peterson(138), the Director of the Fiscal Management Division of the Office of Management and Budget -- the agency sponsor -- spoke. See her written testimony attached.

Rep. Price: (470) During the last session we passed a bill for reimbursement of the handicapped; is this going to have any affect on their reimbursement? We did some thing about special rates for them under special circumstances -- is this going change that?

Sheila Peterson (497) I am going to defer your question to Paul Feyereisen but I do want to insured that we had no intention to impact them. Paul --

Paul Feyereisen(539) I am Director of State Fleet Services, yes, we got that passed 2 years ago for the purpose of allowing state employees who had a disability to have an incentive to drive their personal vehicle. In a sense it would affect us do to the fact and we have introduced HB1186 to address. So we will be back here to elaborate of this issue. All it is, is to change the formula. Because the incentive is not great enough today for an employee who has a disability who has personal vehicle which accommodates his disabilities to drive for state business -- consequently they want you provide a vehicle for them at great cost to us. So our new formula will be in the other bill and this one here -- Sheila's will not affect the disabled employee.

Rep. Weisz - Chairman: (594) If I understand the second section, it authorizes the official to authorize him to authorize himself and his deputies to use their personal vehicles?

Sheila Peterson: I believe they already have that authority.

Rep. Carlson: (649) Where the liability issue here? If some one is driving their own and has an accident?

Sheila Peterson - I visited with head of our risk management division who advised that if a state employee is driving their own vehicle, their own liability insurance will prevail.

Rep. Carlson: So they would be assuming some risk.

Sheila Peterson: Yes. The only time they would not would be when all state fleet vehicles were in use and that was what forced them to use their own vehicle then in that instance the state would assume the liability. Those instances are quite rare.

Rep. Jensen: (753) Is it understood that each employee is insured before they were allowed to use their own car?

Sheila Peterson. Yes We have as I understand it from the Highway Department we have a system of checking they have a drivers license before they drive.

No one appeared in opposition to the bill. Testimony on the bill was closed. (835).

Committee discussion followed.( Tape 1 Side 1 meter at about 1951).

Rep. Thoreson: I move a 'Do Pass' on House Bill 1147.

Rep. Jensen: I seconded that motion.

Senator Trenbeath: If the person taking the car has no liability insurance it opens up a risk for the state.

If I could draw your attention to the last sentence of Section 1 prior to the underlined sentence. "Every state agency, institution, department, board, bureau and commission unless exempted by the director must use the system."

The amendment asks for some limited flexibility where an agency "may authorize the use of an employee's personal vehicle."

Let me give you an example. The State Board of Higher Education held their monthly meeting on Thursday and Friday, December 21 and 22 and this meeting was scheduled for Jamestown. My higher education budget analyst attends these

higher education board meetings. After the board meeting was over she continued on to her parents home in Lidgerwood, ND for Christmas weekend. Had I followed the letter of the law, I would have required her to use a state fleet vehicle to attend the board meeting in Jamestown, drive back to Bismarck after the meeting and get in her own vehicle to drive to Lidgerwood – adding 200 miles to her day.
