Minutes:

REP. M. KLEIN called the meeting to order, all committee members were present.

In favor:

DAVE KRABBENHOFT, BUDGET ANALYST, ND OFFICE OF MANAGEMENT AND BUDGET

Please see attached testimony.

REP. M. KLEIN summarizes to the committee that this is legislation of the result of the past legislation. Ran through the bank of North Dakota. Always having to go through a purchase order, a dragged out system, clearing it up with modern technology.

KRABBENHOFT states that the program has worked great. The program has really been going for about a year now. A little over \$700,000.00 of money has went through the eards, and roughly about 6500 transactions. This lets them to cut down on a lot of coding.

REP. HAAS asks how many cards do they have out?

KRABBENHOFT replies that there are around 364 cards and a number of agencies.

REP. HAAS asks what is the average purchase?

KRABBENHOFT replies that it is about \$110.00.

REP. M. KLEIN asks if there was a lot of hesitancy of agencies to go into this? Then when they found out how it works, really jumped in with both feet?

KRABBENHOFT replies that yes some are like that, they were cautiously optimistic, then they jumped into it right away. Some agencies have very detailed coding though. But we are trying to convince them to maybe relook at their accounting systems, and not at the minimum transaction numbers.

Not in favor or opposition:

#### SHANNON SAUER, NDDOT

<u>SAUER</u> states that their major concern with the bill is that the OMB requires the agencies to come on board. However it maybe amended. The impact that it would have on the rural maintenance sections. It would involve 100-150 individuals. Most of them are located in 66 sections in rural communities.

REP. M. KLEIN talks about an amendment.

REP. BELLEW asks if the DOT is currently purchasing purchase orders now? Do they not have to reconcile these at the end of the month?

<u>SAUER</u> replies that they do have a department purchase order, and most of it is done locally.

The document is then forwarded to the district office, then receives final approval and is coded.

REP, BELLEW then asks what kind of reconciliation would have to be done with the card?

<u>SAUER</u> replies that each card holder will receive a statement and they would have to go through that statement, much as you would have to do your own personal statements.

<u>REP. HAAS</u> asks if they have had conversations with the OMB, where they have already contemplated requiring you to use this system?

<u>SAUER</u> replies that they have briefly discussed the contents of the bill.

REP. M. KLEIN states that they have showed their case, and that they probably wouldn't be pushed into using the system.

REP. HAAS comments that the establishment of the broad band IT system would enable them to get on line.

REP. M. KLEIN states that many of the towns that they are in are not on the system yet.

REP. MEIER asks if the main concern would be the hours that this would additionally tack on.

SAUER replies that yes that is a concern.

REP. MEIER asks if he has a guesstimate in how many more hours it would take?

<u>SAUER</u> replies that it would take a couple more hours a month.

REP. M. KLEIN addresses the committee with his thoughts. Maintenance operators are not office staff.

<u>SAUER</u> replies that is correct. They are classified as equipment operators.

REP. DEVLIN asks as a follow up question, as a snow plow operator in one of the rural sections, wouldn't they review the bills for that office somehow?

<u>SAUER</u> replies that they would not review the bills, they would only prepare the documents.

REP. DEVLIN asks then that he would never see the local statements, say from the local co-op?

SAUER replies that he would get at the time of purchase a receipt that will go into that document.

REP. M. KLEIN asks then where is that processed at?

SAUER replies that it is put into the district office, and the check is processed out of Bismarck.

REP, KASPER asks why would the system change with a purchasing card?

<u>SAUFR</u> replies that the reconciliation of the statement is to be done by the eard holder. It would be done by the people.

KRABBENHOFT is back up speaking to the committee.

KRABBENHOFT states that there is electronically coding in the card, so the loss of flexibility is that if you wanted to change the coding you couldn't.

REP. KLEMIN asks if SAUER thinks that this going to create additional work and

KRABBENHOFT thinks that it will eliminate additional paperwork?

KRABBENHOFT replies that it shifts the work, and changes the work. If they would just implement the program without looking at your processes. Its going to be a different kind of work. The responsibility for purchasing is down on the employee, and they need to account for that on their own.

REP. KLEMIN asks about reconciling receipts with the monthly statements.

KRABBENHOFT replies that yes they could do that.

REP. HAAS asks are the cards specific to a certain cost center?

KRABBENHOFT replies, yes.

REP. HAAS asks does any particular agency have more than one card?

KRABBENHOFT replies yes they do, there is different funding sources for certain agencies.

REP. M. KLEIN states to the committee that they do not intend to designate, as to the DOT, to be one of the agencies.

KRABBENHOFT replies that is correct.

Minutes: Chairman Krebsbach or ched the hearing on HB 1148 which relates to appearal of vouchers for state purchases made using a purchasing eard and required use of purchasing eards for state purchase costing less than a designated amount. Dave Krabbenhoft, representing the North Dakota Office of Management and Budget presented testimony in support of HB 1148. A copy of his written testimony is attached. Senator T. Mathern inquired if this credit card costs the state 6% or what does it cost? Mr. Krabbenhoft indicated the purchasing card program costs the state absolutely nothing. If we use the card the contract indicates that if we use the card for certain levels of purchasing the state starts to earn rebates. This is really turning out to be a good deal. Senator T. Mathern indicated he did not understand the part about requiring. So you can tell and agency that they have to start using credit cards whether or not they want to use them. Mr. Krabbenhoft indicated that was correct. We are not going to go out and be a tyrant and say that this is what is going to happen. He likes to parallel it to like a situation where agencies move into technology where something is appropriate for an agency to move into and

they are dragging their feet. I think it is fair to say that if OMB hadn't adopted a policy and said that you have to enter information into our accounting system on line now that we would still be getting paper coming up to the office and have the coding done up there. The reason we wanted the bill drafted like this is that when it is an obvious situation and when it is no real reason for the agency to do that or as we progress into the program where there's just no good reason not to be on it, we won't force anybody to be on it. The agencies that have been on it have found it to be very useful. Senator T. Mathern inquired if we have had our Bank of North Dakota consider operating this card? Mr. Krabbenhoft indicated when he got involved in the project the Bank of North Dakota had already stepped away from it. It was their choice that they are not in the business of issuing credit cards and that they would not be a partner or get into that business. Senator Dever inquired what happens if a vendor does not accept credit cards? Mr. **Krabbenhoft** indicated that the only thing that changed is the process in which we make payment. If the vendor does not accept credit cards then the agency can go back to the regular way of actually buying the goods. Senator Dever inquired about the possibility of abuse. Mr. **Krabbenhoft** indicated that the system is geared to prevent abuses. They have seen none so far. Senator Kilzer inquired if they monitor or look at the vendors real carefully. Mr. Krabbenhoft indicated that is up to the agency. Senator Kilzer again inquired how closely receipts are monitored to verify actual purchases made with these cards. Mr. Krabbenhoft indicated it is monitored more closely than it had previously been. There was nothing further. Chairman Krebsbach closed the hearing at this time. Senator Wardner made a motion for a Do Pass on HB 1148, seconded by Senator T. Mathern. Roll Call Vote indicated 5 Yeas, 0 Nays, 1 Absent or Not Voting. Senator Dever will carry the bill.
