Minutes:

REP. KLEIN called the meeting to order, all members were present. REP. KLEIN states that we will open the hearing on HB 1154, and hear testimony in favor first.

LTC ALAN DOHRMAN, STATE JUDGE ADVOCATE with the North Dakota National Guard. Please refer to attached testimony.

REP. KLEIN asks if DORHRMAN if he has any idea what caused this thing to get into the law in the first place? Is this something that came way before World War II?

<u>DOHRMAN</u> replies that he has surveyed a number of states, and that he would venture to say approximately that maybe as high as 50% of these states has similar statutes. There isn't any state that has the adjutant general doing this, but in most states its mostly the Commissioner Veterans Affairs or the Health Department. After World War I, there were bodies not coming home or coming home after the fact. Probably federal benefits, such as burial benefits tied to be able to verify where a veteran is buried. He states that in 1939 there was emergency funding

asked for and the legislature gave \$8,000,00. But his guess is that money has already been spent.

That is the only funding that he is aware of.

In Favor:

RAY HARKEMA with the NORTH DAKOTA VETERANS AFFAIRS, states that he is in support of repealing this section of the century code. He also refers to the Blue Book, which is the Vietnam era. Has a listing of the cemeteries, plot, row, number, etc. Which has all the information if it would be requested.

REP. KLEIN asks if HARKEMA'S office has record where and what location over seas?

HARKEMA replies with a no, the office does not have that attainable to them. The United States department of Affairs has that file.

REP. BELLEW asks about service people that become North Dakota residents, where is their information kept?

<u>HARKEMA</u> replies that when that particular individual is discharged from the service, they have that option. They may pick which state they want their records sent to.

BOB HANSON with the NORTH DAKOTA VETERANS COORDINATING COUNCIL.

Would like to go on record as favoring HB 1154.

Against:

MRS. GARY ZENTZ (representing herself), involved a lot in genealogy. Was concerned with this bill, that it might do away with some records or other genealogy work.

REP. KLEIN asks the committee what are their wishes with the bill at hand?

REP. BRUSEGAARD moves for a DO PASS, seconded by REP. GRANDE.

The motion was approved 13-0, 2 absent and not voting.

REP. METCALF is the carrier of the bill.

Minutes: Chairman Krebsbach called the committee to order. The clerk called the roll.

Chairman Krebsbach opened the hearing on HB 1154 which relates to providing information on the burial locations of wartime veterans and to recording of persons who provided military service during World War II and the Korean hostilities and recording the burial places of wartime veterans. Appearing before the committee to introduce the bill was Brigadier General Michael J. Haugen, Adjutant General of the North Dakota National Guard. A copy of his written testimony was attached. Senator Dever inquired what kind of information is included in the book.

Brigadier General Haugen indicated the list of the names of individuals, social security number, where they were born, residence (county and city), branch of the military they were in, the dates they served, the theaters they served in, and where they were discharged. The information is very complete. Senator C. Nelson inquired if this was the book that was alluded to in a previous hearing where it was indicated that there were several names missing from the book? The General indicated this is the red book but he is not aware that there was any omission

of names from this book. He knows that they do maintain a library of books not only from these conflicts but also from World War I. He believes these are pretty complete listings so he is not aware of any errors. Senator Dever inquired if this book goes through the Persian Gulf War or will be amended to include any future wars. Brigadier General Haugen indicated this book contains only World War II and Korean Veterans. The current data bases are available and now are established with computers. He indicated he is not certain who published the books but now that they are available on computer they may not be put into book form. This book has been published through the Vietnam War. Bob Hanson, North Dakota Veteran's Recording Council appeared before the committee. He indicated that council unanimously supports this bill ands requests that the committee give it a do pass recommendation. There was nothing further from the committee. The hearing on HB 1154 was closed at this time. A motion for a Do Pass on HB 1154 was made by Senator T. Mathern, seconded by Senator C. Nelson. Roll Call Vote indicated 6 Yeas, 0 Nays, 0 Absent or Not Voting. Senator C. Nelson will carry the bill.



This Bill repeals statutes rendered obsolete by time and technology. These Statutes require the recording of service to the state during World War II and the Korean Hostilities and the recording of the burial locations of all wartime veterans.


