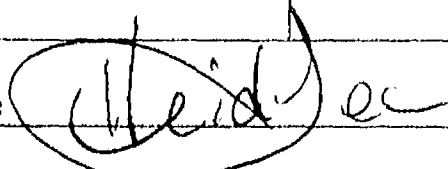

The meeting was called to order. All committee members present. Hearing was opened on HB 1178 relating to name changes of registrants and cancellations of trademarks and trade names filed with the secretary of state.

Al Jaeger, Secretary of State, in favor. Written testimony attached. Engrossed because after it was introduced we found out some changes were needed and the House did that. Intent is to bring consistency to state law and make it user-friendly for limited liability companies, limited partnerships, limited liability partnerships, and limited liability limited partnerships.

Senator Klein: Someone has trademark or name under these business structures, if they went out of business, you would do what?

A Jaeger: We have now a provision for corporations but not the same option for these five. We want to have the same procedure for all. This essentially allows those business structures to do something we allow for corporations.

Senator Mathern: Does it happen very often that groups abandon their trade names?

A Jaeger: In this particular case, if they actually cease to exist. If a legal entity created by law no longer exists we have this trade name with no live owner, we can purge records easier. Trade name registration is good for five years, sometimes at the end of that period they don't get renewed. Many proprietors have not taken advantage of registering their trade name, this is a business asset that needs to be protected, somebody can legally come in and legally register it. \$25 for five years is no big burden.

Senator Mathern: You have to wait end of five years to purge database?

A Jaeger: 60 to 90 days before expiration we send reminder. Challenge is people(single proprietorship) move and amount of returned mail is substantial.

Representative Michael Grosz, District 42, co sponsor. Urge do pass.

Representatives Grosz and F. Klein introduced this bill at the request of the Secretary of State.

After its introduction, it was realized that the bill could be enhanced with the attached amendment.

The intended purpose of the bill and the amendment is to bring consistency to state law and make it user-friendly for five business structures, which are created under the respective state laws administered by the Secretary of State. They are: limited liability companies, limited partnerships, limited liability partnerships, and limited liability limited partnerships.

Sections one and three of the bill allows these five business structures the same efficient and simultaneous process of making a change in the Secretary of State's trade name and trademark records as now exists for corporations when they file an amendment to their articles of incorporation.

The amendment to Sections one and three further facilitates and extends the same user-friendly process to changing the names of owners of trade names and trademarks, which again is only available under current law to corporations.

Sections two and four of the bill allows the Secretary of State to cancel a trade name or a trademark when the owner is one of five business structures registered with the Secretary of State, which has ceased to exist and failed to assign the trade name or trademark to another party. A cancellation of trade name or trademark is currently permissible by the Secretary of State only when the owner is a corporation, which has ceased to exist. This cancellation process will allow the agency to purge its database of abandoned trade names and trademarks.
