Minutes: Rep. Weisz - Chairman opened the hearing on HB 1184; A BILL to amend and reenact subsection 2 of section 39-04-36 of the North Dakota Century Code, relating to license fee credits.

Keith Kiser, Motor Vehicle Division Director, North Dakota Department of Transportation appeared in support of this DOT sponsored bill. See a copy of his written testimony attached.

Rep. Weisz - Chairman (4142) Does this prohibit the ability of a person to buy personalized license plates?

Keith Kiser: No, not a bit.

Rep. Weisz - Chairman: I guess the question is, the language says the owner "must" use the license plates.

Keith Kiser: No that is not the intent. You still have the option to purchase new plates.

Rep. Mahoney: You say we are selling more plates now than before we wrote the law, if that is the case then maybe we should throw out the law.

Keith Kiser: I do not advocate do that. The citizens like this law because it gives them credits.

Rep. Mahoney: I am one of those who likes to run his vehicle into the ground. I usually have 5 or 6 vehicles setting around my yard. This last year I got rid of several of those vehicles and wasn't purchasing anything else at the time. I could hang on to the license plates. It just seems strange you want to force people to take a credit and yet it is a cost to the Department. You say you are making more license -- I am assume that more expense to the Department -- but you are also loosing the credits people lost under the old law. It just seems that this new law isn't working that well.

Keith Kiser: Let me explain why we are selling more plates. If a person trades his car, instead of buying new plates --- we are trying to mandate that the old plates be used even though we give them credits -- it is still less work and cheaper for the department to have you make use of the old plates. The same is true, if you buy a new car, instead of buying new plates it would save us work and expense if you would use your old plates. Under the old law people were not using their old plates and not taking advantage of the credits-- and sometimes the credits are small -- but unless we try to mandate that they use to old plates experience has shown they will buy new plates.

Rep. Mahoney: If I have an old plate in my garage which I am not using and I buy a new vehicle and order new plates, am I subject to a penalty under this bill?

Keith Kiser: The way we would enforce this -- the way we see this whether there is a trade in -- we are not going to be spending time to track back in your records to say that you should have used on of your old plates.

Rep. Mahoney: What if I admit it? What would my penalty be?

Kieth Kiser: Under this statute I believe it would be a class B misdemeanor because there are no specific penalties provided in this statute.

Keith Kiser: The important part of this bill is the part that deals with the lessor's credits. If the committee is uncomfortable with the other requirements we certainly don't object to you taking them out.

Rep. Thoreson: (4840) I think you have pretty much answered my question but the main part of bill is to sort out the lessor/lessee issue.

Keith Kiser: Yes sir you are exactly right.

Rep. K.oppang: (4920) I didn't sign this bill but I am supporting because I did introduce a similar bill which will come up later. The main thing in this bill is the transfer of credits. I encourage you to vote a "Do Pass" on this bill.

Rep. Weisz - Chairman: (5040) There being no one wishing to present further testimony either for or against HB 1184, the hearing for testimony is closed.

Discussion followed. (Tape 1 Side B Meter at 4053)

Rep. Carlson: I move a Do Pass as amended and I would move we remove line 9 to line 12 from the word "the transferor" down to the word Plates 'period' be removed from the bill.

Rep. Mahoney: I second that amendment. Motion carried on a voice vote.

Rep. Carlson: I move a 'Do Pass as amended'.

Rep. Kelsch: I second the motion.

The state's share of this revenue loss is 63%. The counties share is 23% and the cities share is 14%.

This bill as amended would also require the DOT to print a temporary registration certificate on the reverse

side of each vehicle registration eard. This will result in an increase in printing costs of approximately \$15,000 per biennium. These costs will reduce the revenue available to the Highway Tax Distribution Fund.

The previous fiscal note for this bill estimated we could reduce expenditures for license plates by \$3,000 during the 2001-2003 biennium and \$3,300 for the 2003-2005 biennium. The amendment to remove this requirement eliminates this potential cost savings.

The amended bill continues to provides for a license fee credit for lessees that is not currently available to them. Since the leasing companies do not customarily use the credit available to them under current law, it is amicipated there will be a small reduction in revenue if lessees take advantage of the provisions of this bill. It is not possible to accurately estimate the fiscal impact as it is not known how many lessees will have credit available at the end of their leases or how many will purchase a replacement vehicle and use any remaining credit they may have.

Rep. Koppelman: I haven't spoke to them but I don't think they would have problems. This is just a technicality.

Senator Trenbeath: If I were to buy a vehicle privately and I went down to the sheriff's office, would they be able to give me a self-certification certificate? Is it the law that I need one?

Kelth Magnusson: We've sent them out, I would hope they could find one for you. Also, after five days it's the law.

Senator Stenehjem: Here's where I have the problem: If I take a license off an old 73 pickup and put it on a new cadillac, I could drive around for another six months until the fee is due. The registration fee for an old truck is way less than a brand new cadillac. Also, there could be confusion if pulled over by law enforcement.

Senator Espegard: I think that is covered in here. It says five days.

Rep. Koppelman: True. I think what Senator Stenehjem is getting to is how law enforcement knows if your registered. There is a potential for abuse. I think this would simplify this as a procedural matter.

Its that simple. When we passed the plate with owner bill 2 sessions ago -- it was the intent under that bill that is what they would do. Now in an effort not to cost them a lot of money and having them reprint a lot of registration cards -- they have already told us in testimony in the

committee -- they already make those things readily available at the county treasurer's office and all the car dealers -- and this is basically for those people that are selling their vehicle without going through a car dealer. That is all this does -- they just throw one in when they mail you your registration or with your license tabs. They certainly don't want to do it on their own as we have ask them for 2 sessions.

Rep. Carlson: (139) You are asking them to include with the registration renewal an additional form -- the 30 day certificate --

Sen. Stenehjem: If your were going to sell Rep. Mahoney your ear -- when you look in your glove compartment with your registration card in that very same envelope -- there will be that form you need -- Rep. Carson sells this car to John Mahoney -- you place in on the window because you are going to be taking the license plates they are yours. Its right there -- you don't have to search for someone to have one -- its right there.

Sen. Trenbeath: Or drive to a car dealer to get one -- its the 30 days temporary registration.

Rep. Carlson: (320) Are those required to be notarized? ??? No one seemed to know for sure. So you are saying that every time I get my renewal I will get an extra form of this little certificate in there in case I want to sell my car -- I have got my 30 day renewal there -- my 30 day license tabs until my new tabs come -- it is already in that envelope---

Sen. Stenehjem: Or they have the option of when they are already running your registration cards they print it on the back because once you sell the car you don't need that registration. You could tape that to your window and you would be good for 30 days.

Rep. Carlson: (401) I have trouble with the idea that people are going to hang on to save this thing ---

Sen. Trenbeath: Mr. Chairman -- so what? If somebody throws it away and they sell their car they can go down to the car dealer and get one just like they do now.

Sen. Stenehjem: My intent and it was 4 years ago was to have it on the back of your registration card and you would have it.

Rep. Mahoney: (454) So that would go on there and so if I bought a car and I didn't register it for several months like a lot of people do -- could I just keep putting that 30 day things on the window? I suppose I could do that anyway.

Sen. Stenhjem: Yes, that is exactly what you could do but understand that is part of what happens with the plate with owner -- the seller is taking the license plate with him because he still has that credit-- what do you do in the mean time? -- The main emphasis of this is that we get the plates off the vehicle so that the new owners license them.

Rep. Carlson: (570) I don't think you will save it - I am not adverse to have it print it on the back of the registration_card but to think that people are going to save that little piece of paper, I don't think its going to happen.

Sen. Stenehjem: Maybe in your case that is true but in my case I can tell you that my registration card is in the envelope in my glove compartment. My wish would be that it would be printed on the back of the registration card and then you wouldn't throw it away. In an effort not to get a huge fiscal note on here with them saying --gee we have got 10 million cards ready to come out and its not on the back of them -- now what do we do? -- and they come up with a \$985,000 fiscal note -- give them the option -- they are already giving those slips of paper away anyway. Just have them mail them out until they want to print on the back of the registration cards.

Sen. Trenbeath: That would help curb the problem of the stockpiling of them because they are

HB 1184

The North Dakota Department of Transportation supports HB 1184, which would make two changes to the current plate-with-owner law.

- 1. On page 1, lines 9 through 12, we propose to add a requirement that transferors use license plates they have removed from a vehicle they previously sold or traded when registering a newly acquired vehicle, regardless of whether there is any remaining license fee credit on the previous vehicle. Since implementing the plate-with-owner legislation in 1997, we are using more license plates than ever before. In many cases, vehicle owners choose not to transfer license plates because they wish to get new plates for their new vehicle. While we understand their desire for new plates, issuing new plates when other plates are available is an unnecessary strain on our license plate budget. Passage of this suggested change will help to ease the strain on our budget while also making use of perfectly good license plates that will otherwise be needlessly discarded. Vehicle purchasers who do not wish to use a pre-existing plate would have the option to pay the \$5.00 duplicate plate fee and receive new license plates.
- 2. On page 1, lines 14 through 16, we propose to specify that license fee credits remaining on a leased vehicle belong to the lessee. Currently, license fee credits belong to the leasing company even though they are paid by the lessee. We have received hundreds of complaints from lessees regarding this situation and believe this is an appropriate change.
