Minutes: Rep. Weisz - Chairman opened the hearing on HB Bill 1199; A BILL for an Act to create and enact a new subsection to section 39-06.2-06 of the North Dakota Century Code, relating to exceptions from a commercial driver's license requirements.

Rep. Devlin: For the record I am Rep. Devlin, District 23. HB 1199 is brought to this committee because of problems which have arisen in our smaller communities. When there is a blizzard, our area farmers come in with their equipment. They blow snow into trucks and haul it to the edge of town to dump it. The small towns do not have the snow removal equipment to handle these situations. The farmers use their equipment and get paid only a nominal fee to cover their gas and expenses. The problem which has arisen is that they are being told that these people (the farmers) are required to have commercial drivers license. What this bill is doing is to try to rectify that situation. It really is a community service type of thing that these farmers are doing. This bill really allows for an exception in the cases of emergency.

Rep. Mahoney: (3080) Are you looking at only snow removal because the bill does not say emergencies including the removal of excessive snow --- it is limited to the removal of snow?

Rep: Devlin: My only concern was the removal of snow. There could be situation like Grand Forks in a flood situation may welcome this bill being on the books. I don't think most big cities would ever use this.

Rep. Weisz - Chairman: I take it that you mean exactly what it says in the bill --- that if a tornado went through --- that it would imply the individuals take care of clean up?

Rep: Devlin: That is right.

Rep. Ruby: (3196) Would it be an extreme hardship to have the volunteers apply for a commercial drivers license?

Rep: Devlin: There is a cost involved and they don't think they should have to do that.

Rep. Thoreson: Basically this doesn't entail any highway miles, does it?

Rep Devlin: In these cases the snow blower is coming down main street blowing snow into farm trucks. The farm trucks haul it to the edge of town and dump it. They are not on the state highway at all.

Jerry Hjelmstad: Speaking on behalf of the North Dakota League of Cities we urge a 'Do Pass' on this bill .It does give another option to the local governing bodies in an emergency situation to deal with that emergency.

Rep. Pollert - Vice Chairman: (3370) Could there be a liability issue if they were driving without a CDL and got into an accident and there was no written declaration of an emergency?

Rep. Devlin: There could be a liability considerations I guess. That would be something the local governing board would have to take into consideration. That would be one of the factors for them

in this. How that emergency gets declared may with in a city would depend on their local ordinances.

Terry Traynor, Assistant Director of the Association of Counties in North Dakota: We also support this bill. There are a number of different places in the Century Code where increased latitude is granted to local governments in response to emergencies. We think this would be an appropriate extension of that concept.

Keith Magnusson, Director of Driver and Vehicle Services Division of the ND DOT. We don't necessarily have a position on this bill, and I wasn't going to speak. When they started talking about other things than removing snow and ice, my motor vehicle person here handed me note that the feds in there regulations a exception specifically and only for drivers removing snow and ice. So we would ask the bill be restricted to drivers for snow and ice removal. The talk about the intrastate exceptions for farmers, fire fighters, and emergency vehicle drivers and 'drivers removing snow and ice'. We have enough trouble with feds on Commercial Drivers License as it is.

Rep. Weisz - Chairman (3660) You mentioned the exception for farmers, would they be excepted for whatever type of activity they do if it were an emergency?

Keith Magnusson: Looking at the Federal Regulations, the State could exempt them right now. You may want to have something in the statute to make it clear. What I read in the Fed Regs is that when a farmer does these types of things they are not a farmer any more. If a farmer has a grain truck and hauls grain for another, he needs a CDL.

Rep. Schmidt: In 1989 a tornado blew away house away. We waited about three days for the National Guard to come in. If it wasn't for the farmers cleaning it up we would have had to wait

our turn for the Guard. As it was the farmers pitched in and helped. This would allow them to do that without a CDI.

Keith Magnusson: All I am doing is quoting the Federal Regulations.

Rep. Devlin: I might point out that in many cases the farmer furnishes the truck and it may be a barber driving it.

Minutes: **HB 1199** relates to exceptions from a commercial driver's license requirements.

Rep. Bill Devlin: (District 23; Supports) Essentially what we have in one of our small communities, Hope, is that they do not have the money for snow removal. So farmers come to town and haul the snow to edge of town. This has worked fine for a number of years. They have ran into some question on whether they have to have a commercial license because they are getting paid for their expenses and a bit more. No one is making any money on this deal. We want to make sure that state and federal guidelines are the same and allow these communities to do this.

Jerry Hjelmsted: (ND League of Cities; Supports) In support of this bill. It gives another option to get people to remove snow and ice removed from communities.

Wade Williams: (Association of Counties; Supports) We are in favor. In those times of emergency, we can use all the help we can get.

Senator Trenbeath: I have a particular interest in this because we do this in Cavalier. I have always been under the opinion that these people are private contractors and the license status is their problem. Am I wrong in that?

Keith Magnusson: (NDDOT; Neutral) You are correct. If they are a private contractor, they are the ones responsible for licenses. Federal rules specifically allow it for farmers, firefighters, emergency response people, and drivers removing snow and ice. This probably would not have to be in the law, but I think it them much more comfortable. This makes it clear in the law.

Senator Stenehjem: Not under this bill, but under the commercial drivers license, if a tornado came through, could farmers come in and haul out trees and debris?

Keith Magnusson: Under federal regulations, that is not allowed. When you get tornadoes, there may be some other emergency declarations that might kick in.

Senator Trenbeath: Let the record reflect, my understanding of Mr. Magnusson's response is that this is kind of a belt and suspenders situation. If it's truly a private contractor, then it's actually their responsibility rather than the local entity.
