

1A:00 CHAIRMAN NICHOLAS: We will now open the hearing on HB 1209.

1A:028 REPRESENTATIVE MUELLER: I'm Phil Mueller from District twenty four.

In 1997 A Bill was brought forward and it provided for an official Agricultural Hall of Fame at the N.D. winter show held in Valley City. The Ag. Hall of Fame are inductees are people who have a record of significant accomplishments in the Ag. Industry. The Ag. Hall of Fame committee is made of fifteen representatives of N.D. Ag. organizations. By current statutes can only induct two nominees into that Hall of Fame. That committee of the N.D. Winter Show Board have determined that they need the options to set the numbers to set the numbers to be inducted in the Hall Of Fame. In other words they need a little more leeway in that respect. Limiting the number to two inductees per year into the Hall Of Fame has restricted the committee and they have asked to set the number as they see fit. There are many potential Ag. Hall of Fame candidates in our state. This Bill allows Ag. Hall of Fame committee to

determine the number of qualified inductees each year in ND based on their criteria. The committee will continue to stress the integrity of this honor. Minutes:

REP. MUELLER; Sponsor, introduced the bill to the committee. The Agriculture Hall of Fame Committee and the North Dakota Winter Show Board wants to have the option to set the number of persons they can induct into the Hall of Fame on an annual basis. Limiting the number of inductees to 2 annually has restricted the committee and has asked to set the number as they see fit.

SENATOR ROBINSON; Sponsor, testified in support of this bill. This will provide more flexibility that is important.

SENATOR URLACHER; Is this already setup?

SENATOR ROBINSON; It is in place.

SENATOR URLACHER; How many are on the committee?

SENATOR ROBINSON; There are people from all over the state. Gerald Gerntholz can talk to you about the process and detail and the number of other names that have been discussed. There

are plans to add to the facility. There are fewer and fewer people involved in agriculture and as we move down the road, if we don't capture this type of information who is going to tell the story to the future generations?

GERALD GERNTHOLZ; Board of Directors - ND Winter Show and ND Winter Show Agriculture Hall of Fame testified in support of this bill. See attached testimony.

SENATOR NICHOLS; Is this committee setup in your bylaws?

GERALD GERNTHOLZ; The original bill has the designation of how the committee is made up.

WADE MOSER; ND Stockmen's Assoc. testified in support of this bill. To often the people that need to be recognized for pioneering this state are going and many that will not be around much longer, let's not wait until they are gone too before they are recognized.

DALE HILDEBRANDT; ND Winter Show Manager and Secretary of the ND Ag. Hall of Fame Committee, testified in support of this bill.

STEVE ZIMMERMAN; State FFA and Supervisor for Ag. Education, testified in support of this bill. We are making a major effort to preserve our history with the Ag. Hall of Fame. I think we need to make a bigger effort to preserve living history. This is an educational tool for our youth.
