Among this sections provisions is the stipulation that a written medical record release is for a specific period of time but may not exceed three years or until revoked in writing by the patient. (See written testimony.) We ask for a DO PASS on HB 1234.

Chairman Price: Nothing in front of us is going to conflict with HIFA that you are aware?

Arnold Thomas: No. This is a presumption of release that would be outside the provisions of this particular section.

ARNOLD THOMAS, ND Healthcare Assoc., introduced bill. (Written testimony) SENATOR MATHERN: What is rationale for 3 years? MR. THOMAS: Three years is in statute, but I have no answer as to why. SENATOR POLOVITZ: What is definition of consultants? MR. THOMAS: That is medical consultant; a doctor who is prescribing treatment. Finishing claim would involve insurance. SENATOR MATHERN: Seems like we are providing records to secondary (consultant) and not to primary. MR. THOMAS: Need to have time to determine where 3 years comes from. SENATOR KILZER: There is a difference between continuing treatment for three years or someone who was treated three years ago. MR. THOMAS: I will look into that and get back to you.

No other testimony. The hearing was closed on HB 1234.

Madame Chairman, members of Health and Human Services Committee, my name is Arnold Thomas. I am the President of the ND Healthcare Association, here in support of HB1234.

Section 23-12-14 sets forth polices governing the release and copy charges of medical records. Among this sections provisions is the stipulation that a written medical record release is for a specific period of time but may not exceed three years or until revoked in writing by the patient.

HBT234 would create two exemptions to this provision. The first exemption to the time limitations of this section permits access to the patient's medical records by consultants if the course of treatment extends beyond the time provisions of this section. The second exemption to the patient's reauthorization permits release of medical records for purposes of payments or claims, fraud investigation, or quality of care review and studies.


Without HB1234, a reauthorization to access medical records would be required If the treatment and use of consults took longer than the time framework of this section. Without HB1234 a reauthorization to release medical records would be required to settle administrative matters associated with the patients if reatment

or condition that extend beyond the time certainty of this section

We ask for a "Do Pass" on HB 1234.
