Chairman Earl Rennerfeldt, Vice Chair Jon O. Nelson, Rep. Brekke, Rep. DeKrey, Rep. Drovdal, Rep. Galvin, Rep. Keiser, Rep. Klein, Rep. Nottestad, Rep. Porter, Rep. Weiler, Rep. Hanson, Rep. Kelsh, Rep. Solberg, Rep. Winrich,

<u>Chairman Rennerfeldt:</u> I would like to open the hearing on HB 1238. Is there anyone here to speak in favor of HB 1238.

Rep. Nottestad: HB 1238 finishes what we started 3 or 4 years ago relating to purchase of out of state hunting and fishing licenses by out of state vendors. The original bill prohibited the sale of both hunting and fishing to be sold in the state, it was amended pertaining to fishing and that was permitted to be sold out of state, next to state line in rural areas. Since that time, Game and Fish has put in Internet or 1-800 service. This is being done at the time the bill was being written, but it wasn't available that spring. The request for the change in this bill comes from the local

business men in Grand Forks and the Devils Lake area. The reasons why the bill was drawn up was because we tried with the Legislative Council and Game and Fish to cover all bases. We tried to figure out a way to do it without legislation, but there were too many loopholes. There is one provision, that shows that the commission of Came and Fish only appoints out of state vendors. We have large bodies of water on the Missouri from the Montana line to the South Dakota line. If there was a fishing tournament sponsored in either state near the line, for that purpose the commissioner could put a vendor in that area that would be answerable to him not to the county auditor so there would be control of that. I urge the passage of this bill for a number of reasons, it would increase state revenue. The audited businesses selling out of state fishing licenses and the Devils Lake Fishery, advertise come on in and pick up your bait, your clothing and the like. As a little side light in Minnesota you don't have to pay sales tax on clothing. This would up our sales tax if sold here. It would level the playing field. You cannot buy a Minnesota out of state fishing license in ND. It will also help ND Game and Fish, right now every minnow brought into the state purchased out of state cannot be monitored. This wouldn't stop it, but it would slow it down. There is concern about bait being brought into ND. Chairman Rennerfeldt: Any questions? Anyone else here to speak in favor of HB 1238? Date Merkel - Manager of Scheels Sporting Goods: I have three quick points. As a vendor of licenses, I can tell you that customers that come into buy licenses, don't just stop there. I don't have any hard percentages, but I would say 80-90% buy something else also. I feel as a vendor if we allow our fishing licenses to be sold in other places, we are throwing tax dollars out the window. No only are we doing that, we are taking money right out of the businesses in ND that we are trying so hard to build. I think those two points alone are worth passing this. I don't think

by selling them in another state that we are going to sell more licenses, those people coming to ND are coming anyway. They can buy them anywhere in ND and across the Internet.

Rep. Droydal: I have no problem with this bill at all. In fact you can buy them over the Internet anywhere in country now, so it's kind of a mute point, isn't it?

Merkel: I was just restating that I don't think we need to be able to sell them in out of state places now. That was my point.

Chairman Rennerfeldt; Anyone else here?

Paul Schadewald - ND Game and Fish: This bill will accomplish exactly what the sponsor want it to accomplish. In the past we have had some problems with county auditors in the western part of the state. The county auditors appoint the vendors. In some areas we have problems with no places to buy these license, so we have the county auditors that do have some agents across the line, but with this bill we will be able to work with county auditors and still have those agents but only in situations where there is no other business around to handle the license. We are supportive of this approach.

Rep. Keiser: Can you explain to me what is managed by the County Agents by having the authority to appoint these licenses?

Schadewald: The authority who handles it gets a commission from the fee or license. They get a cut of the license.

Rep. Keiser: Has the Game and Fish Department ever thought that they might like to retain that kind of fee?

Schadewald: We found that some of the county auditors wanted to handle it and some didn't.

The Game and Fish liked having a local representative that know the local businesses and can

determine which ones are reliable enough to handle the licenses. They do handle 10's of thousands of dollars. They like the local contact.

<u>Chairman Rennerfeldt:</u> Any more questions of the committee? Anyone else here to speak in favor of HB 1238? Any opposition to HB 1238.

Mike Donahue - NDWF & NDUS; The Federation is neutral on this bill, but the United Sportsmen are opposed to it. (See written testimony).

SENATOR FISCHER opened the hearing on HB 1238.

REPRESENTATIVE DARRELL NOTTESTAD of District 43, cosponsor introduced HB 1238, A BILL RELATING TO USE OF OUT-OF-STATE VENDORS BY COUNTY AUDITORS TO SELL FISHING LICENSES AND APPOINTMENTS OF AGENTS TO SELL GAME AND FISH LICENSES. He testified that HB 1238 finishes what was started several years ago, pertaining to the sale of hunting and fishing licenses by out of state vendors. The original bill at that time prohibited the sale of licenses out of the state, but fishing was amended out because of fishing areas close to state boarders. This was prior to Internet sales and the 800 number of the Game & Fish Department. Since that time the sale of licenses has greatly changed. The request of the bill came from a retailer in Grand Forks. The bill was written up with input from the Game & Fish Department and the Legislative Council. The passage of HB 1238 will increase tax revenue for North Dakota, it will support North Dakota businesses and support North Dakota

tourism. It will also help put a handle on buying out-of-state bait. He is also aware of an amendment that will be submitted later in testimony.

DON DESCHER of Grand Forks and a Scheel's Sporting Goods Store employee, testified in support of HB 1238. He commented that of course the tax revenue is the # 1 issue and would rather see sales of products stay in North Dakota.

SCOTT WAGNER, a Cass County Commissioner testified in support of HB 1238 (See attached testimony). He also proposed amendments to HB 1238 that would give the county auditor the authority to appoint agents to self licenses.

PAUL SHADEWELL, chief of administrative services division of the State Game & Fish Department testified in support of HB 1238. He explained that the amendment would continue the compliance with the how the state money should flow concerning handling fees within license fees. There a now five counties that have agreements where the county auditors have agreements with the county commissioners, that the county staff will handle the sell of licenses and the commissions that the county auditor would usually get will go to the county. Some go directly to the auditor and this would be a good transition. County governments are changing on how things are done and more counties will be making these kinds of agreements.

<u>SENATOR FREBORG</u> asked that in these agreements the county auditor is not obligated to enter into an agreement with the county commissioners.

PAUL SHADEWELL confirmed and the under current law the money goes to the county auditor and that they would have to be willing to make these agreements. It would be up to the auditor and the county commission to make the agreements.

SENATOR FREBORG wanted to clarify that even if the amendment is adopted the authority is still with the county auditor and there is no reason the auditor would have to sign an agreement.

Alon Wieland st Fargo, North Dakota House Bill 1238 adds some language to NDCC 20.1-03-17 allowing for the director of Game and Fish to appoint vendors located outside this state. We are not opposed to this legislation but would like to take an opportunity to enhance another part of this statute dealing with the county auditor and the fees collected for issuing game and fish licenses.

NDCC 20.1-03-17 requires the county auditor to personally receive the fees from the game and fish licenses sold in county. For most of the counties in North Dakota this works very well. The county auditor is responsible for handling of licenses and appointing vendors within the county and is personally responsible for the safe keeping of the licenses and funds derived from the sale of licenses. However, in some counties, Cass included, the county auditor and the county have entered into an agreement where the county takes over the responsibility for the liability concerning licenses and funds derived from the sale of licenses and in exchange the county auditor gives up the right to personally receive the fee from the sale of licenses.

In Cass County, the county auditor has very little involvement with license sales. He supervises that activity as a function of the office the same as he supervises all of the other functions of the county auditor's office. The licenses are sold by county staff, inventoried on the county computer system, and the funds are safeguarded by the county treasurer in her regular duties as county treasurer. The county auditor is compensated by the county for managing the county auditor's office based on a compensation system administered by the board of county commissioners—the sam system that is used to set the compensation for all county officials and employees.

We are asking you to amend House Bill 1238 to allow the North Dakota Game and Fish Department the ability to recognize the written compensation agreements that some counties have with their auditors. This change would not diminish the county auditor's responsibility for handling the licenses, but would allow the county and the county auditor to structure compensation agreements that are fair to both the county and the county auditor. The amendment does not require county auditors and counties to do anything different than they are doing today, but it does allow them the flexibility to administer their compensation system on a consistent basis between all county offices.
