1A:ROGER: It all depends on if he has a son coming into the business so to speak that's he's coming on, they would both qualify. If he is just a sole proprietor he can transfer that to his kids I think the thought behind this is that the guy's are already getting gratis for farmers and ranchers.

When you get into the 160 acres the gratis permits would dramatically increase.



For the record my name is Jeff Delzer, Representative from dist 8, which consists of parts of Melean and Burliegh Counties. I introduced 1257 at the request of a constituent. This past fall he called the game and fish to find out how to transfer his gratis eligibility to his brother and was told it was against the law. When he told me this I myself was quite surprised since transferring of land for gratis does happen in the real world.

The bill as introduced will remove language limiting it to a spouse or legal dependent residing with the landowner to an immediate family member.

I felt this was a subject that deserved legislative debate. My feelings as I put this issue forward was that a immediate family would be parents, siblings and children. I feel that gratis lisence recipients should only be residents of North Dakota. Attached is a e-mail of issues from a revue at the AG's office. I put this in for your consideration.

Mr chairman this issue is here for your consideration and I am sure this committee will do a good job of looking into the issue.

Representative Delzer,

As the sponsor of HB 1257, I wanted to advise you of the issues I pointed out on my bill review form to the Attorney General. This office will not take a position or testify, but the Attorney General asked me to contact you about providing technical assistance.

- Page 1, line 22-23 refers to "an immediate family member". The phrase is not defined in Title 20.1 and may be subject to varying interpretations by the regulated community and the agency charged with its administration. The phrase "immediate family" is defined disewhere in the Code, but that definition is not controlling here. We suggest its meaning within the bill.
- NDCC section 50-10.2-01(4) defines "immediate family" as "husband, wife, father, mother, brother, sister, son, daughter, father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law, stepchild, uncle, aunt, niece, nephew, or grandchild." This list may be more expansive than you intended, but is conclusive when the agency reviews the relationship of transferred eligibility for a gratis license.
- Since the new language being proposed appears more expansive than existing law, a second set
 of Issues is also present.
 - Does the "immediate family member" have to reside with the person transferring the gratis?
 - Does the "immediate family member" have to reside in North Dakota, or may a nonresident family member also qualify?
 - If the Intent was to allow a nonresident family member to receive the gratis, does the non-resident have to pay the fee required for a nonresident big game license (similar to a nonresident landowner)?

TESTIMONY OF THE NORTH DAKOTA GAME AND FISH DEPARTMENT HB: 1257 GRATIS FOR IMMEDIATE FAMILY HOUSE NATURAL RESOURCE COMMITTEE JANUARY 26, 2001

Virtually no one totally disagrees with gratis licenses for farmers/ranchers and landowners as a reward for providing deer habitat. Currently individuals who are eligible for a gratis license may transfer these license to a spouse or legal dependent residing customarily with that person. The question concerning HB1257 is, "is being a relative of someone owning land or farming/ranching a reasonable expectation to receive a gratis deer licence."

Under the current requirements the number of gratis deer flagues has increased over 17 percent in the last 5 years to its current level of 10,650, even though the number of farmers and rancher is decreasing. The definition of immediate family is very broad under state law and would qualify tens of thousands of individuals. I personally would qualify for a license for a large number of farms in several counties.

Even if the number of relatives in the list of immediate family were reduced, it would tax the limits of our current deer license allocation system, especially in areas where certain type of licenses are currently in high demand.

For these reasons the North Dakota Game and Fish Department urges a **DO NOT PASS** recommendation on HB 1257.

50-10.1-07. Confidentiality and disclosure of records and files. Those records and files of the state and regional ombudsman, and their authorized agents, which relate to, or identify any resident of a long-term care facility or a complainant, are confidential and may not be disclosed unless:

- 1. A resident, or a legal guardian or attorney-in-fact, consents in writing to the release of the information and designates to whom the information must be disclosed;
- 2. The ombudsman authorizes a disclosure which does not reveal the identity of any complainant or resident; or
- 3. A court of competent jurisdiction orders the disclosure.

CHAPTER 50-10.2

RIGHTS OF HEALTH CARE FACILITY RESIDENTS

Section
50-10,2-01, Definitions.
50-10,2-02, Residents' rights --- Implementation.

Section 50-10.2-03. Rulemaking authority of department. 50-10.2-04. Enforcement — Injunction.

50-10.2-01. Definitions. In this chapter, unless the context or subject matter otherwise requires:

- 1. "Conflict of interest" means any type of ownership in a facility or membership on the governing body of a facility by a provider of goods or services to that facility or by a member of that person's immediate family.
- 2. "Department" means the department of human sprvices.
- 3. "Facility" means a skilled nursing care facility, intermediate care facility, basic care facility, boardinghouse, or swing bed hospital approved to furnish long-term care services.
- 4. "Immediate family" means husband, wife, father, mother, brother, sister, son, daughter, father-in-law, mother-in-law, brother-in-law, sister-in-law, son-in-law, daughter-in-law, stepchild, uncle, aunt, niece, nephew, or grandchild.
- 5. "Remodeling" means any alteration in structure, refurbishing, or repair that would:
 - a. Prevent the facility staff from providing customary and required care: or
 - b. Seriously endanger or inconvenience any resident with noise, dust, fumes, inoperative equipment, or the presence of workmen.
- 6. "Resident" means a person residing in a facility.
