Minutes: Rep. Weisz - Chairman opened the hearing on IIB 1261; A BILL to amend and reenact section 39-04-21 of the North Dakota Century Code, relating to the temporary registration of motor vehicles.

Rep. Drovdal: I represent District 39. This bill comes about after years and years of seemingly the same complaint. My district borders the Montana border from Trenton south to the South Dakota State line. While we have good relations with the people from Montana, there is one area where we do have some problems. An example of the problem is where an oil field worker whose rig happens to move across the border and is located in Montana. The second day that he shows up for work there is a Montana Highway patrol man waiting there for him. He is there to make sure that he has absolutely met the requirements of the Montana law in licensing that vehicle. They identify it real quick by looking at the vehicle whether he is displaying the plates. Before he can go to work that day he must go in and get his temporary license plates and put it on that vehicle. That's the law. Now when that rig moves back into North Dakota and the Montana

residents come over to North Dakota they are required to have a North Dakota licensed vehicle. Well they may or may not. That's where the perception comes in. We don't require them to put a plate on all vehicles registered in North Dakota. I don't know what it is but I am not picking on any one department; the highway patrol or any one else. But I have asked a number of times; how can I as an individual identify that that vehicle has purchased or paid its fair share in North Dakota. It seems that they can't really explain the bill to foreigner (? Farmer?) who hasn't had the opportunity to see the plates to figure out how to do it. Neither can the general public. So they are perceiving that these Montanans are not paying their fair share when they (North Dakotans) are forced to. Of course they're upset about it. This bill will says that for one thing that North Dakota should required a plate to be place on the vehicle on bumper, fender, tailgate or somewhere it would have to be displayed so that it is easily identifiable. One day when I sold a vehicle in North Dakota the dealer sold it to somebody in Montana with North Dakota plates on it. The third day the Montana sheriff and the Glendive police were checking why my North Dakota vehicle was sitting in Glendive without a Montana plate on it. Now if that vehicle had been stolen I would have been real happy about it. So it works both ways. We don't have enough patrolman. They just can't cover the mileage. We know that if people are involved in our school system, we're going to have a better school system. Same way with law enforcement. By making them more knowledgeable we're going to have people helping us. The bottom part of the law -we want to leave the fines as they currently are and add \$20. The additional \$20 of that fine would go to the local law enforcement -- if the sheriffs department picked up somebody they would get it -- if the local police department picked up somebody, they would get it -- the local police department. It doesn't change the law it merely helps get better enforcement.

Rep. Weisz - Chairman (547) Would this plate be a different style and how long is 'temporary'?

Rep. Drovdal: That I think would be set by the Transportation department.

Rep. Hawken: (683) On our side there are lot people who live in Minnesota. They work in work in North Dakota. I think your license plate is where you live not where you work. I guess I need clarification of what the law is and then what is the time frame. If they are living in North Dakota, then that is a different thing.

Rep. Drovdahl, I will defer that to him (Keith Kiser).

Keith Kiser: Director of the Motor Vehicle division of the DOT. Rep. Drovdahl is correct in that most states, when you are a temporary resident of that state --- that is when you are employed you are required to register your vehicle in that state for the period of time you are gainfully employed there. North Dakota has a similar requirement. Unlike many other states we give you a temporary permit which is a window sticker -- it is approximately 3" x 3" square. It is issued out of our office or out of a branch office or issued by law enforcement officers around the state. So as a temporary resident in this state you have a number of options as to where you can go to obtain that temporary registration. It is sold by the month which is 1/12th of the annual registration fee and can be purchased for a many months as needed. Many of our oil field workers are seasonal workers and they will come in and buy 2 or maybe 3 months temporary registrations.

We issued about 4400 of those permits last for temporary residents in North Dakota. We have never issued temporary license plates. It is a cost factor obviously. If we were to issued license plates we would have to modify our computer system so that we could keep track of those

temporary transfers of title to go with the registration. The reason is that law enforcement officers have to check plates with ownership. Our data base is oriented to the title and the license and permits are referenced to the title but it is a problem to license and not transfer the title for that officer in the field because they do check ownership too. That is because of the license plates and the permits can be correlated with the license plates.

Rep. Price: (1048) Are the rules different for people stationed in the military base?

Keith Kiser: You are correct. There are exemptions from our registration laws for military personnel. This is true so long as they are not employed outside of the base while stationed on the base. If they take a part time job delivering pizza then their vehicle must be registered here. It is a difficult thing to enforce. The same thing is true of nonresident students at our colleges. If they are gainfully employed they are required to have their vehicle registered here.

Rep. Weisz - Chairman (1115) Would that person living in Moorhead working Fargo have to have a temporary permit?

Keith Kiser: No not if they go home every day. But if you are domiciled over night then you would. We have a reciprocity agreement with Minnesota on that. There is a twenty mile free trade zone in Minnesota but not in Montana.

Rep. Carlson: (1206) What does temporary mean?

Keith Kiser: Minimum is 1 month because that is the minimum time for which you can buy a temporary registration.

Rep. Carlson: Let's go back to the example of the guy Rep. Drovdal gave of the guy on the job the second day and the patrolman was siting on his bumper when he came to work in Montana --

how does he know how long a person is going to be in the state -- he could be there a week or he could be there several days or six months?

Keith Kiser: Having been victimized in Montana myself -- the patrolman takes you downtown and you buy whatever you think you might need and you can go back and buy more if you need it.

Rep. Carlson: So what we are doing here is 'do the same to them as they do to us'.

Keith Kiser: Well that is right but what Rep. Drovdal is attempting to do here is get some thing that is visible so that enforcement can see the status of that registration.

Rep. Carlson: If there is a car parked at the local motel for several days, who is going to go in there and ask him?

Keith Kiser: That is an enforcement problem.

Rep. Weisz - Chairman If a person so desired, he could keep his car registered in Montana, he could get his car registered in North Dakota with temporary permits? Forever?

Keith Kiser: It would cost him significantly more. There temporary fee is 1/12 of the cost to him as if you or I were to register that same vehicle. There is no discount if you will. His dual registration is costing him at least double or more.

Rep. Hawken: How about if we got a neon sticker for there license or window?

I think this should be in the college handbooks because I don't think these college kids know about this requirement.

Keith Kiser: You get right back to the same question for the personnel on our military bases.

Rep. Jensen: If we were to use the permit system more extensively it would in fact solve the problem would it not? And part of the consideration of this bill is to add this fee that the local

entities in exchange for enforcing the law already existing. Right now there is not much incentive for enforcing and you don't have provision for it --- to worry about these kinds of things -- it just doesn't get handled. I don't think the license plate or whether it is a permit in the window is not central to this bill. The main thing is that the fees are beginning to be collected.

Keith Kiser: The magnitude of the problem is reflected in the fact that we sold 4400 these last year to non- residents. I don't know how many we should have sold. Enforcement in this area is difficult because you don't know how many ought to be there. One reason that Montana does a good job of enforcement is that the fees remain in the county.

Rep. Price: How do our fees compare with Minnesota's and Montana's?

Keith Kiser: Our fees and other states charge a proportionate amount to the cost of their annual registration. So our registrations in North Dakota are less than those around us. A car that I would register in North Dakota for \$72 would cost \$100 to 150 in Minnesota and probably more than that in Montana.

Rep. Mahoney: (1812) At what point does a person become required to have this temporary registration?

Keith Kiser: There is a statute that says if you become a resident of the state for any reason, the vehicle must be registered immediately. If you are gainfully employed or gain citizenship your privileges enure at that point and your vehicle must be registered.

Rep. Mahoney: My recollection is that residency is like thirty days for a lot of purposes -- do you guys interpret that that if I go over to Montana and work for one day for a day or an afternoon, or one minute that I have -- where does law enforcement step-in?

Keith Kiser. The statute really says immediately. I think the literal interpretation is that if I come to work over here, day one is when I have my registration. If for one day the minimum amount would be a one month permit.

No one else appearing in support or in opposition to IIB Bill 1261, Rep. Weisz. Chairman closed the hearing on any further testimony. (1958).

2. Narrative: Identify the aspects of the measure which cause fiscal impact and include any comments relevant to your analysis.

This bill, as amended, requires NDDOT to collect, track, and distribute a \$50 surcharge on each temporary vehicle registration permit sold. Past history shows that about 4,700 permits are sold each year. It is not possible to estimate the additional registration fees that may be collected as a result of the increased enforcement this bill anticipates. However, it is estimated the \$50 surcharge will generate at least \$235,000 per year for the counties.

  - A. Revenues: Explain the revenue amounts. Provide detail, when appropriate, for each revenue type and fund affected and any amounts included in the executive budget.

It is not possible to estimate whether or not any additional registration fees will be collected as a result of this bill.

B. Expenditures: Explain the expenditure amounts. Provide detail, when appropriate, for each agency, line item, and fund affected and the number of FTE positions affected.

It is estimated that NDDOT will require a \$15,000 one-time computer system enhancement to record, track, and discribute the \$50 surcharge. NDDOT will also need one additional FTE (\$56,207 salary and benefits) and approximately \$10,000 for one-time costs for a workstation and equipment for the new FTE.

This bill requires the Department to issue metal license plates in lieu of the paper window permits that are currently issued to applicants for temporary registration in North Dakota. It is not possible to accurately estimate the amount of additional revenue that could be collected as a result of the increased enforcement effort this bill anticipates. It is estimated that we will receive 10,000 requests for temporary registration during each biennium.

  - A. Revenues: Explain the revenue amounts. Provide detail, when appropriate, for each revenue type and fund affected and any amounts included in the executive budget.

A budget enhancement of \$146,207 for the 2001-2003 biennium and \$100,360 for the 2003-2005 biennium will be required to enact the provisions of this bill. Since Motor Vehicle Division budget dollars come from collected revenue, a budget enhancement reduces revenue available for state, county, and city highway funds.

B. Expenditures: Explain the expenditure amounts. Provide detail, when appropriate, for each agency, line item, and fund affected and the number of FTE positions affected.

The anticipated expenditures for the 2001-2003 biennium would be \$40,000 to purchase the license plates required by this bill, \$50,000 for computer system enhancements necessary to record and provide access to records related to the license plate owner and vehicle, and \$56,207 for one FTE to handle the additional

work this bill will require. The anticipated expenditures for the 2003-2005 biennium is \$40,000 for license plates and \$60,360 for one FTE.

Rep.Drovsdal: (District 39; Supports) How come we allow out of state people to come into ND and work and not pay any registration fees? In Montana, on the first or second day out of staters are in the state, law enforcement is checking you. Most other states require an additional plate to be put on the back of the vehicle. ND requires a sticker. The problems I see with this is that it's not visible and it's also a priority problem. Highway Patrol gives out a \$20 fine and it's not worth their time to stop and fine them. The cities do not want the Highway Patrol to drive around town and ticket people and then the money goes to the state. So we put an additional stipulation giving the fee collected to the treasurer of the governing body of the law enforcement officer who enforced this. This is not a perfect bill. Rental cars should have ND licenses too because they are using our roads also. We are not enforcing these current laws. This bill does not require external plates.

**Senator Trembeath**: Has anyone looked at Montana to see how this works? Do you know of any other area where fees go to counties or cities instead of the state?

Rep. Drovsdal: I don't know.

Senator O'Connell: What's the difference in the two fiscal notes and how does this affect college students?

Rep. Drovsdal: The first fiscal note was based on the extra plate on the bumper. College students I believe are exempt.

Rep. Kempenich: (District 39; Supports) There has been a problem for a number of years with this. Montana strictly enforces this and they are more expensive. Counties in Montana are able to issue licenses on this and it works well. No one really pays close attention or enforces our current laws. We would like to see more enforcement.

**Keith Magnusson:** (NDDOT; Neutral) Hands out proposed amendment. This is an enforcement problem. We sell about 5000 of them a year. We took out the requirement for the external plate but put in a \$50 surcharge fee. Whoever sells this, will get the \$50 surcharge. The amendment would have the city or county collect the temporary registration fee and they keep the surcharge.

Senator Bereier: What does SD do?

Kelth Magnusson: South Dakota has a small registration fee so we don't have much of a problem. We don't have much of a problem with Minnesota either.

Senator O'Connell: In regard to Senator Bercier's question, the minute we cross the South Dakota state lines, law enforcement was there.

Kelth Kiser: (Director of Motor Vehicle Division; Neutral) I'm hear to answer any questions you may have. (No questions asked)

What is happening is that some of them lease cars in other states and would like to license them in North Dakota -- When

they go to the DMV they are told now we want excise tax on that vehicle. This amendment would exempt them from the excise tax because we would gain some income. That is because they will likely license them but with the excise tax and license they probably would pay neither. They would say to heet with that I will just keep the Iowa license plates to what ever state. That is all section two does.

Rep. Hawken: (123) In section 1 --

Sen. Stenhjem: That is what you guys did. We would also like to have the emergency clause on because there are some that would like to register their vehicles now and why make them wait until August.

Rep. Hawken; (145) Does any one have any comments on how the bill stands now?

Sen. Stenehjem: As I read this now my memory is refreshed a bit -- what you sent over to us from the House is a bill that would allow -- and that is in section 1 -- it would allow the \$50 surcharge. Personally I didn't think nor did the rest of us to start putting in there the sheriff's office the ability to start charging anybody \$50 and putting it in their coffers. Their job is to enforce the law; not to be making money -- so what we did is basically like they do to truckers -- if you haul dirt or sand and gravel -- they don't license their vehicle up to the full maximum weight right away in January and February and March because they are not hauling much in those times but if they get into April, May or June when they start hauling loads -- if they don't have them licensed they make them go back and license them from January 1st. Basically what this does if you don't have your permit like you are supposed to have your permit -- the day you get stopped you license your vehicle that day in North Dakota period. So that is kind of a penalty. And in that case 37% of that goes back to the counties and cities and the customer is still liable

for the \$20 or whatever the ticket is for not having the proper registration on their vehicle.

Hopefully this will take care of the problem they had out there and in our opinion it was a good resolution.

Rep. Ruby: (275) The reason we put that on locally was because the resident along the border because right now Montana if very persistent about enforcing their law and North Dakota hasn't and we thought if they got a little bit locally they would enforce it better.

Sen. Espegard: But where do you stop on that -- they are doing their job.

Sen. Stenehjem: And they will probably be stopped for a \$100 registration so they get it back.

Rep. Hawken: (340) So we are getting it indirectly -- you all may not know we did kill this bill once. And then we did amend it further and that was what you all got.

Rep. Ruby: Sen Schobinger wanted the amendment you put on.

Sen. Stenehjem: I think this is a very good bill now -- it is what we should be doing.

Sen. Espegard: When you go across the border into South Dakota and Montana they are right on you. I hope this works the way we think it will.

Sen. Stenehjem: And you don't get by for a\$100 -- more like \$400 -- 450. But Every state funds their operation differently.

Rep. Hawken: (520) So is everyone satisfied with the bill as it is if we add the emergency clause.?

Sen. Stenehjem: I move that House accedes to the Senate amendments and further amends and we add the emergency clause.

Sen. O'Connell: I second the motion.
