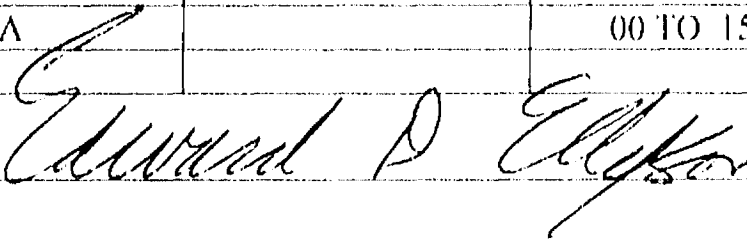

1A:5100 CHAIRMAN NICHOLAS: We will open the hearing on HB 1272.

REPRESENTATIVE DEKREY: I have an amendment for this Bill. What it would do is set up two grate's. Please see attached printed testimony. We would be dealing with 1,000 acres.

The bill relates to gratis licenses to hunt deer. The farmer support the deer. They raise them.

The farmer for the most part raised all of that. They think as a very small token of appreciation the hunting should give them at least one hunting license.

Representative Mueller: What happens when someone living out of state but own one thousand acres. Can that individual come in and take advantage of the gratis license.

DEKRAY: They can under the current law.

If you own land in more then one unit, you have to choose the unit.

Roger: 10,650 and there are 80 to 90,000 deer licenses issued.

Roger: I'm not certain. Agricultural Statistics has some information but I don't know.

There are not very many people taking advantage of it.

Representative Mueller: Do you get a lot of complaints about twenty dollars. from land owners.

Roger: There is an issue about this Bill. It is all about the twenty bucks. That is really what it come down to in my opinion. We hear a lot from land owners, it is negative.

Representative Lemieux: Mr Chairman. If we excluded the highly desirable mule deer areas in the state, then there would be less objection from the sportsman about this.

Roger: The gratis license is good for the mule deer as well as others. There is a one to two year wait to get a white tail license etc.

Where ever you own land you can hunt. This bill would be more restrictive.

Response: We issue those license now at no charge. There would be a fiscal note to this.

Right now a lot of the farmers are we are pretty flexible as to the way we issue gratis licenses.

Meaning that people can go through the regular lotteries and if they don't get a license they can come back later. If they are unsuccessful in the lottery, we hold licenses back and then issue them as gratis. I think the fiscal note is around \$300,000.00 per biennium.

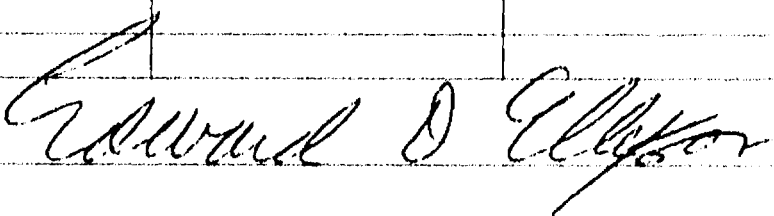

Chairman Nicholas: Rep. Froelich is handing out his amendment for HB 1272.

Rep. Froelich: This amendment here is actually Rep. DeKrey' amendment. This would take the fiscal note out of it. Basically what this does is says if you want that right, you will pay that fee requirement for residents big game license. There will no longer a fiscal note attached to this. It would be revenue neutral. I think it is self explanatory.

Rep. Renner: The 1000 acre requirement. Since they are going to have to pay the \$20 for the license anyway and I think there are a lot of legitimate farmers out there that we could make happy. I think there are a lot of people who own 1/2 or 1/4 sections who are deserving of this treatment as much as someone with a 1000 acres. I hate to put an acreage thing into it, because we are going to make some people mad. If we didn't put that in there, would it be anyone who owns a 1/4 or 1/2, what is the gratis now.

Rep. Froelich: 160 acres. That was moved to amend the amendment to strike that language and let it be, same as the other gratis license.

Chairman Nicholas: Is there a second? Second by Rep. Renner. All those in favor of the amendments signify by saying aye. All opposed? Motion is carried. The chair will entertain an motion on Rep. Froelichs amendments.

Rep. Froelich: I move.

Rep. Lemieux: I second.

Chairman Nicholas: All those in favor signify by saying aye. Opposed? Okay we have HB 1272 with amendments. The chair will entertain a motion on 1272 as amended.

Rep. Wrangham: I move a Do Pass.

Rep. Froelich: I second.

Chairman Nicholas: Any discussion? What this is going to do is give us two classes of gratis licenses. It is going to give us one class which is free and another class where the farmers apply for and pay \$20 and be assured of getting a license.

_____ : They pay for the license but they can hunt the entire unit on which their property is located.

Chairman Nicholas: That is correct.

_____ : Is that the majority of the property ownership or anywhere, you make the choice?

Chairman Nicholas: No, he can hunt the whole unit. He will be able to get a license now. As a landowner he is automatically qualified. He can pay the \$20 and hunt the whole unit, including his own where he can get the gratis license for.

_____: Let's say his land is in two different units. Right on the boundary. Does he have to choose the unit? Does it go with where he owns the most land? Or can he pick a unit?

Chairman Nicholas: It goes with the unit he picks.

Rep. Mueller: What I think we are doing on HB 1272 is we are doing two things. We are serving the guy the license which is a gratis situation currently. And we are also assuring him either a buck or a doe in that unit.

Chairman Nicholas: Any other discussion? The question has been called. Clerk will take the roll.

Rep. Lemieux: Can I ask one question? So really we are assuring that landowner will get a license, then the gratis license allows them to take any deer, buck or doe, versus the lottery where you are assigned a certain animal.

Rep. Berg: This one here is another gratis tag, you are still allowed anything, but you have to pay the \$20 fee.

_____: The difference would be the other people in the lottery, they would have to take a particular buck or doe. I guess the question is, I am assuming Game and Fish would say this would have a bigger impact on the unit because people will be taking bucks in a bigger area than before.

Chairman Nicholas: Any other questions? The clerk will take the roll.

It is difficult to estimate the number of gratis license applicants will use this option to get a unit wide license. 4000 per year for the 2001-2003 biennium and 5,000 per year for 2003-2005 is our estimate. Additional hunters will utilize this option to avoid having to be in the license lottery. Costs for them and Game and Fish revenue will not change, since they are already purchasing a license.

Some hunters who have been getting gratis/no charge licenses will purchase licenses. They will then be able to hunt off of their land and in the entire unit where their land is located. This will result in additional revenue for the Game and Fish Fund.

Currently many landowners purchase regular deer lottery hunting licenses because they want to hunt in more places than just their land. With this bill they would get the unit license at no cost. This would reduce the number of licenses available for purchase in the lottery. It is very difficult to estimate the number of licenses that this would involve. As more people learn about this, more landowner licenses will be issued. This will be especially popular in the mule deer hunting units where 6 or 7 people are applying for each license. It will significantly reduce the number of licenses that are available to hunters who are not landowners.

It is estimated that about 5,000 individuals would utilize this option. Note that it is very difficult to estimate this number. This would result in a reduction of revenue of \$140,000 to \$150,000 per year.

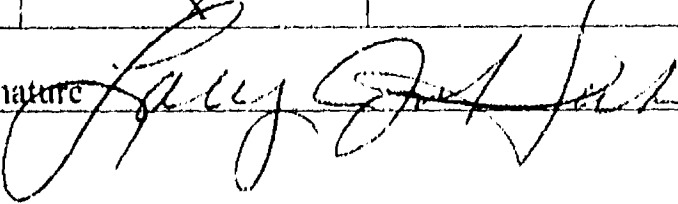

REP. DEKREY; Sponsor, introduced the bill to the committee. With the amendment I handed out, what it would do is make another gratis license in white tail deer for landowners. To qualify for this license a person would have to own and operate at least 640 acres, the reason for that is we don't want to set up a system where out of state people can come in and buy land. We felt that 640 acres would be enough land and expense to prevent people from buying land just to be guaranteed a gratis deer license. They could have to choose between this preferential gratis license or the old style gratis license. This guarantees them a white tail gratis license and lets them hunt unit wide in the unit they choose. If they have land in two units they have to choose one unit to hunt in and they would have to pay the license fee. The other problem with the bill is there are no provisions for mule deer. The way this is written you would be eligible for mule deer. The amendment would take mule deer out of the bill.

SENATOR WANZEK; I see this as a privilege and who actively farms is more important than ownership of land. There are a lot of young farmers that don't own a lot of land but farm a lot of absentee land, who are distributing to the deer food supply.

REP. DEKREY; We worked with the hunting groups. They are leery of someone coming in just for the purpose of hunting. There are a lot people who have hunting leases.

SENATOR URLACHER; Do that mean to farm or ranch?

REP. DEKREY; Yes, it is farm and ranch. This will not take effect until 2002 deer gun season.

SENATOR ERBELE; In the old gratis license you could shot a white tail of any sex, what about this one?

REP. DEKREY; It is a lottery, you have to put down your preference.

SENATOR KROEPLIN; Does this bill guarantee you a license as amended?

REP. DEKREY; As amended you are still guaranteed a license. As a land owner the only thing you get out of this is you would be guarantee a license in the lottery and you would also be able to hunt unit wide. The price you pay for that is \$20 and you can't put in for the other gratis if you don't like the tag you get.

SENATOR WANZEK; Are you guaranteed to get a buck license?

REP. DEKREY; No, you are going to be in the lottery like everyone else.

ROGER RESTUET; ND Game and Fish Dept., testified in opposition to the bill. See attached testimony.

SENATOR KLEIN; Do these amendments address your concerns

ROGER RESTUET; I don't believe that they address my concerns. There would have to be additional language for us to carry this out.

SENATOR KLEIN; I think the intent is to include those in there, maybe that is an area we could work through.

ROGER RESTUET; The intent may have been there but it is not in the amendment as it is written.

SENATOR WANZEL; The amendments make a significant change going from 160 to 640 acres and adding the words actively farms or ranches the land, taking care of the fear that absentee land owners are not going to come in and buy a quarter of land to get a license.

ROGER RESTUET; That would definitely change the overall pool. The concern under the original 160 acres non farmer type, is that there is a tremendous pool out there of individuals that own 160 acres of land. The 640 acres would significantly reduce that number.

MICHEAL DONAHUE; ND Wildlife Federation / United Sportsmen of ND, testified in opposition to this bill. See attached testimony.

CURT DECKER; testified in support of this bill. Initially the way the bill was wrote, I was against it. It was taking away from my opportunities and I was afraid it was going to start the deterioration of landowner sportsmen relations. The initial intent of the bill was to compensate the agriculturists, the rancher and the farmer who were putting up with the sportsmen and the wildlife. This has gone overboard as far as absentee land owners. We are seeing a lot of abuse of this from people in the eastern part of the state coming to the western part, where they own a quarter section of land, to hunt. Application deadlines are another loop hole that absentee landowners have found. They are applying for the standard drawing, if they don't get then they are going back to the Game and Fish and saying they want their gratis permit. This is taking away from others opportunity to draw a gratis permit. We need a mandatory deadline and only put in for one of the permits, not both.

**TESTIMONY OF THE NORTH DAKOTA GAME AND FISH DEPARTMENT

The concept of allowing the use of a gratis deer license for the entire unit is not a new idea. Numerous variations of this concept have been studied by interim agriculture committee studies on the gratis license system in years past. Virtually no one totally disagrees with gratis licenses for farmers/ranchers and landowners as a reward for providing deer habitat on land they own or lease for agricultural purposes. Currently individuals who are eligible for a gratis deer license must hunt upon land that qualifies them for their gratis deer license, except that recent legislation has allowed relatives with gratis licenses to hunt as a group on each others property.

Under the current requirements the number of gratis deer licenses has increased over 17 percent in the last 5 years to its current level of 10,650, even though the number of farmers and rancher is decreasing. It is hard to estimate the increase in gratis license applications because of lack of specific information on how many individual owners there are of the 270,000 quarter sections of land in North Dakota. What ever the number is, their certainly would be an incentive for both resident and nonresident landowners with little or no deer habitat to become part of the gratis license system, and enjoy the flexibility of taking a deer of any species or sex. Such an expansion would tax the limits of our current deer license allocation system, especially in areas where certain types of licenses are currently in high demand. This type of action would undermine the concept that gratis deer licenses are based on deer habitat and production agriculture and not simply an advantage afforded landownership regardless of size.

For these reasons the North Dakota Game and Fish Department urges a **DO NOT PASS** recommendation on HB 1272.

**TESTIMONY OF THE NORTH DAKOTA GAME AND FISH DEPARTMENT
HB 1272 GRATIS UNIT LICENSE
SENATE AGRICULTURE COMMITTEE
MARCH 15, 2001**

The concept of allowing the use of a gratis deer license for the entire unit is not a new idea. Numerous variations of this concept have been studied by interim agriculture committee studies on the gratis license system in years past. Virtually no one totally disagrees with the philosophy of issuing gratis licenses to farmers/ranchers and landowners as a reward for providing deer habitat on land they own or lease for agricultural purposes. Currently individuals who are eligible for a gratis deer license must hunt upon land that qualifies them for their gratis deer license, except that recent legislation has allowed relatives with gratis licenses to hunt as a group on each others property. The Department has been relatively liberal in accommodating gratis licence applicants.

At first glance this bill would appear to be a winner for both the department and landowners. The fiscal note is revenue positive to the department. The landowner would automatically get a license for the entire unit without going through the lottery and that license would be a better license than the regular lottery because it would be good for any sex or species. It could even be reasoned that landowners would be more likely not to post their land or allow increased access because they would not have to hunt only on their own land, however the devil is in the details.

Landowner sportsmen relations are always a precarious balancing act when it comes to dividing up a limited resource, and buck deer can certainly be considered a limited resource. The lottery system for license allocation and the gratis system have developed together over the years. At the present time this balance seems to be working. Eliminating a significant portion of the buck licenses available to sportsman certainly will affect this balance. Under the current requirements the number of gratis deer licenses has increased more than 17 percent in the last 5 years to its

current level of 10,650, even though the number of farmers and rancher are decreasing. It is hard to estimate the increase in gratis license applications if this bill passes because of the lack of specific information on how many individual owners there are of the 270,000 quarter sections of land in North Dakota. Whatever the number is, there certainly would be a significant incentive for individual landowners to avoid the lottery and get the best possible license available, this would especially be true of absentee landowners with little or no deer habitat who currently participate in the lottery. Currently there is no overall shortage of deer or total deer licenses in North Dakota, the concern is that the majority of sportsmen and landowners have a definite preference as to what type deer they want to hunt, that preference is for a buck. In fact when given the choice to take either a buck or a doe as the current gratis system allows 75% of gratis license holders harvest a buck. The application rate for the regular lottery confirms this preference as 77% of lottery applicants first choice is for a buck. Increasing the number of gratis/preferential licenses will decrease the odds of drawing a buck license in the lottery. A statistical analysis based on current application rates and gratis issuance reveals that a 1% proportional increase in gratis licenses for a deer unit equates to .9% decrease in the odds of drawing a buck license. Most individuals immediately focus their concerns on badlands mule deer units, but the reality is that the largest group of hunters affected would be white-tail buck hunters statewide, currently some white-tail units such as 2J1 the average chance of getting a white-tail buck license is once every three years. Such an expansion would tax the limits of our current deer license allocation system, especially in areas where certain types of licenses are currently in high demand.

From a resource management standpoint this law would confront the Department with significant challenges. We would have to immediately withhold an additional number of buck tags from each unit prior to the lottery, not only to accommodate an increase in landowner preference licenses but to accommodate gratis and landowner preferential licenses applied for after the regular lottery deadline.

This Law would require that the department either close the mule deer season most years and at a minimum issue no license in the regular lottery in 10 hunting units(3B 1-3, 3C, 3D 1&2, 3E 1&2, and 3F 1&2) along the Missouri river and Missouri slope as there would be more licenses valid for mule deer than total number of mule deer alive. We have been able to manage these areas for mule deer because mule deer are confined to limited geographic areas and only limited sportsmen licenses are issued, only the landowner with mule deer on their land can harvest one.

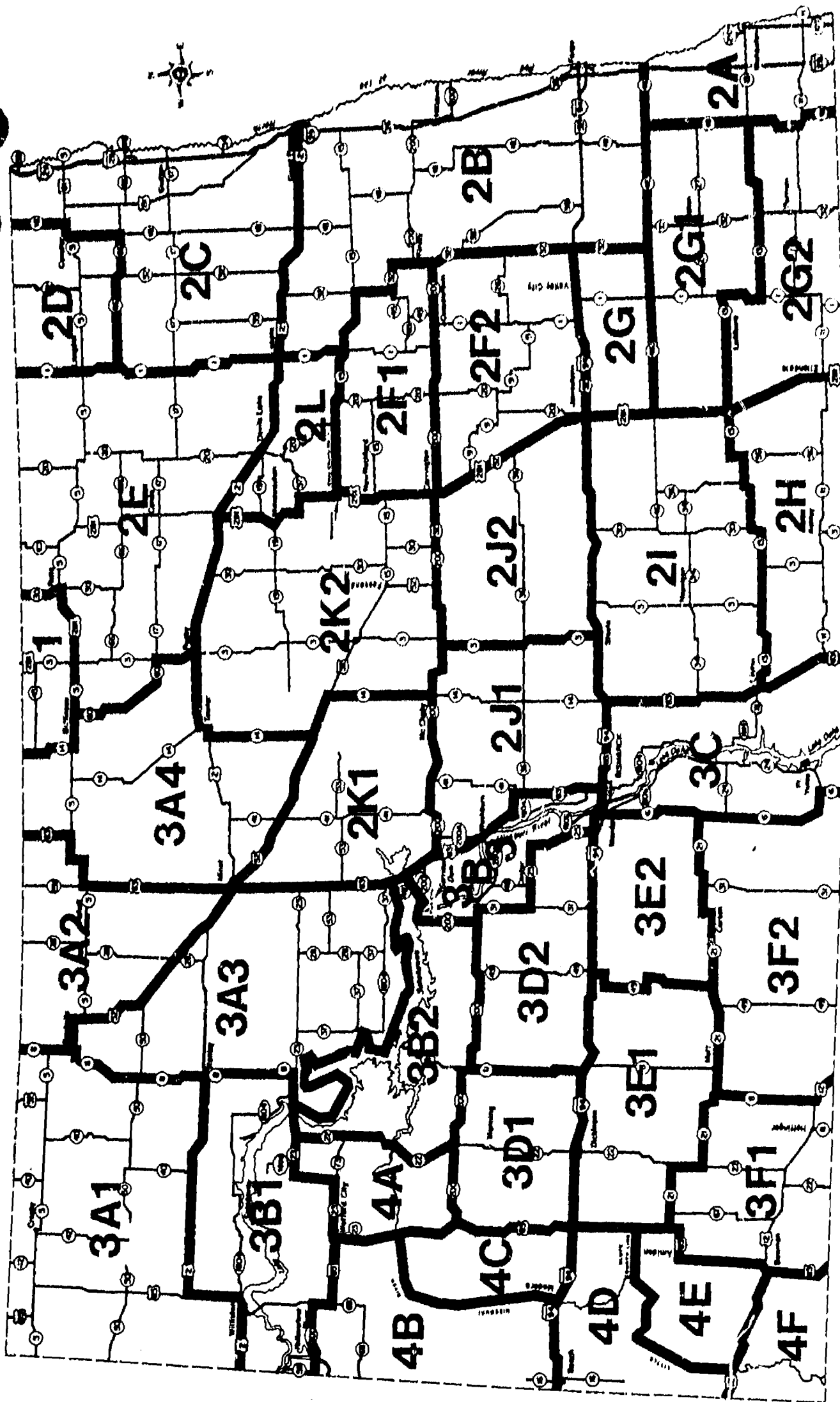
In conclusion, the thought behind this bill may have been to reward production agriculture, but the greatest benefit will be for the individual who is the absentee landowner. This type of action would undermine the concept that gratis deer licenses are based on deer habitat and production agriculture and not simply an advantage afforded landownership. Individuals in production agriculture could be view by non landowners in the same light as absentee landowners, as having an unreasonable advantage over that individual in receiving a deer license of their preference. Real challenges would be created for the department in the allocation of licenses type and numbers (deer sex and or species), implementation dates, application deadlines, overloading of the lottery preference preference system and deer management.

For these reasons the North Dakota Game and Fish Department urges a **DO NOT PASS** recommendation on HB 1272.

TESTIMONY OPPOSING HB 1272

Engrossed HB 1272 is not about gratis (free). At lines 14 through 21 of page one, the language is about preference (a preferential license?) and exclusivity (a license reserved for landowners).

It is not totally friendly to the actively farming or ranching person; whether owning or leasing. Note that lease holders actively farming or ranching are not mentioned in lines 14-21.

All that is needed is to own land. The sidewalk (city dweller) farmer qualifies for this preferential license.

In the year 2000 season there were 10,650 gratis tags. The exponentiation effect of this bill is unknown. Will it be to the second power? Maybe, the fourth power! No one knows – we at this hearing can only speculate.

The lottery system, in particular the first lottery (i.e. buck tags), will be unfair to all who apply. Some units may become doe only for those sportsmen and women that only have the lottery to obtain a buck license. Resource management (the deer) may well become unmanageable.

HB 1272 is unfair to all of us and to the resource. And, this is the wrong setting in which to try quick-fix amendments to make the bill seem fair.

The N.D. Wildlife Federation and the United Sportsmen of ND ask for a Do Not Pass for amendments and for the engrossed bill.

Good morning Mr. Chairman and members of the Senate Agriculture Committee, my name is David R. McCowan from Mandan, North Dakota. I am opposed to House Bill No. 1272 because of loop hole that will be created by the wording of the bill that will allow people who own small amounts of land (160 acres) to lock up hard to get mule deer buck permits. I as a landowner of 320 acres in Morton County could list that on my gratis permit, purchase 1 acre of land in the Badlands and then list that as unit of choice to hunt in. I then would have a lifetime permit to hunt antlered mule deer in the badlands. I want to give you an example of current permit numbers in unit 4C. This unit is known to produce the biggest mule deer bucks within the State of North Dakota. In the deer gun draw for the year 2000 there were 350 antlered mule deer license's available. One percent of those are awarded to non-residents, so that takes the number of licenses to 347, there were then 109 gratis applications, so that then takes the number down to 138 available licenses. There were 2,135 people who then applied for the 138 tags that were left. That gives you

less than 1% chance of drawing a tag. Your odds do go up every year that you apply and get turned down because you accumulate bonus points. On average you should get drawn every 4-6 years using the current system. I feel that the current number of gratis tags of 109 for unit 4C is really high for the number of ranches that you see in this unit. I suspect there are already a number of 160-acre plots of land that have been purchased by people who have money to get a gratis license in that unit. If this bill passes I will be the first person to jump on the bandwagon and purchase 1 acre of land in unit 4C thus giving myself a lifetime license to hunt an antlered buck in the badlands. There will no longer be any reason to apply for this unit if you don't own land there because all available tags will be issued to gratis owners.
