Minutes: <u>Chair Kelsch</u> opened the hearing on HB1301 relating to school district reorganization bonuses; to provide an appropriation; and to declare an emergency.

Rep. Nottestad, Dist 43: support HB1301. This bill will hold back \$2 M appropriated for reorganization bonuses in the last session. There are a number of school districts that have reorganized and the money has not been paid. It will insure that the reorganization study will continue and that future ones will take place; and provide the financial incentive to the districts that were promised the money.

Rep. Aarsvold, Dist 20: here to support HB1301. For many session, we have always encourage school reorganization. We need to keep bringing schools together.

Tom Decker, DPI, Finance and Organization Director: (340) here to support HB1301. (SEE ATTACHED TESTIMONY)

Rep. Mueller: (752) What do you mean by "adjusted formula in some way"?

<u>Tom</u>: I'm not unhappy at all with the way that the square miles is for bonuses. You may want to put in a minimum enrollment. Some lesser square mile comes in with enrollment. 800 miles seems reasonable.

Rep. Nelson: (900) Why is it that the Langdon unit didn't receive the total \$500,000?

Tom: The formula is a three part deal. With the \$500,00 cap. You have to add the three pieces. Very seldom do you come up with the \$500,000.

Rep. Brucegaard: The Surrie/Sawyer failed. Was there a main sticking point or issue that we can try to fix and give another try.

<u>Tom</u>: Some things just aren't to be. Some history there.

Chair Kelsch: Any more testimony for or against? Hearing is closed.

(Tape 3, side A) Chair Kelsch: (1820) Let's take up HB1301.

Rep. Brusegaard: We don't need more than \$ 2 M to accomplish the reorganizations that will take place. Why are we appropriating \$ 3 M, then?

<u>Chair Kelsch</u>: Because the districts that have the bonus coming now, won't receive it until December of this year. What are committee wishes?

Rep. Hawken: I move a DO PASS and REREFERED to APPROPRIATIONS.

Rep. Timm: Opened the hearing on HB1301.

Rep. Nottestead: HB1301 very simply will hold back \$2 million dollars of appropriated last year for the reorganization bonuses and there are a number of school districts who are in the process today and this process hasn't been completed, and in essence it will do basically two things, it will insure that the reorganization studies continue toward a completed reorganization and secondly it will provide the financial incentive to the districts that was promised. At this point I would like to have Tom Decker come up and answer the technical questions.

Tom Decker, Department of Public Instruction. (Followed written testimony)

Rep. Timm: There is a question here by one of the committee members about your testimony pertaining to another bill.

Rep. Monson: Tom, I think your testifying on HB1310 and this is HB1301 and in your testimony you do say HB1301 but your talking about HB1310.

Decker: Mr. Chairman can I see a copy of the bill.? HB1301 should be the school district of restructuring bonus bill.

Rep. Timm: The one that restricts the amount of money that can be used.

Rep. Monson: Maybe I'm wrong. Yes I'm wrong.

Decker: You can see the amount of those bonuses, let me give you a work sheet that shows you the manner in which the bonuses are determined. The four districts that I have picked as an example for you are not currently engaged in discussions about reorganizations but I think they are an excellent example of what the possibilities are, and also excellent example of the sort of thing that's happening in some parts of rural North Dakota. You can see what the enrollment is in the Wing, Tuttle, Robinson, Pettibone districts that's in northern Kidder and northern Burleigh county, three districts that operate 2 K-12 and 2 K-6 at the present time four facilities and they have a total enrollment of 188 students. We project that their enrollment by 2006 will be 125, and those districts cover over 1100 square miles and the way the formula works they would qualify for a half a million dollar bonus if they came together into a single district. We believe that them coming together into a single district represents the kind of long term solution that we should be aiming for and for which we should be paying bonuses. 1100 square miles is a large enough area to require K-12 services into the future as far as we can see, almost regardless of what else happens, certainly probably not at 4 locations, but at some point in that area we will need K-12 services and we think that the bonus program is designed to facilitate those kinds of comings together, so you can see how that works out in terms of formula. Three different factors, its number of districts, number of students, and land area of the largest district in the unit.

Rep. Timm: The question is in this bill to me looks like there is originally three million dollars appropriated and what this bill says is that you can only spend one million dollars and you have to keep two million dollars in reserve, it talks about the bonuses but I think in a way Rep. Monson might be right, your testimony isn't pertaining to spending a million dollars or up to a million dollars and not spending the additional two million dollars, and that is what the bill is about.

Decker: I may be missing something but essentially this is the testimony that I have given on this bill in three other committees and SB2200 is virtually the same bill and I guess I don't understand the problem. I think were appropriating a total of 3 million for the next biennium carrying two million forward and adding one million to it making that available and authorizing the use of that money for future bonuses including those that are already owed.

Rep. Gulleson: There is another bill, but I haven't followed it closely, but the one that limits the 800 square miles for reorganized districts, do you know what the status on that is?

Decker: I think your probably talking about HB1384 which sets standards for approval of the reorganizations by the state board. That bill is in the House Education Committee at this point and the sub-committee will report to the full committee probably today.

Rep. Timm: Getting down to the money part of it, those three million dollars. Is this scenario right? There was three million dollars appropriated for this current biennium and you only spent approximately one million dollars of it and what you want to do is take the added two million dollars that you got for this biennium and put another million into it so that you end up with three million again, am I right on that?

Decker: The appropriation for last time is reflected in item C. Of section one here, there was a two million dollar appropriation last time that was contingent if it was available after other

allocations were paid, we could have spent up to two million, the way it worked out the timing of the reorganizations was such that in fact we will not pay out any money for bonuses in this biennium. The bonuses that are accrued in this biennium \$1.165 million will be due and payable in December in 2001, which is into the next biennium. So the request here is to move two million dollars of the foundation aid carryover forward into the next biennium and add another million to it, we paid \$1.165 million on schedule and have just under two million left to carry us through the rest of the biennium for other bonus payments that may become due.

Rep. Timm: So were adding an additional million dollars to the fund then? Answer was yes.

Rep. Monson: When you cross out the language in C here you are not changing any of those provisions though, your still going with the same 800 square miles and all the things in your formula. That would remain the same so all this is doing is saying those that went with the incentive and through a technicality couldn't get paid this time will get paid because we would move that money that was appropriated for them forward to the next biennium, so you will continue the same exact program again for the next biennium?

Decker: That's correct, there are other bills that Rep.Gulleson points out that deal with the formula or reorganization issues, there is discussion going on about dealing or changing the 800 square miles, and so on, those are not in this bill, but those discussion are going on.

Rep. Monson: The is another Senate bill that is exactly like this one too. Right?

Decker: Yes that is SB2200.

Rep. Aarsvold: I hope I can clear up this issue. The dollars were talking about here are left over dollars after the foundation aid dollars are distributed and I think it was Sen. Freeberg who initiated the language we see here and said that the first million dollars of any left over money from foundation aid would schools based on ADM. (Average Daily Membership). The second

million of the left over dollars would go to schools that are experiencing declining enrollment and I think there is a formula that's available to account for that distribution, and then finally the next block of dollars, two million dollars of that leftover were to go to schools for purposes of the organization bonuses, so this was all tentative assuming if there were dollars left over, we would distribute them according to this formula and anything over the formula then that we have talked about would back to the school districts on the basis of ADM and I think the projection now is somewhere over five million. So the purpose of this bill and I appear here as a cosponsor says that we will guarantee that two million dollars for school reorganizations to make sure those school districts that have started the process of reorganization, but yet by time constraints were not able to conclude it would be still eligible for those dollars.

Rep. Carlisle: What is the criteria when they actually get the bonus money when its a done deal?

Decker: Bonus money is paid on December 1st of this year, that's 6 months after these districts become reorganized districts, the payment throughout the discussion was intended to be after the fact.

Rep. Timm: Any other questions? Any other testimony in support of HB1301? Any opposition? Hearing will be closed on HB1301.

In my logislative district, we have successfully used reorganization a number of times to pull together school districts that have I think have a long term viability into the future and its a lot like a marriage, if I might be so bold. We bring together people from diverse communities and it takes time to resolve differences that those communities might have.

Rep. Monson: There is something a little more even than that, that is involved with this, and some of those districts did meet all the timelines, and they did go through with the reorganization and they did everything that they were supposed to and we promised them they would get the reward. Rep. Monson went on to discuss some of the issues concerning reorganization problems.

Rep. Skarphol: I don't have a problem with the bill other than the fact that there is an identical bill in the senate, the only thing different is the name of the sponsors and the number on the top of the bill, and to answer a question that Rep. Glassheim had earlier, I asked in my second session what it cost to get a bill drafted, to get the bill drafted and to get it introduced, they told me it cost \$600. I just really resent having the same bill being introduced on both sides of the hall and I'm going to vote against both of them.

Minutes: CHAIRMAN FREBORG called the hearing on HB 1301 which relates to school district reorganization bonuses.

Testimony in support of HB 1301:

REPRESENTATIVE NOTTESTAD, District 43, stated this bill will hold back \$2 million of the monies appropriated for reorganization bonuses during the last session. There are a number of school districts who are in the process of reorganization, and keeping the funds in place will do two things: 1. Insure that the reorganization study continues into a completed reorganization, 2. It will provide a financial incentive to the districts that have been promised. SENATOR O'CONNELL wondered how many districts actually get the \$.5 million when you add the three components together. He does not know.

REPRESENTATIVE AARSVOLD, District 20, stated this corrects a problem that developed as a result of an oversight from the Session Laws of 1999. Chapter 169 called for the distribution of the leftover foundation aid dollars. Two million dollars of the leftover money was to be

designated for reorganization bonuses that were provided for in code in SB 1441, also passed in 1999. The oversight had to do with when a school district actually becomes a new entity, which is July 1st of the current year. The funding authority expires June 30th of the current year. We are at a midnight crisis. This bill would reserve \$2 million that was allocated from the leftover foundation aid dollars in Chapter 169 of the Session Laws and hold it in a safe position for the schools to qualify for the bonuses on July 1, 2001. The bill also provides for the addition of \$1 million to deal with reorganization bonuses into the next bicanium. He is told that there are \$1.1 million committed at this point to reorganizations for July 1, 2001. He has no problem with the Senate (companion) bill which does the same thing. SENATOR FREBORG stated the Senate bill was amended to have another \$1 million from this biennium surplus to cover the \$3 million. He stated the amendment was applied in Senate Appropriations and rather than taking the \$1 million from the general fund, it took another \$1 million from the surplus. SENATOR O'CONNELL again asked what % of districts get \$.5 million. TOM DECKER, DPI, answered that maybe 50% of the reorganizations would be eligible. SENATOR WANZEK asked about the square mile criteria. MR. DECKER said there is no specific legislation at this time to change the 800 square mile criteria for reorganizing districts.

There was no testimony in opposition to HB 1301.

Hearing no further testimony the hearing on HB 1301 was closed.

Representative Ole Aarsvold, District 20, Blanchard and sponsor testified in support of the bill. He indicated it is a correction for last session's oversight. July 1 was the effective date and the dollars ran out before completion --- like to continue in the future --- as provided for when working on the reorganization plans.

<u>Tom Decker</u>, Director of Finance and Organization, Department of Public Instruction, spoke in support of HB1301 (a copy of his written testimony is attached).

Senator Bowman: Is there a net savings after consolidation? When we give dollars to the districts to do it? Some return to the State?

I am here to speak in support of House Bill 1301.

As you know, the last legislative session the legislature adopted the school district consolidation bonus program. The legislation provides bonuses of up to one-half million dollars for reorganized districts that include at least 800 square miles of area.

I have attached a copy of the legislation from last session to my testimony. In addition, I have attached a copy of districts that have reorganized over the last two years and have indicated the effective date of the reorganization. Three newly reorganized districts will qualify for bonus money under this legislation. The reorganizations that they are involved in will become effective July 1, 2001, and we would expect to make their bonus payments to them around December 1, 2001.

HB 1301 as currently written will capture \$2 million dollars from this biennium's ending balance in the Foundation Aid appropriation and appropriate an additional million from the general fund to provide a \$3 million dollar line item for bonuses for the next biennium. This \$3 million dollars will include the current obligation of \$1.165 million to the districts who already qualify. That leaves somewhat less than \$2 million dollars for bonuses for the upcoming biennium.

The cycle through which districts become eligible for bonus money is somewhat complicated.

If a set of districts begin to work towards reorganization today, they should be able to have their county committee meet and approve the reorganization plan and the State Board meet and approve their reorganization plan by July 1, 2001. Those districts would then need to vote on the proposed reorganization in the districts between July 1, 2001, and the end of 2001. If the reorganization were approved, it would become effective July 1, 2002. Only those reorganizations that meet this cycle would require payments in the next biennium.

Districts, who begin to move on the reorganization issue after July 1 or into the 2001/2002 school year, would have their reorganizations become effective July 1, 2003. The legislature will have another chance by then to meet and to review funds needed to continue payments of bonuses. My point here is that the sum of less than \$2 million left after we pay current obligations out of a \$3 million appropriation will certainly be enough to get us through reorganizations that become effective July 1, 2002.

The bonus program is working reasonably well as currently structured. Before this session is over, we may feel the need to revisit the amount of bonuses and adjust the formula in some way. But generally speaking, it seems to be working reasonably well. I am not sure it is producing reorganizations at the pace that we need them given the rapid decline in enrollment that we are experiencing.

SENATE BILL NO. 2441 (Senator Freborg) (Approved by the Delayed Bills Committee)

AN ACT to provide for school district reorganization bonuses.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Reorganization bonus - Eligibility - Distribution.

- 1. If a school district reorganizes with one or more contiguous school districts or portions of districts, the newly reorganized district is entitled to receive a reorganization bonus, provided at least one of the reorganizing districts is a high school district and that the newly reorganized district consists of at least eight hundred square miles.
- 2. The total reorganization bonus to which a newly reorganized district is eligible consists of:
 - a. Fifty thousand dollars per one hundred square mile block, or a major portion thereof, included within the reorganized district and calculated by determining the lesser of the total square mileage of the reorganized district or one thousand four hundred square miles, and subtracting from that amount the square mileage of the largest district or portion of a district involved in the reorganization;
 - b. One thousand dollars per student calculated by determining the lesser of the total fall enrollment of the newly reorganized district or seven hundred fifty and subtracting from that amount the fall enrollment in the district or portion of the district that had the largest student population of those districts or portions of districts participating in the reorganization during the school year immediately preceding the effective date of the reorganization; and
 - c. Fifty thousand dollars for each whole school district that formed the reorganized district.
- 3. The superintendent of public instruction shall distribute the reorganization bonus to each eligible reorganized district during the month of December, following the effective date of the district's reorganization.

SECTION 2. Reorganization bonus - Distribution - Limitation. For purposes of distributing reorganization bonuses, the superintendent of public instruction shall determine the eligibility of reorganized districts chronologically, according to the date on which each district's reorganization plan was approved by the state board of public school education. After all other statutory obligations have been met within the limits of legislative appropriations, the superintendent of public instruction shall make the distribution of reorganization bonuses from funds made available in the grants - foundation aid and transportation line item in Senate Bill No. 2013, as approved by the fifty-sixth legislative assembly, for the 1999-2001 biennium, provided the superintendent may not expend more than two million dollars during the 1999-2001 biennium for the purpose of this Act. No reorganization bonus payable under this Act may exceed five hundred thousand dollars. A reorganized district that receives a reorganization bonus under this Act is not eligible to receive additional reorganization bonuses based on future reorganization efforts for a period of ten years.
