Senator Stenehjem: Co-sponsored the bill, testified in support. 1302 is a companion bill to a bill we will be hearing next week that has to deal with payday loans. This bill corrects technicalities which exist for pawnbrokers currently operating in our state. This legislation, if passed, would exempt pawnbroker transactions up to \$1,000 from North Dakota's usury provisions.

2001 TESTIMONY HB 1302

TESTIMONY FOR HB 1302 By Jay Conture President, NDPA

Chairman Berg & Members of the Committee, I want t thank you again for this opportunity to speak before you and ask for a "DO PASS" recommendation on HB 1302.

I am Jay Couture. I am the President of the NDPA. My wife and I also operate Jay's Pawn Shops in the Bismarck / Mandan area... we've done so for the past 15 years.

HB 1302 is something of a "house keeping" bill. While I can see that it updates language and makes it consistent with current law, I do not want to minimize its importance.

This bill will amend NDCC Section 47-14-09 and will serve to specifically exempt pawnbroker transactions up to \$1,000 from usury provisions. The passage of this amendment is critical if pawnbrokers are to continue to operate in ND.

I would like to point out several things as I ask for your support of this bill and let you know that this is a bit of a technical issue...

- 1. NDCC, chapter 13-03 deals with small loans. In 13-03.1-02(2), it clearly & specifically states that this chapter does not apply to pawnbrokers.
- 2. NDCC, chapter 40-05-01(26) authorizes municipal governments to license, tax & regulate pawnbrokers.
- 3. If you visit the Department of Banking & Financial Institutions web site, you will see who this department does <u>not</u> regulate. This web site clearly states that the Department does <u>not</u> regulate pawnbrokers. More specifically, under the pawnbroker heading, the web site states that "Pawnbrokers are licensed and supervised by the municipality in which they are located."

While it is the intent of state law to allow local municipalities to license, regulate, tax, control & supervise pawnbrokers, the law of supremecy applies. In no case do local city ordinances supercede state code. Consequently, without a specific exemtion for pawnbrokers, state law may apply. If pawnbrokers are to continue to conduct business in ND as they have since the days of Custer, they need to correct this technical oversight and write a specific exemption into section 47 of the NDCC.

Therefore, I respectfully ask for a "DO PASS" on HB 1302.

This letter summarizes the amendments to North Dakota Century Code Section 47-14-09 provided in the attached bill draft. Section 47-14-09 defines usury and provides who is exempt from the usury provisions.

The attached bill draft clarifies that bona fide, licensed pawnbroking businesses may make bona fide wnbroking transactions up to \$1,000 without violating the usury provisions. We understand the intent of a bill draft is to allow licensed pawnbrokers to continue to conduct business without threat of violating the usury laws.

Testimony for HB 1302 By Jay Couture President, ND Pawnbrokers Association

Chairman Urlacher and Members of the Committee, I want to thank you for the opportunity to speak before you and ask for a "DO PASS" recommendation on HB 1302.

I am Jay Couture, President of the North Dakota Pawnbrokers Association. My wife and I also operate Jay's Pawn Shops in the Bismarck/Mandan area.....we've done so for the past 15 years.

HB 1302 is something of a house-keeping bill. While it updates language and makes it consistent with current laws, I do not want to minimize its importance.

This bill will amend NDCC 47-14-09 and will serve to exempt pawnbroker transactions up to \$1,000 from usury provisions. The passage of this bill is specific to pawn transactions and seeks to recognize in state law that which is currently authorized by municipal governments and is critical if pawnbrokers are to continue to operate in ND.

This is a bit of a technical issue and 1 90 int out a couple things about this legislation as I ask for your support:

- 1. NDCC, 13-03 addresses small loans. In 13-03.1-02(2), it states that Chapter 13 does not apply to pawnbrokers conducting a pawn transaction.
- 2. NDCC, 40-05-01(26) authorizes municipal governments to license, tax and regulate pawntrokers.

While it is clearly the intent of state law to allow local municipalities to license, regulate, tax, control, and supervise pawnbrokers, in no case do local city ordinances supersede state code. Consequently, without a specific exemption for pawnbrokers in Section 47-14-09, state law may apply.

Therefore, if pawnbrokers are to continue to conduct business in ND, as they have since the days of Custer, this technical contradiction must be corrected.

Mr. Chairman and Members of the Committee, I respectfully ask for a "DO PASS" recommendation on HB 1302. I will be happy to answer any questions you may have.
