

Testimony on House Bill 1323 Political Subdivisions Committee

Mr. Chairman and members of the committee, my name is Joel Boespflug and I am the Chief of the Bismarck Fire and Inspections Department and a Director with the North Dakota Fire Chief's Association. I appear before you today in support of House Bill 1323.

On page 3, lines 15-27 establish the requirements that a fire department must meet in order to receive premium tax rebate monies from the Insurance Department. The changes in lines 21-25 refer to a more appropriate fire protection standard that is already in place in North Dakota and throughout the nation. For the purpose of this bill and for legislative intent, a "class 9 protection" as listed on line 22, is intended to be the community fire protection rating of nine in accordance with the Insurance Services Office Fire Suppression Rating Schedule. Throughout the state and nation, this rating schedule is inplace and is widely utilized by insurance companies as a community fire risk measurement tool. The "class 9 protection" requirements refer to a fire departments organization, membership, training, handling of alarms, apparatus, equipment and records. It is much more applicable to modern fire protection in comparison to the original wording in the Century Code.

The change provided in this bill on page 3, lines 23-25 is favorable. The second sentence had required that a fire department must be in good standing with the North Dakota Firemen's Association in order to be eligible to receive rebate monies from the Insurance Department. To be in good standing currently requires that the fire department has paid its annual membership dues, which are established and collected by the Firemen's Association. There is no direct correlation between paying annual dues to an organization and to the purpose of the insurance rebate monies. There is however, a positive and measurable relationship between the insurance rebate monies given to the fire department and the common objective of reducing the fire risk for a community.

Mr. Chairman and members of the Committee, I urge you to pass House Bill 1323.
