REP. AL CARLSON, CHAIRMAN, Opened the hearing.

REP. BILL PIETSCH, DIST. 22. Introduced the bill at the request of a disabled veteran who is a constituent in his district. He found out last summer that a motor vehicle exemption on a second vehicle, which is allowed to have a distinctive license plate, according to the law, was not eligible for the motor vehicle tax exemption. At his request, I have had this bill drafted. He also submitted an amendment prepared by the legislative council. The amendment would re-define disabled American veterans. We would want to make another change to the amendment, which would make the eligibility for a distinctive license plate line up with the eligibility for a motor vehicle tax exemption.

REP. CARLSON Stated, we cannot remove the reference to the federal law?

REP. PIETSCH It is my understanding, without that reference, you may have people with a very minor disability, eligible for this.

**REP. DROVDAL** Related to section 2, a motor home would also be exempt from the taxes?

**REP. PIETSCH** It is my understanding, it does relate to vehicles of 10,000 pounds or less.

**REP, DROVDAL** You are taking that language out, if this passes, as presented, any vehicle regardless if it is a car, truck, 18 wheeler, or RV, would meet that exemption?

REP. PIETSCH I really couldn't say.

**REP. WINRICH** The fiscal note says, this bill would have a fiscal effect of less than \$5,000, current department policy is to allow an exemption for a second vehicle, owned and operated by a disabled veteran. In effect, what this bill does is codify current practice.

**REP. PIETSCH** That is my understanding.

REP. OLE AARSVOLD, DIST. 20, Testified in support of the bill. See attached written testimony. He also supported the amendments presented by Rep. Pietsch.

BOB HANSON, COUNCIL OF VETERANS, Testified in support of the bill. He pointed out that Line 8, did mention taking out vehicles of 10,000 pounds. He also supported the amendments presented.

**REP. PIETSCH** Stated he would have another amendment drafted.

KEITH KEISER, DIRECTOR OF MOTOR VEHICLE DIVISION IN THE DEPT, OF

TRANSPORTION, Testified in support of the bill. Gave an explanation of how the bill came about. He referred to the reference in federal law, which defines who is qualified. It limits that qualification to those veterans who receive financial assistance from the veteran's administration if they have suffered loss of limb or eyesight and that they need special controls in motor vehicles to operate those vehicles. That reference was always there, and that was how it was interpreted. The legislature had also granted a tax exemption for a vehicle registered under this statute. In

1987, the legislature expanded that, to include two vehicles. It did not change the past exemption statute, which is section 2 of this bill to include two vehicles being tax exempt also. We incorrectly interpreted that, in fact, there was a second tax exemption. Since 1987, we have allowed a second tax exemption for vehicles for veterans who require a vehicle which meets the registration exemption.

Mr. Keiser stated he would check the amendments to make sure they were drafted in proper form.

With no further testimony, the hearing was closed.

<u>Senator Urlacher</u>: Opened the hearing on HB 1325, relating to motor vehicle excise tax exemptions for motor vehicles acquired or leased by disabled veterans.

Senator Wardner and Senator Christmann absent.

Representative Bill Pictsch: Co-sponsored the bill, testified in support. This bill is at the request of a disabled veteran, who thought that something needed to be done legislatively in order to clarify and bring the exemption on motor vehicle excise tax into concurrence with the policies that the Highway Dept. has been implementing. In 1987, disabled veterans became eligible to license two vehicles. They overlooked granting the excise tax exemption on that second car at the same time that they allowed for the licensing of a second car with the distinctive license plate. They have been granting it all along. This would extend what the department had been doing and include it in the Century Code. There is no fiscal note to continue to provide that exemption.

Representative Ole Aarsvold: Co-sponsored the bill, testified in support. Written testimony attached.

Keith Kiser: ND DOT, testified in support. A year ago, we discovered we were granting the second exemption incorrectly. The statute that provides for the licensing of disabled veteran vehicles requires a \$5.00 annual fee. In that statute, there is specific language that exempts them from the payment from the state sales and use tax. Based on that, we have always granted an extension. It was an oversight at the law was changed and this is an effort to correct that.

Senator Stenehiem: How does this compare to SB 2209?

Keith Kiser: SB 2209 deals with the other part of this equation with is POW's. The same tax exemption problems exist. That statute is limited to one license plate and one tax exemption.

Senator Stenehjem: So if you're a POW, you get one exemption. If you're a disabled veteran, you get two.

Keith Kiser: That's correct. Those are not new concepts. The POW license plate legislation passed in 1981, no one's ever asked for that two be extended to two.

Senator Nichols: How many individuals fall into this category?

Keith Kiser: Around 200.

Bob Hanson: ND Veterans Coordinating Council, testified in support.

Senator Urlacher: Closed the hearing. Action delayed.

Others signed the roster in support.

Discussion held later.

Senator Stenehjem: I am going to support this bill. I certainly am appreciative to the sacrifices that are military personnel have made. But we can't give them everything. And, I have a
