Rep Grande: District 41, Fargo, introduced the bill, this would give the right to use something other than polygraph. Page 1, line 8 - a is the new language of the bill. The amendment to the will is to take out the word it and add the new language on lines 20, 21, 22.

Rep Delmore: What other devises do they want to use and how reliable are they?

Minutes: Senator Traynor, opened the hearing on HB 1379.

Rep. Grande, testifies in favor of HB 1379. Primary sponsor of the bill

Lt. Rick Majerus, Cass County Sheriff's Department, (testimony attached) supports the bill.

Senator Watne, has this been approved by the Attorney General and is it in their budget?

Rick Majerus, the Attorney General has approved the polygraph machine use. The Attorney

General has in place a certification process for these machines. Officer still needs to be certified.

Senator Trenbeath, are poly operators licensed by the state? If the results are not admissible in court, why do we need this?

Rick Majerus, same question came up in the house. Polygraph is the only instrument certified.

Senator Trenbeath, people can't administer without being certified.

Rick Majerus, the bill was drawn up that way. In discussion with the poly operators they didn't want to hurt the amendment.

Senator Bercler, have the support of poly examiners, are there any here today? Will we hear from them?

Bob Bennet, from the office of the Attorney General, quite a few courts have treated the "voice stress analysis" machine just like a polygraph machine. Polygraph machines can only be used as evidence if people consent to it. Have 16 people licensed as polygraph operators in ND. May not be impossible to do-but don't know why may happen.

Senator Traynor, if this passes, would the attorney general need an appropriation?

Bob Bennet, I would assume that we would need it, with the hearing process and licensing. There will be a cost involved.

Senator Nelson, costs less than 5,000 dollars?

Bob Bennet, I don't know, I assume less than 5,000.

Dave Cyseneski, Detective for the Bismarck Police Department. Concern that legislation not taint the process we presently use. Had to do 50 field tests before licensing. Don't know requirements for other machines as far as licensing. Went to school as a polygraph examiner in 1998. Polygraph has been around for about 100 years and is an effective tool for detecting truth and deception.

Senator Lyson, would it be fair to say that FBI grads do this?

Dave Cyseneski, don't have any experience with the FBI.

Senator Lyson, any graduates from the FBI in you department?

Dave Cysenski, yes we have some.

Senator Lyson, have you discussed this with them?

Senator Bercier, are there other technologies in the next two years?

Dave Cysenski, No I am not. Some departments would like to use voice stress analysis.

Testimony in support of House Bill No. 1379 To the house Judiciary Committee On January 31, 2001

I am here to testify in support of House bill 1379, because I believe it will help law enforcement to provide better service to the public they serve.

Under current law, the only detection of deception machine that is allowed is the polygraph machine. I am not here to argue the validity of the polygraph machine or any other detection of deception machine. But rather I am here to have the legislative body give law enforcement the ability to use any technology at it's disposal. As the law is currently written it is much like telling law enforcement what kind of vehicle to drive or what kind of weapon to use rather than giving them the choice to use what best fits their needs

House bill 1379 allows the ability for law enforcement to use other deception machines that meet instrumentation requirements set fourth by the Attorney General of North Dakota. I have discussed this bill with many of my colleagues across the state and have had a lot of success with getting their support of this bill. It was never my intention to affect the integrity of the current law as it deals with the polygraph machine, but rather augment the usefulness of detection of deception machines.

I have also talked with several currently certified polygraph examiners and have gained their support as well, as long as the examiner portion of the law stays intact. Therefore, I would ask that the amended change in section 43-31-03 not be changed to exempt law enforcement but rather leave it the same except for

the minor change as noted toward the bottom of the page from himself to <u>oneself</u>. This will still make sure that an operator of any devise will still have to be licensed and certified to operate the devise by the attorney general.

I would also like to amend 43-31-07 subsection 5 to read as follows: Who has satisfactorily completed a polygrapin examiners course, or other certified courses for any deception detection devise approved by the attorney general. I believe this would allow the use of the polygraph and other deception detection devises by trained and attorney general licensed examiners.

I would like to thank you for your time and consideration on House Bill 1379 and ask you for a do pass.

House bill 1379 allows the ability for law enforcement to use other deception machines such as computer stress analyzers that meet instrumentation requirements set forth by the Attorney General of North Dakota.

I have discussed this bill with many of my colleagues across the state and have had a lot of success with getting their support of this bill. It was never my intention to affect the integrity of the current law as it deals with the polygraph machine, but rather augment the usefulness of detection of deception machines.

I have also talked with several currently certified polygraph examiners and have gained their support as well, as long as the examiner portion of the law stays intact.

Therefore, after the first reading of this bill the house amended the bill and simply wrote it up as an addition to section 44-08-20 which deals with powers of peace officers. With this amendment the use of other detection of deception machines would be allowable without affecting the polygraph examiner law. This will also make sure that an operator of any machine will still have to be licensed and certified to operate the machine by the Attorney General.
