REPRESENTATIVE AMY KLINSKI, Sponsor of the bill, introduced the bill. The Protection and Advocacy project has four appointments on their board. Two are legislative and two are Gubernatorial. This bill is asking that one of those appointees would be disabled or a family member of a disabled person. Passage of this bill will not change makeup of the board. It would affect future appointments.

CINDY VOLMER, Chairperson of the Protection and Advocacy, supports the bill and the entire committee has given a positive consensus (Written testimony)

#### Opposition:

BOB HARMS, Council to the Governor, opposes bill. There is no need for this bill. Practices forclude what has gone on. The Governor needs the flexibility to make up a well balanced

The Committee on Protection and Advocacy is the governing board of the Protection and Advocacy Project (P&A), a state agency with the mandate to protect, and advocate for, the rights of individuals with disabilities.

P&A was established in North Dakota in 1977. For years it was governed by the Executive Committee of the Governor's Council on Human Resources. In 1989, a State law was passed that provided for a separate governing board, called the Committee on Protection and Advocacy. With two of the seven appointments made by the Governor, the rest of the board membership was essentially self-perpetuating. In 1995, North Dakota law was revised to allow for the appointment of members by the Governor (2 members), the Legislative Council (2 members), the Mental Health Association in North Dakota, The Arc of North Dakota, and People First of North Dakota.

P&A is held accountable through a variety of mechanisms. It currently receives funding from four federal entities, each of which requires annual reports of the agency's expenditures and activities.
