Minutes: Chairman Krebsbach opened the hearing on HB 1406 which relates to the duty of the insurance commissioner to send annual reports. Appearing before the committee was Representative Dan Ruby, district 38, primary sponsor of the bill. He indicated to the committee that he supports the bill. This is a pretty simple bill which seeks efficiency from the insurance department. The way the law reads now the department is required to send an annual report to every state and to each company that does business in the state. He showed a copy of the report to the committee. At this time they are not following the law in its entirety. They are sending a summary of the report which looks like this. He held up a copy of the sheet. To these entities with a notice that if they wished a copy of the entire report they can request it. That one will then be sent to them. HB 1406 simply changes language in the law to match the current practices of the department. He believes this is a sensible move for the insurance department and respectfully asks the committee to give it a do pass recommendation. He indicated that they currently do print 150 copies of the report. They will continue to do so because they need to

send it to the various agencies, and some of the state departments. It costs \$480.70 to make 150 copies of the report. If somebody requests more copies it costs \$10.00 per copy. If they sent out to 1500 companies the approximate cost would be \$4810,00 plus \$1.75 shipping each. Basically by sending just the summary to the companies that would need a copy and then if they would like further information this would save money. Senator C. Nelson inquired why didn't you just write the bill to send a summary of your annual reports to all those folks and that the full copy of the report is available on the Internet. That would save you sending out all these and you would be doing what you are doing now. You would legitimize the current practice. Representative Ruby indicated that this is not currently available on the Internet. He also indicated that however, this was something that could be done. Senator Dever noted that he didn't see anything in that bill that would preclude what Senator C. Nelson just suggested. Do you know if we receive these kinds of reports from all the other states? It was noted that some of the other states send out books. Chuck Johnson, an attorney with the insurance department, appeared before the committee. He indicated that the first reaction they had when they looked at changing the law was to conform the law to their current practice. They didn't look at Senator C. Nelson's question about putting it on the Internet. This would not be too difficult to do but let us ride for another two years and if necessary we can come in in a couple of years. We will be looking at certainly other legal obligations that we have with notifying the public relating to publishing all of the companies annual reports in all of the county newspapers in the state. There are tremendous costs involved in all of this with questionable benefits. This has been visited before and has gone down in a ball of fire as the newspapers are not in favor of this. Senator C. Nelson indicated that the way this bill is written you don't even have to send a summary out anymore. Mr. Johnson indicated that was correct. Senator C. Nelson again inquired if the companies

Mr. Johnson indicated that since the companies publish this information they are aware of it's existence and would need to request a copy of it. Senators Krebsbach, Kilzer, Dever directed questions to Mr. Johnson and Leona Ziegler (Tape 1, Side A, meter #'s 16.9-22.0). There was nothing further at this time. Chairman Krebsbach closed the hearing on HB 1406. Senator Dever moved a Do Pass on HB 1406, seconded by Senator Wardner. Roll Call Vote indicated 6 Yeas, 0 Nays, 0 Absent or Not Voting. Senator Kilzer will carry the bill.
