Minutes: <u>Chair Kelsch</u> opened the hearing on HB1418 relating to student loan reductions; and to provide an appropriation.

Rep. Disrud, Dist. 21: testified in support of HB1418. This is an important concept. This is to encourage ND graduates to stay in ND. We have a concern over the teacher shortage in ND. We have too much outward migration. We in ND have an excellent work ethic and excellent education program. Why wouldn't other states come after our graduates. They are top notch. I hope this bill will help keep graduates here.

Rep. Herbel: (240) here to support HB1418. This bill will encourage young people to go into education and stay in the state. Once we can get people to start teaching in ND, they generally stay because they like the quality of life and the people. Once teachers leave, they tend not to come back. Other states are paying bonuses to attract our teachers, and some pay off some of their loans. This bill will help.

Max Laird, Pres. NDEA: (427) in support of bill. When surveying prospective teachers, the second most listed comment is they would like some form of student loan forgiveness. The first comment was good pay.

Rep. Hunskor: (679) Is there any thought that students who qualify for a loan and receive it, then get their degree, can then be expected to teach in ND?

<u>Max</u>: I don't believe that is specifically identified in this bill. That is one of the methods that has been discussed.

Rep. Nelson: (750) Have you ever done any studies as far as when a graduate goes into education and begins to teach, and how long they teach before they look for a career out side of education? Is there any documentation?

Max: Dean Harris of UND did a study for a few years concerning new teachers. This research confirmed the national research. If we are able to retain a teacher for five years in the profession, they will keep that as a career. One, two, and three years are the key years that determine if they stay in teaching. Years 4 and 5 are called the finishing years, where you refine your skills and techniques. They may move horizontally, but they will stay in education.

Rep. Nelson: (840) Is this important enough that maybe we should take this fund out of the teachers compensation package, if we can't find funding for this?

Max: I get asked that almost everyday. I believe there are other vehicles. We shouldn't be talking about that at this point.

Janet Welk, Education Standards and Practices Board: (970) here in support of HB1418. 1 get many calls each week from students in other states asking if ND has this type of opportunity. I have to tell them, no. We need this concept in place. Elementary education is the only area that

there is no shortage. We have a unique situation in ND. 50% of us will retire within 10 years.

We will need 4,000 new teachers in ND. We need to start recruiting and retain them in ND.

Rep. Mueller: (1145) Do you think we should have those specific areas of shortage in the bill?

Janet: Actually, the broader we leave it, may be best. But, if you think we need to specify, then do it.

Rep. Hunskor: Was there any distinction between resident and nonresident qualifying. We are giving nonresidence the same option?

<u>Janet</u>: What is the intent of the bill. Is it to keep ND teachers in ND, or to provide teachers from all over. You need to decide.

Bey Nielson, ND School Board Assoc.: (1335) in support of this bill. We, too, want to keep this concept alive. This is a good concept for recruiting. I read the bill that you must be and stay in a ND school to qualify for the annual loan forgiveness.

Rep. Hunskor: Don't you think that we need to address that teachers from other states need to remain, or what will make them not leave after they get the forgiveness?

Bey: We aren't paying upfront. They need to be employed in ND. Each year they are teaching they are forgiven \$2,000. If they are not teaching the next year, they will not get the loan reduction.

Richard Ott, ND Council of Education Leaders: in support of HB1418. This provides kind of a tool chest. This one also deals with retention, which is good. I would not be opposed to including that a person needs to stay in ND x number of years.

Chair Kelsch: Any more testimony for or against? Hearing none, we are closed.

2. Narrative: Identify the aspects of the measure which cause fiscal impact and include any comments relevant to your enalysis.

The proposed payment mechanism does not fit readily within the Bank's current student loan servicing operations because: 1) many of the borrowers eligible for these payments are not currently customers of the Bank; 2) Bank systems do not currently track some of the data elements necessary to support the requirement of the proposal; and, 3) existing Bank systems do not provide for generation of annual principal reductions.

The legislation contains an appropriation of \$2 million for the biennium. Are we to assume that this is \$1 million each year? Or, do we satisy all requests until the monies are exhausted, even if it means more money is available in one year than the other?

Note that as the language is presented, it would be possible for someone who is teaching only part-time to qualify for these benefits.

What happens if there is a temporary cessation of teaching due to medical reasons, military duty or a return to school for continuing education? Does the borrower loose his eligibility for these benefits? Or, should we allow for some sort of deferment similar to the Federal Family Education Loan Program (FFELP) offerings.

How are borrowers made aware of the program? Is the Bank expected to provide some sort of notice to anyone? We did not allow anything in our calculations for this.

What kind of notice of benefits do we need to provide to the borrower? We have assumed a simple letter.

Do we need to provide IRS 1099C reporting for cancellation of debt? We have assumed so.

Legislation on the federal level could compound the benefits available in certain instances. Should there be a limitation to prevent "double dipping"? Should the borrower be required to exhaust the available federal benefits before they are eligible for benefits under this program?
