

Minutes: <u>Chair Froseth</u> opened the hearing on HB1456 relating to the filing of campaign contributions and expenditure statements by political committees; and to provide a penalty.

<u>Rep. Joe Kroeber, Dist 48, Jamestown</u>: testified in support. (**SEE ATTACHED**) I also have amendments that I would like the committee to consider part of the bill. Cory Fong found a slight mistake that needed to be cleared up.

Rep. Ekstrom: (4499) Can we raise the limit a bit so that every time you pop over that \$1,000 limit, you don't have to rush and file.

Rep. Kroeber: PAC's have to report over \$200, so we are already raising this to \$1,000 in aggregate. This is not a 48 hour reporting period. Don't confuse the last bill with this. This is for final aggregate report.

Rep. N. Johnson: Is there a definition of what a political committee is? Is there a penalty?

Cory: There is a definition and the answer to the second question is an infraction.

Rep. Grosz: I have the code in front of me. It's defined as: Any committee, club, association, or other group of persons receiving contributions or makes expenditures for political purposes.

Cory Fong, Sec. State's Office: (4915) I'm here to answer any questions. I'm glad Rep.

Kroeber is including the amendments for line 20 and line 22. That is in line with the other reporting time lines. Candidates are not required to report, but generally everything goes through their committee. If a candidates decides I am not going to report anything as a candidate, they would be crucified. PAC's have to report any expenditures used for political purposes over \$200. Candidates and political parties don't have to report expenditures right now. This bill would be a significant change. There is a lot more reporting when you deal with expenditures. Sometimes you will be dealing with sensitive material. If you don't go over the \$1,000 threshold, you don't have to file.

<u>Vice-Chair Severson</u>: In section 2, lines 13 and 14, do you feel that is necessary?

Rep. Kroeber: In section 2, this is new ground that we are looking at. If this committee feels it needs changes, that is O.K. by me. Right now when we report, we have to list the name of the person that we got the money from and their address and their association (PAC's). The purpose of the expenditure might be self explanatory by who the check was written to.

Rep. Lonny Winrich, Dist. 18: here in support of HB1456. There a loopholes in law now we want to close.

Rep. Grosz: (6060) I have a small worry about this. Will there be enough FTE's at the Sec. of State's Office to do this. Also, are there enough FTE's at the Auditor's Offices?

Rep. Winrich: I can't speak for the Sec. State's Office. Current reports from political parties or candidates are not audited. (end side A, begin side B, Tape 1) I don't think we will have much increase in the number of reports.

<u>Vice-Chair Severson</u>: This doesn't cover federal candidates?

Rep. Winrich: I understand it doesn't. Federal law does.

Cory: To address Rep. Grosz question. I don't that our office will be impacted too much. We are looking at ways to use technology to make things easier and faster for reporters. We have rarely taken up an audit. We look at campaign contribution statements much closer now than in the past. We get clarification from candidates if we need to.

Rep. Herbel: Are we trying to fix something that is not a problem?

Cory: I think the bill's intent is to head off a problem. Our laws in ND are all based on disclosure and based on limitations. Some committees will have to start reporting with this bill.

Chair Froseth: (445) If a committee does not have to register with you, and they don't file, how do you know they exist?

Cory: That's a challenge. We will have to educate parties if this is passed.

<u>Vice-Chair Severson</u>: (499) What if there was a group called, HUNTERS FOR SEVERSON. Do they have to file as a political group?

Cory: If they were raising money for your election, yes they would. If they were HUNTERS FOR RESPONSIBLE GOVERNMENT who don't contribute funds for one candidate, no. If the local NRA would promote you, they would have to report under the conditions in this bill. The federal NRA promoting you are under the federal guidelines.

Rep. Delmore: Yes. But under the conditions described in here. They wouldn't have to automatically register, would they? If they fit the \$1,000 requirement, then you would have to be informed?

Cory: They are required to register with our office within receipt of any funds within five days.

Reporting would be prompted any time they get contributions over \$200 or expend expenditures over \$200 if they have gone over the \$1,000 limit. According to this bill, yes they would.

<u>Vice-Chair Severson</u>: Rep. Kroeber, is this modeled after other legislation?

Rep. Kroeber: No, it is not. It is legislation that has been in before and failed. This is addressing situations that actually occur in the state of ND. We do have political committees that are formed that do not report, because they are not required to report.

Rep. Disrud: (1009) Is not a candidate responsible for the committee that is representing them?

Rep. Kroeber: Not by statute. In reality, if they did not want to, they wouldn't have to.

Rep Ekstrom: I need clarification of the \$200 and the aggregate amount. A man will give me \$100. Then maybe the wife will give me \$100. Since this is two people, you don't have to report.

Rep. Kroeber: Yes, you can still get around it.

Rep. N.Johnson: Is this is passed, would this be the only section in law that requires a candidate, political party, or committee to itemize their expenditures?

Rep. Kroeber: PAC's are already doing this. To my knowledge, the state groups are not.

Chair Froseth: Is there any more testimony for or against? Hearing none, HB1456 is closed.

Side B, tape 1 (2250) Chair Froseth: We will hold this bill for amendments.

Minutes: Chairman Krebsbach opened the hearing on HB 1456 which relates to the filing of campaign contribution statements by political committees; and to provide a penalty.

Representative Joe Kroeber, District 48, introduced the bill to the committee. A copy of his written testimony is attached. Senator Kilzer inquired if political committee has a specific definition so that we can separate it from a political candidate. Representative Kroeber indicated he wasn't sure. He indicated that he would defer to Corey Fong. Senator Dever indicated he was a little confused too because his district party which serves as our political committee has to report this already. Representative Kroeber also deferred this question to Corey Fong. Representative Lonnie Winrich, district 18, cosponsor of the bill appeared before the committee. He indicated he wanted to appear before the committee and express his support for the bill. He believes it does close something of a loophole in our election reporting laws and although there isn't any great evidence of abuse of this loophole that exists he thinks it is something we should do. He simply wanted to appear before the committee and express his

support. Corey Fong, representing the Secretary of States Office appeared in a neutral position on HB 1456. He indicated what the sponsors of this bill are trying to get at and the secretary of state's office has had some concerns about the same problem. The difference between committee that forms for the purpose of corporate purposes or association purpose which are specifically required to form because they can't have their association or their corporation give directly to the candidate. Those are considered PACS and that is not what this is getting at. What this is getting at are committees that form that are not PACS, that just form to support a group of candidates. Or a candidate he thinks. A perfect example were the candidates for governor this last time around. They both had committees that formed. There was Heitkamp 2000 and Hoeven 2000. They are only required to report as candidates and they reported. The question is would they really have had to reported all those things because all the contributions came to those committees. There are a number of other committees that form out there for the purpose of supporting the candidacy of folks especially at the legislative level. I think what this is trying to get at is the requirement that they would have to report just like candidates do. With that he thinks this is the real purpose and the justification for this. He indicated he had some comments on the bill that may be potential problems that may need to be fixed in the current bill. First of all, one of the things that the house took out of the bill that he couldn't understand and he wasn't sure why they did it was the requirement that these particular committees would have to report the amount of each reportable contribution. Adding the requirement that the amount be reported would be very important. Chairman Krebsbach inquired what amount Mr. Fong was speaking of. Mr. Fong indicated what he means is that they have to report all contributors over \$200 but it doesn't say that they have to report the amount that they contributed. As he understands it it could be a list of names and dates of contributions. He thinks that would be very valuable if they

had to report the amount because that is also consistent with all of our other reporting requirements. With that the current bill does not require them to list the address of the contributor which is also very important. Then that indicates where the person is from if you have list of contributors and all you have is the name and the date. That's not very much information including the amount would be a lot more information that would be valuable and also where they are from because they need to separate whether these are out of state or in state supporters, east support or west support. That's very important so he thinks that could be added. That would make the bill much better. The other thing he questions is if you are going to make them report, these kinds of committees which I think there is some value in doing that, should they also not be required to register. Right now the only committees that are required to register. are committees like PACS for example or committees that form for large statewide candidates. But should they also not be required to register if they are supporting legislative candidates. Under 16-08,1-03,2 legislative candidates are not included in that. Chairman Krebsbach inquired if Mr. Fong intended to submit amendments to what he requests to the committee. Questions were offered by Senators C. Nelson and Kilzer (Tape 1, Side B, Meter #'s 54.4-End). Comments concerning possible amendments were made by Representatives Kroeber and Winrich who both indicated they would have no concerns with the amendments proposed by Mr. Fong. There was nothing further on HB 1456. Chairman Krebsbach closed the hearing HB 1456. Chairman Krebsbach brought amendments to the committee for their review. After discussing the amendments it was determined that the committee needed additional information before it would take any action on the bill. The committee adjourned for the day. On January 22, 2001, Chairman Krebsbach opened the discussion on HB 1456. Corey Fong, with the Secretary of States Office appeared before the committee to review the proposed amendments

with the committee. Senator C. Nelson indicated that she had a concern about legislative committees. She indicated her district 22 legislative committee and her Nelson legislative committee and if she had a friend's of Carolyn Nelson legislative committee would all have to pay \$5.00 to register. Corey Fong indicated her district party is not required to register. If you set up a friends of Carolyn Nelson yes they would if this were to pass. But, if we remove the overstrike and a committee organized in support of a legislative candidate, then she doesn't have to. Corey Fong indicated that was correct. Senator C. Nelson, so if the only two changes we made were on page one lines 10 and 12, we would get the name, address, and amount and she wouldn't have to pay the \$5.00 registration fee. Corey Fong indicated that was correct. You would still have to report and show all contributions over \$200.00, the name of the contributor. the date they gave it and the amount. You would have to show all that information but you wouldn't have to register your committee. She indicated her problem is IRS related. Any money coming directly to her becomes income to her not to her committee. She really has a problem with now having to register and pay money for doing something that she has been doing for sixteen years. Chairman Krebsbach so if we just didn't act on section two you would be okay. **Senator C. Nelson** indicated yes. The discussion ended at this time. Later in the afternoon Chairman Krebsbach reconvened the committee and discussion of HB 1456 continued. **Senator C. Nelson** once again reiterated her objection to section two of the amendments. She has no objection to the first set of amendments on line 10 and 12. She has a major objection to section two of those amendments. We never had to do this before and she objects that we would have to do it now. Senator C. Nelson moved to adopt the amendments on page 1, line 2, 10, and 12. Seconded by Senator T. Mathern. Roll Call Vote indicated 6 Yeas, 0 Nays, and 0 Absent or Not Voting. A motion for Do Pass as amended was made by Senator C. Nelson, seconded by

contributions and expenditures by political Committees. The Secretary
of State Office has helped me with a short amendment that would keep
the reporting dates the same as are now required. I request your
consideration of this amendment. The law now requires candidates to
register. The law also requires political committees to register.
However, only candidates have to report. This bill would fix this
oversight. A number of political committees do report. Example:
Hoeven for Governor and Heidi for Governor. However, at this time
there is no requirement to do so.

Section 1 #2 Require political committee's expending more than \$1000.00 in aggregate file a report detailing each expenditure over \$200. PAC's now must report amounts in excess of \$200.00. So this requirement(over \$1000) is much less than the PAC's requirement of amounts over \$200.00

Section 1 #3 Requires the political committee file a list of each contributor who contributed over \$200 in aggregate during the reporting period.

Section 1 #4 as amended matches the time line now required of candidates and PAC's.

Section 1 #5 Requires the same reporting system used by candidates and PAC's if the Political Committees did not receive contributions in excess of \$200 during the reporting period.
