Minutes: Chairman DeKrey opened the hearing on HB 1478. Relating to charging inmates for board and room at correctional facilities.

Rep D Monson: District 10, introduced the bill, relating to charging inmates for room and board at correctional facilities. The house bill that is before you, is a bill, that came out of a conference that I attended and talked to a State Senator of Iowa. This bill would only cover adults, convicted of a criminal offense. What we are purposing is that the correctional facility would be able to charge an inmate. All monies must be credited to the general fund of the governing body of correctional facility. I do have amendment, line 20 the last word shall should be may. He goes on to explain the bill. After the claim is approved by the court, the claim for the amount owed by the person has the effect of a judgment for the purposes of enforcement. However the judgment does not have priority over a claim for child support obligations owed by the inmate.

Rep Klemin: After the claim is approved by the court, this would be a new procedure, it would seem that the inmate has no opportunity to contest the claim.

Rep Monson: That is why we should have may instead of shall.

Ren Klemin: We do have some constitutional requirements that would have to be followed.

Rep Monson: You may be absolutely right and would want to correct that.

Rep Klemin: Another something that could be looked at and added to this about estates, maybe the procedure should be in this bill.

Rep Monson: I see no reason why it couldn't be, there is a provision already in place that allows where people are on work release, can be charged up to \$10.00 per day, there is no maximum or minimum in this bill. Iowa has a maximum of something like \$30.00 per day.

Rep Delmore: Are we setting up a two tier here, I don't see the state correctional facilities.

Rep Monson: This by definition is for correctional facilities and that does not include the state.

This was to address the smaller jails.

Rep Delmore: If we are setting the fee, are you looking at a sliding fee.

Rep Monson: The fee set would be the same. The fee would be set by the county and it would be reasonable. They should have limits for a guideline.

Rep Delmore: I see that you have child support taken out, might there be more to be taken out.

Rep Monson: The Legislative Council set this up in accordance with Iowa law. We have to be careful about what we put in there as other exemptions.

Rep Klemin: Any judgment that we have is subject to exemptions under state law. Lots of things would be exempt.

Rep Mahomey: The food was changed to \$15.00 or funds earned by the inmate while on work release. You might want to be careful what county you were picked up in, if you leave it up to the counties. Maybe we should set up a flat fee?

Rep Monson: I don't know how long it is on the books. I think that we should have some kind of maximum.

Rep Mahoney: I would like to know what lowa has done, are there variables.

Rep Monson: I am not sure, I think that it is variable and it was capped out at a certain level.

Chairman DeKrey: Are there any further questions, if not thank you for appearing. Anyone else wishing to testify.

Wade Williams: North Dakota Association of Counties. We have not had a lot of time to look at this bill. The counties are somewhat favorable to the bill, with a cap. The cost would vary for each county.

Rep Mahoney: The problem would not be with assessing the cost, but we could run into constitutional problems without a standard fee.

Wade Williams: Yes, that is correct.

<u>Chairman DeKrey</u>: Doesn't the bill say that you have to be convicted?

Rep Mahoney: I think that is the way the bill reads.

Rep Klemin: Some of these correctional facilities house inmates from other states, how is will that dollar amount set?

Wade Williams: I don't know. I can find out for you.

Rep Wrangham: Would this be an additional tax on the bad people. Will we see a reduction in funds needed to run the institutions.

Wade Williams: I don't know how many inmates this will effect, it will make some difference but to what degree, it is hard to say

# **Testimony on HB 1478 Senate Judiciary Committee**

Rep. David Monson March 14, 2001

Chairman Traynor and members of the Senate Judiciary Committee. I am unable to be at the hearing on HB 1478 today. I will submit this written testimony today, and I will be glad to meet with you or any of your committee members at your convenience at a later time to answer any questions you may have. I am sorry for any inconvenience that my absence may cause. I will be back on Thursday, Mar. 15.

This bill is modelled after legislation from Iowa. It is designed to help counties and cities and other non-state correctional facilities collect some of the costs associated with housing their inmates who are 18 years of age or older. In many cases these inmates do not have a great deal of money and there is no use even trying to get any costs out of them. However, in some cases the inmates have the means to pay their room and board, especially in the case of drug dealers or white collar crime. This bill would allow the administrators of these smaller facilities to file a room and board reimbursement claim with the district court. The maximum amount of \$20 per day was amended into this bill by the House Judiciary Committee since there were no limits in the original bill. My own feeling is that this is a little low, but I trust that your committee will discuss this and do what is proper and reasonable. I believe that these facilities can now collect \$15 per day in some instances, but this would expand that authority and increase the amount a little bit. My contact in Iowa says that this similar legislation has made a big positive difference to the county budgets in Iowa.

Subsection 2 indicates that the court may approve this claim along with any filing fees. However, the judgment does not take priority over a claim for child support obligations owed by the inmate.

The proceeds of this fee are to be used as specified in subsections 3 and 4 which are basically to improve the facility itself or for hiring enforcement personnel.

I would hope that you would give this bill your positive consideration. I have no problem if you would choose to make some minor amendments as you see fit, also. Thank you for your time.
