Minutes: Chairman DeKrey opened the hearing on HCR 3017. A concurrent resolution directing the Legislative Council to study the method of providing legal representation for indigent criminal defendants and the feasibility and desirability of establishing a public defender system. Judge Newmann: Judge of the North Dakota Supreme Court introduced the bill. It has been more than 25 years since we have looked at this. We should have a study as this question is being addressed by study in very state. It would be a question of money and how to spend it. Chairman DeKrey: We have seen this in one bill form and one resolution, could these all be done at once.

<u>Judge Newmann</u>: I would like it to be done this way as a bill and as a resolution, because it could be lost in the shuffle, this needs some attention paid to it now.

Chairman DeKrey: Is this more than a money problem?

<u>Judge Newmann</u>: I think it is, it is an ethical problem, judges are now deciding how the money is to be spent.

Rep Mahoney: There is a lot of material and a lot to study.

<u>Judge Newmann</u>: Right now there is a group called the Stenjhem that tells us a lot of the information that we are using.

Rep Mahoney: Has it all been compiled yet?

Judge Newmann: I don't know.

Rep Mahoney: You are saying that this would be better as an independent study.

Judge Newmann: An independent study, preferably.

<u>Chairman DeKrey</u>: Is it pro bono work or what the legislature appropriates?

Judge Newmann: The legislature gives more than a little, currently it is 3.8 million.

<u>Vice Chr Kretschmar</u>: Currently the appeals are they based on the fact that the attorneys are not to smart?

<u>Judge Newmann</u>; I don't recall any cases, but that doesn't mean that the attorneys are doing the best job. Quality of representation is always a concern.

Rep Klemin: Right now do we have contracts with more then one company.

<u>Judge Newmann</u>: If we use nothing but public defenders right now, we would have to hire more people.

<u>Vice Chr Kretschmar</u>: In the statue, is there a provision, if time goes on, must the defendant pay back the state, if they acquire property.

Judge Newmann: Yes, we have records of this, but not enough money has come back in to cover the cost.

<u>Chairman DeKrey</u>: If there are not further questions, thank you for appearing. Is there anyone else wishing to appear in support? In opposition, if not we will close the hearing on HCR 3017.
