Chairman Rennerfeldt: I will open the hearing on HCR 3021.

Rep. Jim Kasper - District 46: HCR 3021 again talks about Garrison Diversion and Lake Sakakawea and the water that we have stored behind the dam, it talks more about the use of the water for projects around our state. Again one of the promises that our Federal government made the state of ND is that you would have the use of this water supply all over the state. Here again it is fifty years later and so much of those water use projects are just setting there in debate after debate and excuse after excuse from the Federal Government. What this resolution is going to do is to urge the Federal government to allow us as a state and to change their water policy from the

Corps of Engineers so that we can develop those lake water supply sources around our state.

There has been some uses you know, from the SE and the SW pipelines, but one of the big areas of my concern representing the eastern part of our state and the Fargo area, is lack of a stable water supply up and down the Red River Valley. Most of the water that is used for Fargo and Grand Forks comes from wells or the Red River itself. That river is not a real stable source of water. By allowing pipelines to be completed and water to be piped to the eastern part of the state and all the communities all the way. We can begin to assure that water we need for economic development, for plants and manufacturing units that need stable water along the years. There is an amendment recommend on page 2 by Mike Dwyer so I won't discuss that at this time.

Chairman Rennerfeldt: Does the committee have any questions? Anyone else care to speak in favor of HCR 3021?

Tom Disselhorst - Attorney with the Three Affiliated Tribes: (See written testimony).

<u>Chairman Rennerfeldt:</u> Are there any questions of the committee? Anyone else care to speak in favor of this resolution?

Dave Koland - Ex. Dir. Of ND Rural Water Systems Association: We certainly support this resolution and the amendments to be offered. The funding that will come from the federal government will provide additional funding for SW Pipeline, NAWS Project, Water to Eastern North Dakota and Tribal water systems have all become much more urgent. The arsenic rule recently handed down that the Federal government expects the states to comply with in the next five years will be addressed by the NAWS project. The communities in that area's only probable solution to solving this is water from the NAWS project. So we certainly support this resolution and the hasty return of the money due ND.

Mike Dwyer - ND Water Users Association: We strongly support his resolution. The DWRA has been the focus of our efforts for the last several years. We are so pleased it has been approved by Congress. As I mentioned to the committee we have made progress on the SW Pipeline and NAWS and the Eastern Dakota Water supply and the Indian MR&I is something we are pleased that will addressed. I apologize for not having the proposed amendments in writing, we support the resolution. I talked to Rep. Kasper and I think it would be better if we stated under the whereas, under the Dakota Water Resource Act, the state will be required to provide cost share repayment and operation and maintenance and not mention the amounts. What happens is the representatives say the state is going to put that money in so maybe we will back off a bit. I think it would be better if we struck out all the references to the dollars and just said the state would be required to provide cost share repayment and operation and maintenance. I can certainly provide that in writing to you and Rep. Kasper is supportive of those proposed changes. I will have those to you this afternoon.

Chairman Rennerfeldt: Any questions from the committee?

Dale Frink - Interim State Engineer for the State Water Commission: I certainly support his resolution. DWRA is certainly something we regard as landmark federal legislation for our district. It took an incredible amount of time and it's unbelievable the amount of people involved in this. I think is a very good resolution and we certainly support it.

Rep. Galvin: Is it too late to further amend? On line 20, page 2, I would like to strike out Legislative Assembly expresses appreciation for the Dakota Water Resources Act.

Rep. DeKrey: I don't understand why we are thanking them for doing their job 50 years late. (more discussion).

Rep. Porter: I second that. (more discussion).

Rep. Winrich: Could we have a reading of what this says?

(more discussion)

Chairman Rennerfeldt: First we have to deal with the amendments handed out earlier. All in favor signify by saying Aye, opposed? Amendment carries. Okay, now we have a motion to further amend by Rep. Galvin and a second by Rep. Porter. Now we can discuss it.

<u>Vice Chair Nelson:</u> I am simply going to say this, my mother taught me to be polite even when things didn't happen at the proper time. I am going to resist these amendments.

Rep. Winrich: Again, I would ask for a clear reading of what this amendment does? I am not sure I understand what the wording is going to be.

Chairman Rennerfeldt: Rep. Galvin. would you read what you mean?

Rep. Galvin: On page two it would eliminate the wording on line 20, "assembly expresses appreciation for the Dakota Water Resources Act. It would read "the 57th Legislative Assembly urges the Congress of the United States to fund their federal share of water projects in that act." On page 1, line 1 you would take out "expresses appreciation" and you would put "asking" in there. So it would read, HCR asking for the passage of the Dakota Water Resources Act? (more discussion on wording)

Rep. Winrich: I agree with Rep. Nelson thoughts and I am going to vote against this amendment. In the event it does pass, in both places where the change occurs, the phrase "that act" should be replaced by Dakota Water Resources Act. Otherwise there is no antecedent for the phrase "that act".

Rep. Solberg: I do agree with Rep. Nelson, I don't think this is necessary and I am going to vote against it. It doesn't hurt to say thanks.

Rep. DeKrey: I am going to support this, I don't feel like groveling in front of Congress for something they got to 50 years late.

Rep. Galvin: I would agree with Rep. Winrich on the Dakota Water Resources Act being in there.

Rep. Porter: As the second I would agree to changing the end of line two, it says "in the Dakota Water Resources Act." And at the end of line 22, it also states that. So from an English standpoint it flows.

<u>Chairman Rennerfeldt</u>: Okay, does everyone understand what the further amendment is? Call the roll. Yes, 6 No. 9. The further amendment fails.

Vice Chair Nelson: I move a Do Pass as amended.

Rep. Keiser: I second.

Mr. Chaiman, members of the Committee. On behalf of the Mandan, Hidatsa and Arikara Nation (the Three Affiliated Tribes of the Fort Berthold Reservation), I rise in support of HCR 3021, which seeks full funding for the Dakota Water Resources Act. We want to thank the House of Representatives for accepting our friendly amendments to this bill and ensuring that our needs for funding under the Dakota Water Resources Act are mentioned as Well.

As did many other North Dakota citizens, the North Dakota Tribal Nations worked hard for the passage of the Dakota Water Resources Act. Approximately one-third of the total funding authorized in the Act is for Municipal, Rural and Industrial water projects on the reservations in North Dakota, projects that in the case of the Standing Rock Sioux Tribe and the Three Affiliated Tribes were needed 50 years ago when the dams were first constructed. The Tribes eligible for funds include all four Tribes in North Dakota, and the names of the Turtle Mountain Band of Chippewa and Spirit Lake Tribes should be added to the list of Tribes to receive a copy of this Resolution.

Those of you in the room who were at any of the hearings on the Act know that we were at almost all of the hearings to offer support for the rural water needs of our Reservation, where more than 300 families still have to truck in potable water. Our needs for complete funding for our Municipal, Rural and Industrial water for us is paramount, as we have waited, as has the rest of the state, more than 50 years for the completion of the water projects promised us to replace our easy access to good water before the dam was constructed.

We also want to note that we are ready, willing and able to work with all of the legislative leaders, and our Covernor to seek full funding for the Dakota Water Resources Act. We believe we have a lot to offer as we seek full funding for the Act; we invite your assistance and offer ours to this effort.

Therefore, Mr. Chairman, members of the Committee, I urge you to give a DO PASS recommendation to HCR 3021, as amended, seeking full familing for the Dukota Water Resources Act. Let us work together to achieve our common goals. Thank you.
