This is only one reason to look at the NAFTA agreement. Minutes: Chairman Krebsbach opened the hearing on HCR 3027 which is a resolution urging Congress to correct the inequities of international trade policy. Appearing before the committee to introduce the bill was Representative Arlo Schmidt, district 12. He indicated this was a resolution which came out of seeing the inequities of the NAFTA agreement in his area of the state. He reviewed the basics of the resolution with the committee. He then related a story to the committee relative to a situation with lavatory equipment which is no longer available to citizens of the United States unless they purchase the product in Canada and then bring it back to the United States for installation. A copy relative to this story is attached. Senator T. Mathern noted that he believed that the stool issue is more of a federal government EPA issue than it is a World Trade Agreement or a GATT issue. He wondered if that is your intent here really, it seems like it really had nothing to do with that. The EPA if they changed their rules you could buy the product you are looking for here. Whether or not GATT changed or NAFTA changed, he wonders what that would have to do with the availability of plumbing fixtures such as toilets.

Representative Schmidt indicated he checked into this along with the plumbers and that was an agreement that included EPA, NAFTA, and GATT. It's been quite a while since they signed this but a lot of the inequities are coming more and more to light. If you go back to your town you will find out. He found out just how many people are disgusted with this. Chairman **Krebshach** indicated that she couldn't agree more. Instead of conserving you end up flushing two or three times. She thinks that the law that the 1.6 standard came in under was the energy policy conservancy act. The North American Free Trade Agreement allows you to go to Canada where they don't enact that to bring back your 3.5 standard. Representative Schmidt indicated she was right. Senator Dever indicated that in his recollection when these agreement were negotiated Senator Dorgan opposed them and Senator Conrad supported them. He didn't recall how Congressman Pomeroy stood on them. Carol Two Eagels appeared before the committee as a private citizen. She indicates she supports this resolution. There were no questions from the committee. The hearing on HCR 3027 was closed by Chairman Krebsbach. A Do Pass motion was made by Senator C. Nelson, seconded by Senator Wardner, Roll Call Vote indicated 6 Yeas, 0 Nays, 0 Absent or Not Voting. The resolution was placed on the Consent Calendar. Senator Dever will carry the bill.
