Minutes: Chairman DeKrey called the committee to order on HCR 3051.

Rep Klemin: We were discussing HCR 3008, which provided for a constitutional right for an individual privacy, there were a lot of questions and concerns. People said that this was an issue that should be studied before any action was taken. What HCR 3051 does is to call for a Legislative council study of the issue, relating to individual privacy. If selected would mesh with the SCR. In the February issue of Newsweek, I was reading about Spyware, and the NECl Quick Click. Click on any word and it gives you information about that word. He then reads the paragraph out of Newsweek of February 19th. Talking about the computer revolution, "While there is a revolution going on, but it is happening outside our computers. As information gets stuff from them and gets transmitted to commercial concerns, its a silent revolution. While engaging in Internet activity, most uses are not aware that they are beaming out stuff they would prefer to leave on their desk tops. There is a word for programs that quietly transmits those nuggets. Spyware. It is fair to say that it applies to anything that is under our personal radar that

sends out personal information about us or our habits. One case in point is Quick Click. Though it does perform a neat function, creating sometimes useful links for words that are not already hooked to related web sites, it works is problematic........All users are given a unique identifying number, that is transmitted..... So that when you use Quick Click, information about you is given back." This is the kind of thing that concerns me. I know that the concern is more than in North Dakota but nationally. If this is selected may or may not come up with some sort of constitutional amendment. I would request a DO PASS on this resolution.

Rep Eckre: Isn't the Attorney General going to do a study on privacy.

Rep Klemin: The Attorney General can go his own thing, but what has happened is at his request Senate Bill was introduced. That is limited to financial privacy.

Rep Eckre: How would this study address the issue for North Dakota and then nationally. What can we do by ourselves.

Rep Klemin: It goes back to what is stated on the dollar. "Out of many one". North Dakota can't effect anything national, but if all the states work on it, some positive impact can result.

Chairman DeKrey: Are there any further questions, if not thank you for appearing. If there is not one else to testify on HCR 3051, we will close the hearing on HCR 3051. What are the wishes of the committee.

- 1 A concurrent resolution to create and enact a new section to article I of the Constitution of
- 2 North Dakota, relating to the right of privacy.

3 STATEMENT OF INTENT

- 4 This amendment would provide that the right of individual privacy is essential and may not be
- 5 infringed without the showing of a compelling state interest. The amendment also would
- 6 provide that the right of privacy would not prohibit or invalidate statutory provisions restricting or
- 7 regulating abortion and assisted suicide.
 - BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF NORTH DAKOTA, THE

9 SENATE CONCURRING THEREIN:

- That the following proposed new section to article I of the Constitution of North Dakota
- 11 is agreed to and must be submitted to the qualified electors of North Dakota at the primary
- 12 election to be held in 2002, in accordance with section 16 of article IV of the Constitution of
- 13 North Dakota.

- SECTION 1. A new section to article 1 of the Constitution of North Dakota is created
- 15 and enacted as follows:
- The right of individual privacy is essential to the well-being of a free society and may not
- 17 be infringed without the showing of a compelling state interest. This section may not be
- 18 construed to invalidate any legislation regulating or restricting abortion or assisted suicide.
