Minutes: CHAIRMAN FREBORG called the committee to order. Roll Call was taken with 6 members present. (SENATOR WANZEK was absent but came later). Students from Newburg were in attendance which is in Senator O'Connell's District.

CHARIMAN FREBORG called the hearing on HCR 3061 which directs the Legislative Council to study the delivery of education at the elementary, secondary, and post secondary levels during the ensuing five, ten, and twenty years, and focus specifically on demographic trends as they affect the nature and scope of the services to be delivered, as well as the role of elementary, secondary, and post secondary education in work force training and economic development initiatives in the state.

### Testimony in support of HCR 3061:

REPRESENTATIVE MERLE BOUCHER, District 9, testified in support of the resolution. (see attached) He stated this is a package of five resolutions to study the infrastructure of the state of ND regarding education. The questions of where do we think ND is going, where do we think

ND should be in the future re: education, what should education look like in 20 years, and how are we going to deliver it.

BEV ARNOLD TANGESDAHL, ND Assn. For the Education of Young Children, spoke in support of the resolution. She represents those who work with children birth to eight years old: childcare, Headstart, the law schools at the Universities, and the Air Force Base Child Development Centers. She feels early childhood education should be included in any plan put forth. ECDF fund is bringing \$4.2 million more than anticipated to the state. She would like to be more cooperative with other layers of education. They would rather have educated people teaching and training young children. Would like to eliminate duplication of services.

Hearing no further testimony on HCR 3061 the hearing was closed.

Tape 1, Side B, 5.0 - 23.0

CHAIRMAN FREBORG presented an amendment (13071.0101) and explained them. The amendment removed higher education from the resolution. He feels school to work, work study, work force development etc. are better served in a bill dealing with economic development or commerce. Therefore the amendment. This would cover the areas most needing study. There is a concern that administrators should be included in this. SENATOR COOK has a concern of administrators not having a vision for the future and therefore their inclusion. He also has a concern with the role of the state versus the role of the local districts. He feels maybe another "therefore" in the resolution to study the role of state and the role of local decision making in reorganization. SENATOR KELSH feels economic development efforts in conjunction with the needs of primary, secondary, and post secondary education should be studied, at least primary and secondary education, and should be left in the resolution. SENATOR FREBORG asked if we were going to keep the line "and focus specifically on demographic trends as they affect the

nature and scope of the services to be delivered". That line has been in a resolution during each of the last few sessions. Are we going to do it again? We could just as well copy the resolution from three sessions ago and introduce it. SENATOR KELSH again reiterated his feelings that the demographics of this state can be changed with economic development. SENATOR FREBORG again stated what the amendment does. SENATOR COOK feels the issue of economic development in the state should be studied but probably not by the education committee. SENATOR WANZEK sees this amendment as more focused to concerns and problems facing education.

SENATOR COOK moved to adopt the amendment. Seconded by SENATOR WANZEK Roll Call Vote: 7 YES, 0 NO. 0 Absent. Amendment adopted.

SENATOR COOK presented an amendment which hoghouses the current amended bill (13071.0102). He explained the intent is to get progressive discussion on future education. He feels there needs to be a clear discussion on what is local control and what is state control. He feels there seems to be a lot of confusion in this area. SENATOR KELSH said that sometimes more talking about local and state control seems to cause more confusion. SENATOR COOK stated it is not the intent to usurp any state control over local control. He would like to see accountability on all side. SENATOR CHRISTENSON stated local control needs to be defined. SENATOR COOK moved the amendment (13071.0102). Seconded by SENATOR CHRISTENSON. SENATOR COOK stated we need to have a vision of future education, how it will look then, and then it would be easier to move forward with policy changes, etc.
