The estimated increased amount is based upon averaging the fees paid within each speeding group, multiplied by total number of convictions for each speeding category. From January 1, 1999, through December 31, 2000, a total of \$1,431,851 was collected. An estimated \$2,553,819 will be collected during 2001-2003, based on the same number of convictions for speeding issued in speed zones greater than 70 mph. Based on this, we estimate an additional \$1,121,968 would be generated by this bill as amended.

If the current amendment is passed, we are estimating additional revenue of \$33,500 per biennium, based on an average of speeding citations issued between January 1999 through December 2000. This total estimate represents both state and city revenue as there is no way of differentiating between speeding citations previously issued by either city or state.

Minutes: Rep. Weisz - Chairman opened the hearing on SB 2088; A BILL for an Act to create and enact two new subsections to section 39-06.1-06 of the North Dakota Century Code, relating to fees for traffic offenses; to amend and reenact sections 39-06.1-05, 39-06.1-07, 39-06.1-09, and 30-06.1-10, subdivision g of subsection 2 of section 39-07-09, and subsections 1 and 2 of section 39-21-46 of the North Dakota Century Code, relating to traffic offenses; and to provide penalties.

Doyle Schulz: I am Director of Motor Carrier Operations for the North Dakota Highway Patrol.

I have a copy of my prepared remarks for each of you. A copy is attached. It explains the various sections of this bitl. It is meant to decriminalize the Federal Motor Carrier Safety Regulations and Federal Hazardous Material Regulations.

Marv Skaar: I am the President of E W Wylie out of Fargo, ND. Also I am President of the North Dakota Motor Carriers Association. I am testifying for this bill primarily because of what it costs when our guys get stopped. Our guys have critical loads - - if we don't have law like this

we have to round up money -- we have round up money -- take time and talent and delay the loads to pay a fine that will simply be paid if the guy signs it and sends it in. We use -- a T check to get emergency funds to our people -- in these small towns that is not easily done -- small town courthouses -- they don't even know what a T - check is - - which is kind of like a guaranteed check -- but no everybody is familiar with them -- so a lot of time and money is spent in these situations. There are other states who are just like we are -- we had a guy in Chicago that had a 15 minute log violation and they didn't have a law like this either -- it was on Memorial Day weekend -- they put him the Cook County jail on Friday and he didn't get out until Monday for a 15 minute log violation -- the other part of this that he testified on that makes sense -- is when he signs the ticket and a guy doesn't pay they go right to the State that issued his drivers license and suspends his license --it is a very effective method of finding and getting the person who doesn't pay. As soon as he goes across the scales he gets a DOT check or whatever it is -- they check his drivers license -- if he isn't licensed the truck is stopped right there. Under the current system if there is warrant the guy gets a ??? warning and if he is from Alabama he is gone and will never be back here. I think it is more fair to our system and it is more fair to the trucking companies and it is more fair to the driver who is dealing with something he doesn't understand. Here the company just pays the bill and makes sure it is taken care of -- a lot simpler than tracking down money at 2 o'clock in the morning or 7 o'clock in the morning and paying the fine. I am in support of this bill.

Minutes: Rep. Weisz - Chairman opened the discussion for action on SB 2088.

Following discussion that several years ago North Dakota did not ask for the exemptions from the federal requirements for agricultural vehicle drivers from the Medical card requirement when they drive ag vehicles of 26,000 pounds or greater whether or not you need a CDL license. The committee discussed an amendment for this purpose. This was prompted as the highway patrol has recently been stopping vehicles and enforcing the Medical card requirement. It is acknowledged there is a possibility that if the amendment is passed that the Feds will pull out \$500,000 of funds from the highway patrol funds.

Rep. Jensen: (2537) I move approval of the amendment. Rep. Mahoney: I second the motion.

Motion carried on a voice vote with 11 yeas 3 nays.

Rep. Weisz - Chairman presented for the committees consideration a series of amendments which essentially were the same provisions for increasing the fines for traffic violations but none of the speed limit increases. Most of these provisions except the speed failed in HB 1443. This was deemed not to bring 1443 back but only to get fines increased for violations. Discussion emphasized that this part of the proposed amendments to SB 2088 were to not be "pushed" to the limit detriment of the original Highway Patrol bill SB 2088 on the floor.

Rep. Jensen 1 move approval of these amendments. Rep. Mahoney: I second. On a voice vote The motion carried 13 yeas 1 mays.

Rep. Hawken: (5503) I move a "Do Pass as Amended" for SB 2088.

Rep. Jensen: I second the motion.

The highway patrol shall issue a seasonal permit for the commercial movement of vehicles exempted by this subsection. The seasonal permit issued under this subsection or under subdivision d of subsection 1 of section 39-12-04 entitles an individual with the permit to operate a vehicle as allowed by either of these provisions. A seasonal permit issued under this subsection is subject to the requirements of subdivision d of subsection 1 of section 39-12-04; except a vehicle exempted by this subsection which is an implement of husbandry is not required to have proof of financial responsibility and does not have to be operated by a commercial entity."

Good morning, Mr. Chairman and members of the Senate Transportation Committee.

The purpose of Senate Bill 2088 is to decriminalize the Federal Motor Carrier Safety Regulations and the Federal Hazardous Material Regulations which were adopted October 1, 1983. It also would clarify the difference between a modified and an unsafe vehicle.

Effective October 1, 1983, the North Dakota Highway Patrol, under general authority of section 28-32-02 of the North Dakota Century Code, adopted certain parts of the Federal Motor Carrier Safety Regulations. These regulations were adopted by reference rather than duplicating the federal regulations to ensure that any time there was a change on the federal level our rules would be current. The regulations were adopted through the administrative rule process and are part of the North Dakota Administrative Code, Article 38-03 (Hazardous Materials) and Article 38-04 (Motor Carrier Safety Regulations).

In 1987, section 39-21-46 of the North Dakota Century Code was amended to give the Highway Patrol the authority to adopt the necessary rules concerning the safe operation of motor vehicles and when and how motor carrier audits or inspections will be conducted. Section 39-21-44 directs the superintendent of the Highway Patrol to adopt rules for the safe transportation of hazardous materials; in both sections, it requires these rules shall duplicate or be consistent with current regulations of the United States Department of Transportation.

The placement of the authority to adopt these rules in NDCC 39-21-44 and 39-21-46 was determined to be an infraction if violated and this has caused many problems for enforcement, adjudication in the courts, disposition of drivers license, correct evaluations of motor carrier profiles, and the motor carrier industry in general.

Currently if these regulations are violated, the trooper must require the driver to post a bond prior to being released. This means transport to the nearest court or jail, or if the judge approves, release on a promise to appear. This action may delay the driver for hours. If the driver fails to appear in court, the case cannot be adjudicated and a warrant for his arrest is issued. Without a conviction, the drivers license division cannot take any action and neither the driver's record nor his carrier's profile will indicate a violation. We believe this process is unnecessary to achieve the goals of reducing commercial motor vehicle crashes and may actually hinder our efforts.

If this bill is enacted, it would allow the trooper to issue a traffic citation and the driver to mail in his bond; it would not require an appearance in court. If the driver failed to either post the bond or appear in court, it would be entered as a conviction and sent to the drivers license division. Based on the driver's license compact, his state of license would suspend his driving privileges until such time as he posts the bond or appears. This bill will also set a uniform fee schedule for violations, which has been difficult to institute.

In summary, this bill does three things:

- First, decriminalizes Hazardous Material Regulations. This is done in sections 1, 2, and 6. It removes it from the list of criminal violations, lists fees for violations, and assesses two points for violations.
- Second, decriminalizes Federal Motor Carrier Safety Regulations. This is done in sections 3, 4, 5, 6, and 9. It lists fees for violations, allows separate notification form, lists FMCSRs as non-moving violations, assesses no points for violation, and identifies FMCSRs as non-criminal and indicates where the fees for violation are found.
- Third, clarifies the difference between a modified and unsafe vehicle. This is done in sections 5, 6, 7, and 8. It removes unsafe vehicle as a moving violation, keeps the same points for unsafe vehicle, adds unsafe vehicle to the list of offenses under which a person halted may not be entitled to release upon promise to appear, and separates 39-21-46 subsection 1 into subdivision 1.a. modified vehicle, non-criminal and 1.b. unsafe vehicle, infraction.

This bill has the approval of the council of presiding judges, the state's attorneys association, and the North Dakota Motor Carriers Association.
