Mr. Chairman, Members of the Committee:

My name is Julie Leer and I am General Counsel for North Dakota Workers

Compensation. I am here today to testify in support of 2001 Senate Bill No. 2134 to remove the expiration date from the Guardian Scholarship Program. The Workers

Compensation Board of Directors unanimously supports this bill.

In 1997, the Legislative Assembly established a scholarship fund for the surviving spouses and dependent children of workers who die as a result of work-related injuries or accidents. In 1999, the Legislative Assembly increased the amount of the annual scholarship award from \$1,500 to \$3,000 per recipient.

- ❖ For the 1997-1998 school year, 23 scholarships were awarded totaling \$34,500.
- ❖ For the 1998-1999 school year, 30 scholarships were awarded totaling \$45,000.
- ❖ For the 1999-2000 school year, 36 scholarships were awarded totaling \$108,000.
- ❖ For the 2000-2001 school year, 40 scholarships have been awarded totaling \$120,000.

As you can see, the program has been quite successful and continues to grow. North Dakota Workers Compensation would like to continue this program and for that reason requests your favorable consideration of Senate Bill No. 2134. If there are any questions, I'll attempt to answer them at this time. Thank you.
