Minutes: Chairman Krebsbach opened the hearing on SB 2158 which relates to interest earned from the sale of Veteran's Cemetery License Plates. Appearing before the committee to introduce the bill was primary sponsor Senator Tim Flakoll, District 44, Fargo. The clerk presented the narrative on the Fiscal Note to the committee. Senator Flakoll presented copies of his written testimony to the committee. A copy is attached. There were no questions from the committee. Also appearing before the committee was Brigadier General Michael J. Haugen, Adjutant General of the North Dakota National Guard who offered testimony in support of SB 2158. A copy of his written testimony is attached. Senator Dever indicated that he was curious if he was talking about the plates which have the different service branches on them? The Adjutant General indicated that was the correct plates. Chairman Krebsbach indicated she wondered when that program was instituted? The Adjutant General indicated the program was implemented in 1998. Keith Bjurke, private citizen and former Adjutant General of the North Dakota National Guard also appeared in support of SB 2158. The bill is a streamlining effort.

We aren't talking about a great deal of money however, it is money that does go directly into the maintenance account of the office of the Adjutant General and that gives us the opportunity to pay those salaries and operating expenses without raiding the principle of any funds. It doesn't totally eliminate the need at this point but there are other bills that are coming before this body that will. The cemetery has been in existence for almost a decade. It is a place to behold.

Chairman Krebsbach asked Mr. Bjurke to relate to the committee a story had told her about what an impression the cemetery had made on a visitor who came to North Dakota to see it. He related the story. Bob Hanson of the North Dakota Veteran's Coordinating Council appeared before the committee. He indicated this bill is merely a continuation of what was started in 1997 and his organization supports it. He recommended a Do Pass from the committee. There was nothing further to come before the committee. The hearing on SB 2158 was closed at this time.

A motion for a Do Pass was made by Senator Dever, seconded by Senator Kilzer. Roll Call Vote indicated 6 Yeas, 0 Nays, 0 Absent and Not Voting. Chairman Krebsbach will carry the bill.

Additional revenues are needed to support the special funds appropriated in the executive budget for existing 3 FTE and temporaries at the Veterans Cemetery. Revenues, appropriations and expenditures are all included in our budget to support these salaries, therefore we show no fiscal effect. This bill allows us to identify a source of those special funds, interest earnings from the Veterans Cemetery Trust Fund. Revenue comes to the Veterans Cemetery Trust Fund. Revenue comes to the Projected revenue from interest on the Veterans Cemetery Trust Fund accumulated through the 01-03 Biennium is approximately \$8,000.00. Projected interest that will be earned for the 03-05 Biennium is approximately \$6,000.00. Moneys from this fund have never been appropriated since the principal is still relatively small, approximately \$28,000.

Additional revenues are needed for special funds appropriated in the executive budget to support 3 FTE and temporaries at the Veterans Cemetery. The projected revenue from interest on the Veterans Cemetery Trust Fund accumulated through the 01-03 Biennium is approximately \$8,000.00. Projected interest that will be earned for the 03-05 Biennium is approximately \$6,000.00.

This revenue was included in the executive budget to fund the Veterans Cemetery salaries as special funds but the specific sources of that revenue had not yet been determined. This revenue comes from interest earned from the Veterans Cemetery Trust fund.

Expenditures are for salaries for the Veterans Cemetery. This revenue has no effect on expenditures since the expenditures are for existing FTE and temporary salaries.

TOPIC: Veteran's Cemetery

Testimony by: Senator Tim Flakoll, District 44 of Fargo

Madam Chairman and members of the Government and Veterans' Affairs Committee. For the record I am Senator Tim Flakoll, District 44 of Fargo.

The issue that we are dealing with in SB 2158 is the interest earned from the North Dakota Veterans' Cemetery Trust Fund. Currently the fund generates interest from:

- 1) revenue from special Veterans' Cemetery license plates
- 2) donations
- 3) accrued interest from the fund that is placed back in the fund

The ND State Investment Board manages the fund. Historical investigation indicates that the fund originally required legislative approval so that the fund and its interest could be monitored and that the interest could be used to help the fund reach its minimum long-term investment value of \$50,000. Under the law, the Adjutant General can request the interest from the account to fund the salaries and maintenance of the Veterans' Cemetery.


SB 2158 does not change the required use of the fund, which is for salaries and maintenance of the cemetery. It simply streamlines the process.

It should be noted that on lines 16-18 of the first page of the bill that "the department must still report to the legislative assembly on the funds collected under this section during each legislative session." This will insure that the legislature can continue to monitor the funds growth and usage.

I know there will be testimony from the North Dakota National Guard on this Bill, but I will be happy to stand for any questions.

Madam Chairman, Members of the Committee, good morning.

This Bill gives the Adjutant General the authority to receive, on behalf of the Veterans' Cemetery, the interest in the Veterans' Cemetery Trust Fund, without first obtaining legislative approval.

Under our current law, the Adjutant General must come before the legislative body and request the transfer of these funds. We would like to simplify the process by making these funds readily available upon request by our agency.

It should be noted that there are safeguards in the law that prevent the indiscriminate spending of the interest in this fund. If this Bill is enacted into law, the fact remains that these funds can only be spent on salaries and maintenance at the Veterans' Cemetery. This restriction effectively controls this money, without the additional requirement that the Adjutant General receive authority from this body to obtain these funds.


