Don Flynn - Vice Chair SW Water Authority: I am in favor of this bill. (See written testimony).

Chairman Rennerfeldt: Any questions of the committee? Anyone else to testify in favor of this

bill?

Chip Unruh: I am one of the 27 SW Water Authority board of directors. When we first got started we needed 27 members, however we don't need that many anymore. We can reach our goals with a smaller board and I ask that you do pass this bill.

James Lennington - SW Pipeline Project Manager: I am here in support of SB 2223.

Dave Koland - ND Water Resource Rural Water Systems Association: We are here in support of this bill. Reducing this board is a large step forward in running the water system. I have some amendments with the approval of the sponsors that address the subject relating to water, but not specifically the SW Water Authority. I put these amendments on a bill that passed the Senate and ran into considerable amount of trouble because the Senate killed that legislation. This is a simple housecleaning amendment. During this session we had the Legislative Council take a look at the reimbursement of travel expenses for water district directors and employees. Chapter 61 covers directors with reimbursements but doesn't cover the expenses of employees. It gives the board the authority to fix the compensation of employees and it doesn't cover the reimbursement of expenses. This amendment adds the words, "and reimbursements of expenses. To make it clear that the board is entitled to fix the compensation of employees and reimburse them for their expense. Also to furnish vehicles for travel.

Chairman Rennerfeldt: Any questions of the committee?

Andy Mork - Morton County Water Resource Board: We appear here today in support of SB 2223. We do have a question on the makeup of the board. They have 1 director for each county,

Rep. Klein: Isn't it true that all the water in Dickinson is treated?

Flynn: Yes, it is. Dickinson made a suggestion that they go ahead vith their water treatment plant and they have done some upgrades and it was a saving of 7.2 million dollars by going through their treatment plant. So right now, the treatment plant is treating for all of the system that is in service now, including the city. Now, as of April 1st we will have operated and maintained the treatment plant for about a year. SW Authority does not own anything.

Good Morning. I am Chip Unruh, I zipped out of Zap. I am here to support Senate Bill 2223.

I am one of 27 directors on the Southwest Water Authority Board of Directors, representing Mercer County the past four years.

When this board was initially formed about nine years ago, we believed its size was appropriate considering the enormous task at hand covering such a large area.

Much has been accomplished since its inception. Presently we are furnishing a billion, yes I said a billion, gallons of quality water to 22 cities and 4500 patrons with 1869 hookups to farms and ranches.

While we have not yet reached our goal, a lot of potential and work still remains in Mercer, Oliver and North Dunn Counties. The Intake facility is located in Mercer County, yet we serve only the city of Golden Valley.

We voted to downsize our board and feel assured that we can reach our goal and reduce expenses with a smaller board as we have excellent leadership and staff.

We urge you to support this bill giving it a "DO PASS" designation.

Today, as shown on the charts accompanying this statement, the
Authority has a very capable staff to meet the needs of the Authority,
including meeting with county and city commissions and other groups as
needed. Downsizing will again save duplication of efforts by having one group

necessary business. Currently, the Executive Committee discusses some issues

Today, as shown on the charts accompanying this statement, the Authority has a very capable staff to meet the needs of the Authority, including meeting with county and city commissions and other groups as needed. Downsizing will again save duplication of efforts by having one group meet each month as the Board of Directors to discuss and approve all necessary business. Currently, the Executive Committee discusses some issues one month and these same issues must then be brought before the full Board the following month before action can be taken.

Situations change and the Southwest Water Authority is now in a position to downsize its Board and still meet the needs of southwest North

Dakota. This Board of Directors will still work to complete the Southwest

Pipeline Project, to continue to provide excellent operation and maintenance

of the system on behalf of the people of North Dakota, and to continue to take

an active role in water development throughout the state.
