Chairman Price, Vice Chairman Devlin, Rep. Dosch, Rep. Galvin, Rep. Klein, Rep. Pollert, Rep. Porter, Rep. Tieman, Rep. Weiler, Rep. Weisz, Rep. Cleary, Rep. Metcalf, Rep. Niemeier, Rep. Sandvig.

Chairman Price: Open the hearing on SB 2249.

Senator Kilzer: Presented the Bill. SB 2249 is a bill that I sponsored at the request of the State Board of Medical Examiners. Skin care comes under the Board of Cosmetology and if you violate something to do with skin care without a license, you will be prosecuted by the Board of Cosmetology. There are seven or eight exemptions under the existing law. This bill would add one more exemption to the people who do skin care so that they would not be subject to the Board of Cosmetology. This bill states that people who work in physicians offices and clinics would be exempt. For example, if I have someone in my office who removes stitches after

surgery and they don't have proper qualifications, they could be prosecuted if they are not licensed. So this Bill is brought in to take care of that.

Rep. Weiler: Can you give me an example in your office of someone that would take out stitches?

Senator Kilzer: Usually LPN's, sometimes technicians of one type or another.

Rep. Weiler: Give me an example of someone that is licensed to do that?

<u>Senator Kilzer</u>: In a typical medical office, it is just the physicians who are licensed in addition to nurses that might be there.

<u>Chairman Price</u>: Are you saying that, unless we pass this bill, that anyone in a physicians office that does some type of skin care is falling under the Board of Cosmetology right now?

Senator Kilzer: The incident that Mr. Sutton will address is someone that was in that situation.

There is a possible liability of someone doing skin care without a license.

Rep. Galvin: I can't envision a cosmetologist removing stitches, but it must have something to do with removing or shaving the hair before the procedure, that's what the bill would be about?

Senator Kilzer: That is probably a better example than what I gave.

Rep. Devlin: We had suggested merging the Board of Podiatrists with the State Medical Board, and it didn't meet with a lot of success. Do you have any thoughts on that?

Senator Kilzer: My thoughts on that is that we should have the numbers. We should have at least 100 or 200 practitioners before we give licensing authority, because if they have to discipline one of their members, they run out of funs and complete the process.

<u>Chairman Price</u>: We will stand at ease until Mr. Sletten gets here.

Chairman Price: The meeting will come to order and we will resume the hearing on SB 2249.

John Olson: North Dakota Board of Medical Examiners. I have passed out testimony that was written out by my boss, the Executive Director Rolf Sletten. The bill essentially does a very simple thing. It exempts the services provided under the supervision, control, and responsibility of a North Dakota licensed physician from Cosmetology Practice Act. Currently Estheticians are people who engage in the practice of skin care and they are regulated by the Board of Cosmetology. The Board of Cosmetology's attorneys advised the Board of Medical Examiners that there were some people who were providing these kinds of services in a plastic surgeons office that were in violation of the Cosmetology Act. As a result, this Bill was prepared to exempt those people who assist physicians in Dermatologists offices from the Cosmetology Act. (See Rolf Sletten's written testimony.)

Bert Knell: President, N.D. State Board of Cosmetology. (See support of SB 2249 in written testimony.) The board members voted to except this exemption.

Chairman Price: Close hearing on SB 2249.

Chairman Price: We pulled SB 2249 back down here to hold until we decided on SB 2371. The Board of Medical Examiners have proposed amendments to that bill. On the last line it will read "licensed physician in a hospital or a medical clinic". The first thing we need to do to re-address this bill is that we have to vote to reconsider our options. If not, it will go back up to the floor as is as a DO PASS. The concerns expressed by the cosmetologists with this bill which all came after our hearing was that the persons owning or operating a spa would have licensed personnel doing these procedures. I had asked Mr. Olson to prepare language that he felt would definitely specify that the only exemptions are in a hospital or in the doctor's office. I also expressed my

concerns about the physician actually seeing the patient. Mr. Olson, would you like to address that?

John Olson: I presented this year and it is the best we can do. We want to make it very clear that we're not talking about spas. Medical clinics and hospitals are pretty widely known terms and should restrict those exemption to those practices where medical services are being rendered.

Chairman Price: Committee, what would you like to do?

<u>Vice Chairman Devlin</u>: I would move that we reconsider action where SB 2249 received a DO PASS in this committee.

Rep. Metcalf: Second.

<u>Chairman Price</u>: All those in favor signify by saying Aye. We have 2249 in front of us what are your wishes.

Vice Chairman Devlin: I will move the Medical Examiner's amendment.

Rep. Metcalf: Second.

<u>Chairman Price</u>: Any discussion? Mr. Olson, do you feel that this will take care of having these services in a spa unless by a licensed cosmetologist or esthetician?

Rep. Porter: My concerns are still there. That what we're saying it is not under the direct supervision. We're saying that an untrained, unlicensed individual that is working in a medical clinic for a physician can, by themselves, apply medical grade products to an unknowing patient. If nothing ever happens, I think we have an unknowing patient situation being in a physician's office. We don't allow it with nurses, and we don't allow it with lab techs. I am going to oppose the bill as it is written.

Chairman Price: This bill came in front of us because, apparently, there was an unlicensed person doing some sort of services they felt should require a license. Do you want the physician's office to have that legally or not?

Rep. Porter: We have a motion for a DO PASS as amended. Clerk will read the roll. The motion failed.

Rep. Porter: I move a DO NOT PASS as amended.

Rep. Klein: Second

Rep. Porter: By defeating this bill it does not affect the licensed practical nurse, the licensed registered nurse, any licensed professional working inside that physician's office. All it is affecting is an untrained, unlicensed person, doing something in a physician's office. It is the right statement in public protection.

As is true of most if not all professions, the scope of practice of cosmetology is defined in very broad terms (see Exhibit A).

More importantly, the code provides that the cosmetology board licenses stheticians. Estheticians are defined (Exhibit A) as people who are licensed by that board "to engage in the practice of skin care".

The term skin care is extremely broad. Obviously, other people also engage in providing skin care, eg., dermatologists and plastic surgeons provide skin care at a level that no esthetician ever contemplated.

The history of this bill is that an attorney representing the Board of Cosmetology wrote to one or more plastic surgeons practicing in North Dakota and suggested that the doctor's assistant could be prosecuted criminally for practicing cosmetology without a license because that assistant was providing skin care.

We then suggested to that attorney that when activities which might be described as cosmetology or skin care are provided in a medical facility under the direction of a physician, the services fall within the practice of medicine and should not be regulated by the Cosmetology

Board.

The Cosmetology Board agreed and provided us with a proposed amendment to their practice act (Exhibit B).

This bill is an addition to the exemptions from the provisions of the Cosmetology Practice

Act. The other exemptions are included here at Exhibit C.

## EXKIBIT.

43-11-01. Definitions. In this chapter, unless the context or subject matter thereof otherwise requires:

1. "Board" means the state board of cosmetology.

2. "Cosmetology" means any one or combination of practices generally and usually heretofore and hereafter performed by and known as the occupation of beauty culturists or cosmeticians or cosmetologists or hairdressers, or of any other person holding him or herself out as practicing cosmetology by whatever designation and within the meaning of this chapter and in and upon whatever place or premises; and in particular cosmetology is defined and includes, but otherwise is not limited thereby, the following or any one or a combination of practices: arranging, dressing, curling, waving, cleansing, cutting, singeing, bleaching, coloring, or similar work, upon the hair of any person by any means or with hands or mechanical or electrical apparatus or appliances. or by the use of cosmetic preparations. apparatus or appliances, or by the use of cosmetic preparations, antiseptics, tonics, lotions, creams, or otherwise, massaging, cleansing, stimulating, manipulating, exercising, beautifying or similar work on the scalp, face, neck, arms, hands, bust or upper part of the body, or manicuring the nails of any person.

3. "Cosmetology salon" includes that part of any building wherein the occupation of a cosmetologist is practiced.

4. "Esthetician" means a person who is licensed by the board to engage in the practice of skin care. An esthetician does not include a

- in the practice of skin care. An esthetician does not include a professional make-up artist trained in facial make-up application by a cosmetics company.
- 12. "Skin care" means the use of cosmetic preparations, antiseptics, tonics, lotions, creams, or otherwise, massaging, cleansing, stimulating, manipulating, beautifying, or similar work on the scalp, face, neck, arms, hands, bust, or upper part of the body of any person.

# EXHIBIT C

48-11-02. Exemptions from provisions of chapter. This chapter does not apply to:

1. Services in case of emergency.

2. Services provided by persons practicing cosmetology upon members

of their immediate families.

3. Services by a person licensed by the state and working within the standards and ethics of that person's profession, if that person does not represent to the public that the person is a cosmetologist or manicurist.

 Services by nurses, undertakers, and morticians lawfully engaged in the performance of the usual and ordinary duties of their vocation.

5. Educational activities conducted in connection with any regularly scheduled meeting or any educational activities of any bona fide association of licensed cosmetologists, from which the general public is excluded. For purposes of this subsection a "bona fide association of cosmetologists" means any organization whose constitution, bylaws, or membership rules establish within said organization a class of membership consisting of licensed cosmetologists.

6. Services provided by retailers or their sales personnel trained in the demonstration of cosmetics application if the cosmetics are applied only with disposable applicators that are discarded after each customer demonstration. The board may adopt rules to ensure sanitary conditions for services provided under this exemption.

7. Services provided in a licensed hospital or a nursing home by a person practicing cosmetology on a volunteer basis without compensation or by a nurse's assistant.
