SENATOR FISCHER opened on the hearing on SB 2256, RELATING TO THE ISSUANCE OF BONDS FOR CONSTRUCTION OF AN OUTLET FROM DEVIL'S LAKE.

SENATOR TRAYNOR, of District 13 the prime sponsor of SB 2256 presented the bill, stated the bill was necessary because in the 1999 session SB 2188 was passed that provided flood relief and protection for several cities. The bill provided that the outlet be constructed only after the United States authorized the project. This has not been done and SB 2256 extends the authority of the state to issue bonds for the state's contribution of \$20,000,000.00 for the outlet cost. REPRESENTATIVE DENNIS JOHNSON, of District 12, cosponsor of SB 2256 testified in support of the bill.

JOE BELFORD, County Commissioner and Chairman of the Lake Emergency Management Committee testified that \$400 Million has been spend on the battle of the flooding of Devil's Lake. flooded if the lake rises to 1460. He is sure water will flow into Stump Lake this year, that is 13 feet below running into the Sheyenne River. He gave several updates on proposed projects and plans to keep up with continuing flooding.

DALE FRINK, interim State Engineer of the North Dakota State Water Commission, testified in support of the SB 2256. (See attached testimony).

ARDEN HANER, former water manager, testified in a neutral position of SB 2256.

There was no testimony presented in opposition to SB 2256.

The hearing was closed on SB 2256.

SENATOR TRAYNOR made a motion for a "Do Pass - rereferred to Appropriations" of SB 2256.

SENATOR EVERY second the motion.

SENATOR FISCHER called for roll vote of SB 2256. The vote indicated 7 YAYS, 0 NAYS, 0 ABSENT OR NOT VOTING.

SENATOR TRAYNOR will carry SB 2256.

SB 2256 extends the effective date to issue bonds for only the Devils Lake flood control project through June 30, 2003. North Dakota State Water Commission's appropriation bill, HB 1023, also contains the bonding authority for the Devils Lake project.

The Devils Lake flood control project was approved for \$20 million. At this time none of these funds have been expended. SB 2256 provides the authority to bond for \$20 million.

Although extending the effective date would allow the State Water Commission to issue \$20 million of bonds, the State Water Commission has only included \$10 million in our 2001 - 2003 budget with the balance needed in future bienniums.

Chairman Rennerfeldt; I will call the House Natural Resources Committee to order. Call the roll.

I will open the hearing on SB 2256. We have Sen. Traynor here to introduce the bill.

Sen. Traynor - District 15: I am here to encourage your support of SB 2256. We passed a bill 2 years ago that offered water programs for several communities in ND, it was really a statewide program and provided the funds to do it for 10 years and beyond. The item for Devils Lake was the authority to issue bonds up to 20 million dollars for an outlet from Devils Lake in cooperation with a Federal program. This bill merely extends the authority to issue the bonds until June 30, 2003. That authority will expire this coming June. So that is the only purpose of

this bill. We are hoping the Federal government will move forward in the next couple of years on this program. The only item I want to mention is the law passed two years ago addressed downstream interests. It says, "The State Water Commission may only issue bonds for the construction of an outlet from Devils Lake when the US authorizes construction of an outlet, and neither the State Water Commission or a Federal Agency has developed a plan addressing damage to basic infrastructure, such as roads, culverts, and bridges, riverbank erosion, downstream flooding and increased water treatment costs caused by or resulting from the construction of an outlet." That remains in the law. This does not change that. So the program would protect the downstream interests. With the recent forecast, I am sure you have all heard that the lake will likely rise another 3 feet to almost 1450 feet. The urgency of the outlet is even more than it was two years ago. So I would encourage the committee to give a Do Pass to this bill.

Chairman Rennerfeldt: Does the committee have any questions for the Senator?

Joe Belford - Ransom County Commissioner: I stand before you in support of SB 2256, the bonding bill for Devils Lake. The Environmental Impact statement is on the way. We are going to have our scoping meeting on the 6th of April, there will be 6 of them. The schedule for the Environmental Impact Statement is to be completed by November 2002. The design will be ongoing. So we could very possibly be needing to tap into t! __funding bill before the session meets again. As you know we are going to spend another 30-40 million dollars on roads in Devils Lake this year. Some more dikes and things of that nature. It is time to move forward and get some kind of relief.

TESTIMONY ON SENATE BILL 2256

Dale Frink, Interim State Engineer North Dakota State Water Commission

Mr. Chairman and Members of the Senate Natural Resources Committee, I am Dale Frink, Interim State Engineer for the State Water Commission and I appear today in support of funding for a Devils Lake outlet.

The flooding crisis around Devils lake continues to be one of the most difficult issues facing the state. Devils lake is at elevation 1446.1 msl and is expected to start to flow into Stump Lake later this year. An outlet from Devils Lake is a priority of the Water Commission. We continue to work with the U.S. Army Corps of Engineers on a permanent outlet from the west end of the lake. We are also considering an emergency state outlet for the lake.

Last biennium the legislature authorized up to \$20 million of state funds for a Devils Lake outlet. The Water Commission's appropriation bill, HB 1023, includes \$10 million for the outlet during the 2001-003 biennium, including bonding authority for the outlet and other statewide water projects.

Mr. Chairman and Members of the Committee, I urge your continued support for a Devils Lake outlet.
