#### Minutes:

The hearing was opened on SB 2326.

SENATOR LEE introduced the bill. This bill has to do with CHAND, Comprehensive Health Association of ND. It's a high risk pool for people who are unable to the resultance from other sources. The concern is that there is no limitation that an individual must live in ND for any length of time to participate in this high risk pool. This calls for an individual would be required to live in the state for half of the year - 182 days- in order to continue to participate in CHAND. SENATOR MATHERN: What happens when a person leave? Do they leave the eligibility immediately? SENATOR LEE: They would know at the beginning that they would have to be a resident for 182 days, but at the time of renewal they would have to vouch for the fact of residency. The concept is that somebody living out of the state for most of the year should not be able to participate.

ROD ST. AUBYN, BCBS, supports bill. The CHAND board is experiencing problems. This is a residency requirement. There are always a problem with residency, but we are trying to avoid some of the abuses. SENATOR KHLZER: Are there other states that have reciprocity agreements? MR. ST. AUBYN: I am not aware of any. Most states will allow for portability. SENATOR MATHERN: How would you interpret this? MR. ST. AUBYN: We would determine when address actually changed. Haven't had too many cases to resolve. SENATOR POLOVITZ: Is this for underprivileged? VANCE MAGNASON: CHAND is a high risk program. 135% of rate for individual coverage. Claims are higher so there is help from CHAND. SENATOR MATHERN: If we added when coverage ceases immediately when another plan is in place.

CHUCK JOHNSON sited an example of a lady on Chand living in Las Vegas for 3-4 had property in ND, so she claimed residency in ND.

KEN KARLS, Cystic Fibrosis Assoc., has an amendment to propose. (Written testimony). The amendment would allow for exemption from CHAND participants who are absent from the state for authenticated medical reasons. It is possible for cystic fibrosis patients to be at a place of treatment for days that may take them over the 182 day requirement. We have a number of members on CHAND now. SENATOR MATHERN: Do you agree with the amendment, Mr. St. Aubyn? MR. ST. AUBYN: If the amendment read if the individual physically resides outside the state for other than a verifiable medical reason as determined by the CHAND board. SENATOR KILZER: This could happen in burns and neonatal cases.

The hearing was closed on SB 2326.

Discussion was held on SR 2326. SENATOR MATHERN moved the amendments. SENATOR ERBELE seconded the motion. Roll call vote carried 6-0. SENATOR MATHERN moved a DO

Chairman Price and members of the committee, my name is Ken Karls and I represent the Cystic Fibrosis Association of North Dakota. The Association has been involved with the Comprehensive Health Association of North Dakota for many years because of the need for such coverage by persons with cystic fibrosis.

We support the bill as amended in the Senate Human Services Committee, which allows exceptions for participants who are absent from the state for verifiable medical reasons. I include the following as an explanation as to why we believe that amendment is necessary.

Lung transplantation for North Dakotans with cystic fibrosis is no longer an uncommon occurrence. Because it is withheld as an option until all other alternatives have been tried, persons needing a transplant are usually in need of frequent and in some cases, continuous hospitalization while awaiting organs. This hospitalization normally takes place at the Medical Center doing the transplant due to the serious condition of the patient. Since no lung transplantation is done in North Dakota, that hospitalization necessarily takes place out of state.
