Minutes: Chairman Krebsbach called the committee back to order and opened the hearing on SB 2342 which relates to providing a appropriation to the national World War II memorial in Washington, District of Columbia. Appearing before the committee was Senator Russell Thane, District 20, prime sponsor of the bill. A copy of Senator Thanes written testimony is attached. Representative Ron Carlisle, District 30, cosponsor of the bill indicated to the committee that he supports the bill and would hope the committee would give it a positive recommendation.

Arnold Maier, Bismarck, presented testimony in support of SB 2342. He submitted black and white handouts to the committee which provide information including photos of the proposed monument. Ray Harkema, Commissioner of Veteran's Affairs appeared before the committee. He indicated that on behalf of all veteran's in the state of North Dakota they would ask a favorable recommendation for SB 2342. Senator C. Nelson indicated that there are several memorials located in Washington, DC, where in proximity is this one to be located? Mr. Harkema indicated that this is on the mall in the same area as the other war memorials. Jerry

Wheatman, representing the Flasher American Legion indicated he is very much in support of this bill. He expressed a concern about names that are missing from the rolls of World War II. Bob Evans, secretary of the North Dakota Veteran's Coordinating Council, appeared before the committee. He indicated that the council unanimously supports this bill and asks the committees favorable consideration of the bill. George Jahner, citizen, appeared before the committee. He indicated he served in the South Pacific and toward the end of the war he was severely wounded and given up for dead. People never expected to see him. He was in the hospital almost four years and came back with the loss of a kidney, the loss of his right hip, and he has been living with this inconvenience and suffering since 1945. He indicated that he has done very well and is glad to be here. He indicated he totally supports SB 2342. Senator C. Nelson inquired what division Mr. Jahner served with. He indicated he was with the 37th Division out of Ohio. Bill Peschle, President of the Veteran's Service Officers Association in North Dakota, appeared before the committee. He indicated that his organization supports SB 2342. Senator Thane came before the committee once more and wanted to clarify to the veterans present that he was not a veteran of World War II, he spent the entire Korean conflict in the Air Force. Senator Deverinquired about where the appropriation was coming from for this bill. Senator Thane indicated that this appropriation will come from the general fund. It will go to the governor and the governor in turn will present it to the World War II Memorial Fund. John Jacobson, Member of the VFW Honor Guard appeared before the committee. Last year our honor guard buried over 120 members or former service members. It is a fitting way to send a veteran to his final rest. The World War II Veterans are dying at a rate of 1,000 to 1,500 a month. Many of them will not see this memorial. He indicated he is a veteran of the Persian Gulf War (Desert Storm) that spent 29 years in the Army Reserve and National Guard. He retired five years ago. He becomes very

emotional about some of these ways the veterans are being treated or mistreated. The veteran's of World War II do deserve memory of this. He has been to Washington, D. C. and has visited all the memorials and finds it difficult to walk by them without shedding a tear. He urges the committees support of this. There was no further testimony at this time. Chairman Krebsbach indicated that it is a most befitting honor for the World War II Veteran's to have such a memorial, both those who are with us now, and those who have gone before us. A mere thank you to this group of people seems very inadequate. We all in this room today have reaped benefits from their service to our country. The hearing was closed on SB 2342. Senator C.

Nelson moved a Do Pass and Rerefer to Appropriations on SB 2342, seconded by Senator Dever. Roll Call Vote indicated 6 Yeas, 0 Nays, and 0 Absent or Not Voting. Senator C. Nelson will carry the bill.

Senator Schobinger: Know that there has been national push to complete this --- individuals like Tom Hanks and companies like Walmart have been active in this area; along with Dole -- how close is it to fully funding?

Senator Thane: Don't have that answer. Each state was asked to make one dollar contribution per serviceman from their state.

Rep. Timm: We will open the hearing on SB2342.

Sen. Thane: (Followed written testimony and then answered questions following his testimony.)

Rep. Timm: The money, \$53,000 represents a dollar for every person who served from the state in World War II?

Sen. Thane: That's correct. It represents a dollar along with the 15790 who contributed by administrative committee of veteran's affairs from the post war trust fund.

Rep. Timm: Is this the formula that's being used by all the states?

Sen. Thane: Others will be testifying a little bit more on that, but all of the states have been asked by this special committee to contribute one dollar for every serviceman who served in World War II.

Rep. Delzer: How did the administrative committee come up with the 15790 out of that fund, there is close to \$5 million dollars in there, why such a small amount from them?

Sen. Thane: I can't really answer that question for you Rep. Delzer. I'm not exactly sure what was behind there decision to do that.

Rep. Delzer: They just brought it to you and asked you ask the legislature for the \$53,000?

Rep. Timm: Any other questions of Sen. Thane?

Rep. Koppleman: How is the funding for this raised across the country, is each state asked to contribute? The answer was yes.

Rep. Timm: Any further testimony in support of SB2342?

Sen. Bereler: (Had Handouts) I have some information here that outlines some of the numbers. As you look at these numbers, and I will start with the first bit of information that I provided to each of you and as you can see there are a phenomenal amount of people that were involved in World War II and I won't read every single one of them, but I will go into my testimony and I will have copies made of the testimony and I will bring it down, because the speaker before me spoke quite eloquently about the project and it is a national project. The list below , I will explain and some information on the World War II memorial, number one, the total cost of the memorial is to be in the \$150 million plus area, and total contributions to date are nearing that amount.

Number two, it is estimated it will take 30 months to complete once construction starts. World War II veterans are dying at the rate of over 1000 per day. Some states have contributed or pledged slightly over \$16 million dollars to date, the remaining donations have come from individuals, organizations, corporations, foundations, and the like. There are three states plus North Dakota that have yet to meet the goal established by Sen. Dole of one dollar per individual who served in that war. Legislation is currently being considered in these three states. Nine states

have contributed substantially more than one dollar per individual. The VA statistical and logistical branch has estimated 69,000 North Dakotan's served in the war and the administrative committee on veteran's affairs has given \$15,690 of post war trust fund earnings to the World War II memorial fund which represents \$10 for each individual from North Dakota who was killed in World War II. The remaining \$53,210 is contained in SB2342. I'm here today and I signed on to this bill because I too am a veteran, perhaps of a different war, but all wars the same that you lose lives, men and women alike and it doesn't matter how old you are or what rank you hold, if your in the line of duty and in harm's way you stand a good chance of being harmed and or ultimately killed. (Sen Bereier) went on to speak of his experiences in the Viet Nam war.

Rep. Timm: Any questions of Sen. Bereier? Any further testimony in support of SB2342?

Mr. Arnold Maier, World War II Veteran. (Followed written testimony and then answered questions following his testimony.)

Rep. Delzer: I have no problem with the idea of helping the World War II memorial, the question I have is how, do you have any knowledge of how they came up with other than the \$10 for everybody that died. With \$5 million dollars in the post war trust fund, why is the level at \$15,000 instead of saying matching what you want the state to do?

Mr. Maier: There is \$5 million dollars in the trust fund, but I think if you look at the law it says we can only spend the interest earned off of that trust fund and that is a part of that balance of the interest.

Rep. Wald: Isn't there a national effort where you can enroll a person that served in World War II and I think its forty dollars to have their name engraved like under North Dakota. I enrolled my oldest brother who served in World War II and I'm sure it was a forty dollar check I sent to

this national foundation. In the absence of that, all those who died will not have there name unless you go through that process?

Mr. Maler: I cannot answer that specifically because I do not know, but I was told that every persons that served in World War II is supposed to be inscribed on that memorial somehow.

Rep. Timm: Any other questions of Mr. Maier? Any other testimony in support of SB2342?

Rep. Delzer: A question for Allan. I'm reading through here and I don't necessarily see that it is just the interest, is there a requirement that none of the principal can be spent?

Allan, Legislative Council: Yes, the "96" initiated measure made the trust fund a constitutional trust fund and only the interest can be spent, the principal is like \$4.1 million dollars, so anything in addition to that can be spent.

Rep. Timm: And the interest can be spent? Response was yes.

Mr. Maler: The interest is spent on helping veterans who are in need, physically, mentally, health wise including some of their heirs and families that are in dire need of financial assistance and this fund is administered by the commissioner of veterans affairs.

Rep. Delzer: Do you know how much your projecting to spend in the next biennium?

Mr. Maier: No I don't

Rep. Timm: Any other testimony in support of SB2342? Any opposition to SB2342? If not we will close the hearing on SB2342.

"Affiliate" means any company that controls, is controlled by, or is under common control with another company.

"Nonaffliated third party" means any entity that is not an affiliate of, or related by common ownership or affiliated by corporate control with, the financial institution. The term does not include a joint employed of such a financial institution."

Page 2, after line 23, insert:

"SECTION 4. A new section to chapter 10-04 of the North Dakota Century Code is created and enacted as follows:

Disclosing customer information. Every dealer, agent, invostment advisor, federal covered advisor, and invostment advisor representative is a financial institution for purposes of chapter 6-08.1, relating to disclosure of customer information. The commissioner shall enforce compliance with this section.

SECTION 5. A new section to chapter 26.1-02 of the North Dakota Century Code is created and enacted as follows:

Disclosing customer information. Every insurance company, nonprofit health service corporation, and health maintenance organization is a financial institution for purposes of chapter 6-08.1, relating to disclosure of customer information. The commissioner shall enforce compliance with this section.

SECTION 6. A new section to Senate Bill No. 2127, as approved by the fifty-neventh legislative assembly, is created and enacted as follows:

SECTION 3. EFFECTIVE DATE. Section 1 of this Act becomes effective on August 1, 2003."







Congress provided legislative authority for siting the memorial in the prime area of the national capital, known as Area I, which includes the National Mall. The National Park Service, the Commission of Fine Arts, and the National Capital Planning Commission approved selection of the Rainbow Pool site at the east end of the Reflecting Pool between the Lincoln Memorial and the Washington Monument.

This prominent location is commensurate with the historical importance and lasting significance of World War II to America and the world. In the immediate vicinity are the Korean War Veterans Memorial, the Vietnam Veterans Memorial, the District of Columbia World War I Memorial, and Constitution ardens.

Listed below is some information on the WWII Memorial.

1. Total cost of Memorial is estimated to be in the \$150 million plus area. Total contributions to date are nearing that amount.

- 2. Estimated it will take 30 months to complete once construction starts. WWII veterans are dying at the rate of over 1000 per day.
- 3. State governments have contributed or pledged slightly over \$16 million to date. The remaining donations have come from individuals, organizations, corporations, foundations and the like.
- 4. Three states, plus North Dakota, have not yet met the goal established by Senator Bob Dole of \$1 per individual who served. Legislation is being currently considered in these states. Nine states have contributed substantially more than the \$1 per individual.
- 5. The VA's statistical and logistical branch has estimated 69,000 North Dakotans served in the war. The Administrative Committee on Veterans Affairs has given \$15,690 of Postwar Trust Fund earnings to the WWII Memorial fund, which represents \$10 for each individual from North Dakota who was killed in WWII. The remaining \$53,210 is contained in SB 2342.

Gene Kouba from the state veterans affairs department in Bismarck researched the questions you asked about various numbers concerning WWII veterans and gave me the following answers.

- 1. Total number of those who served in WWII, nationally: 16,535,000
- 2. Total number who served in WWII from North Dakota: 68,940
- 3. Total number who lost their lives in WWII, nationally: 405,399
- 4. Total North Dakotans who lost their lives in WWII: Numbers vary from 1579 to 2501
- 5. Total number of WWII veterans still alive, nationally: 8,150,000
- 6. Total number of WWII veterans from North Dakota still alive: 19,496
