Minutes: Senator Traynor opened the hearing on SB 2365: A BILL FOR AN ACT TO CREATE AND ENACT FOUR NEW SECTIONS TO CHAPTER 25-13 OF THE NORTH DAKOTA CENTURY CODE, RELATING TO ASSISTANCE DOGS; TO AMEND AND REENACT SECTIONS 25-13-02, 25-13-03, 25-13-04, AND 39-10-33.3 AND SUBSECTION 22 OF SECTION 40-05-02 OF THE NORTH DAKOTA CENTURY CODE, RELATING TO THE RIGHTS OF INDIVIDUALS WITH DISABILITIES WHO ARE ACCOMPANIED BY ASSISTANCE DOGS AND THE LICENSING OF ASSISTANCE DOGS; TO REPEAL SECTIONS 25-13-01 AND 25-13-05 OF THE NORTH DAKOTA CENTURY CODE, RELATING TO LEGILSLATIVE POLIC; AND TO PROVIDE A PENALTY.

Mike Goering, I support you. I'm saying the dog needs training to learn how to socialize with people. Allergies are a big problem and accomidations were made by employers. I have found allergies not to be a problem.

Senator Nelson, in subsection 4. A photo id, do you get a card for qualification?

Mike Goering, no, but there is a frame certifing.

Senator Nelson, could you take that and use them on the id card?

Mike Goering, I could do that, but it won't make much of a difference.

Minutes: Vice Chr Kretschmar opened the hearing on SB 2365. Relating to assistance dogs; relating to the rights of individuals with disabilities who are accompanied by assistance dogs and the licensing of assistance dogs and to provide a penalty.

Senator Robert Erbele: District 28, introduced the bill, there is a very similar bill on the House side carried by Rep Gulleson and then I introduced a bill on the Senate side (Great Plains Guide Dog School of Jud, North Dakota). They began in the late 1980 to train guide dogs. He explained the bill and explained the penalty phase of the bill.

Rep Klemin On page two, line two of section one, the word "common carrier: is used, what about North West Airlines.

Senator Erbele: Perhaps Mr Gehring can answer that question.

Rep Delmore: Arn't the dogs clearly recognizable as a trained assistance dog.

<u>Senator Erbele</u>: They have the harness that would indicate that they are an assistance dog, and the trainer would have a photo ID.

<u>Vice Chr Kretschmar</u>: If there are no further questions, thank you for appearing before the committee.

Rep Gulleson: District 26, appeared in support of SB 2365. I had a similar bill in HB 1395 and I went to the Senate side and asked for a DO NOT PASS recommendation, we are going to go with this bill as there is not point in having two bills. By the passage of both bills, we can pull them into one and have a strong bill. The language in this bill is very important and it puts them in line with seeing eye dogs.

<u>Vice Chr Kretschmar</u>: Are there any portions in your bill that you would like to have in this bill.

<u>Rep Gulleson</u>: There is an additional amendment that was not part of either bill that further clarifies the definition. There is nothing else.

<u>Vice Chr Kretschmar</u>: Are there any other questions, thank you for appearing.

Mike Gehring: There are two items in the bill that we need to look at, the importance is that the American With Disabilities Act speaks to assistance for people with handicaps. We have several problems trying to find out where the lines are in the use of the law. He then names several different types of animals that are being used. There is a coalition of consumers, trainers and guide dog programs that have come up with new language (see attached) to put in under section one to clarify the definition. The second change is in section three item 1B - trainer ID - we would like to add the US Council of Guide Dog Schools and international federation of guide dog schools.

Rep Delmore: Section six, I can understand, but a cane tells me one thing and a harness tells me another. Is there anything on the market that will identify an assistant dog.

Mike Gehring: That section of the law came as a result of the guide dog movement. When we school an individual, they are provided with a harness and back pack.

Rep Delmore: In section seven, it says there will be regulated examines, but the license fee will always be waived. Is there a reason why we will always be waived/

Mike Gehring: This comes out of model law. Because so many people who use our dogs, many of them are living month to month, we did not want to burden them financially.

<u>Vice Chr Kretschmar</u>: That part of the section is part of the municipal code. Could you tell us in a few minutes what your organization is doing down there.

Mike Gehring: In 1989, Great Plains started and we train dogs for people who have disabilities. He then goes on to explain the history of the organization.

Vice Chr Kretschmar: How long does it take to train a dog.

Mike Gehring: It takes 18 to 24 months, we start with 8 week old puppies and work with them until they reach the age of 2 year. The cost of training is \$15,000.00 per dog.

Vice Chr Kretschmar: What breed of dog do you use.

Mike Gehring: We use golden retrievers and labs and some cross breeds.

Rep Disrud: How many dogs can you house.

Mike Gehring: We have the facility to house 24 dogs.

Rep Delmore: Once the dogs are trained to the people come to North Dakota for their training.

Mike Gehring: The people come and stay for three weeks and then we provide a follow up service. In Montana Medicaid pays for the dogs and this can save the state up to \$60,000.00 per case.

Dear Committee members,

I am writing to urge make changes to SB 2365. I have worked people with disabilities for the past 8 years. In my current job as and ADA/Accessibility Specialist over the year and a half I have assisted people with disabilities with self-advocacy in requesting reasonable accommodations to allow both assistive animals in public places along with assistive animals and companion/therapeutic animals in housing situations. The current bill should be changed to include the following.

q Expand the proposed bill to include service animals instead of only addressing service dogs.

q Differentiate between service animal and companion/therapeutic animal along with defining the rights allotted to each type of animal and owner regarding access to public places, work or housing.

q Use caution in authorizing or requiring licensure or certification of service animals or companion/therapeutic animals.

First, SB 2365 only provides access rights to persons with disabilities who use assistance dogs. The Americans with Disabilities Act (ADA) provides access rights as a reasonable accommodation to persons with disabilities who use any assistance animal, recognizing other animals such as monkeys or other animals that are trained to do work or perform tasks for the person. See attached section from the ADA Title III Technical Assistance Manual along with the enclosed ADA "Commonly Asked Questions about Service Animals in Places of Business" and Department of Justice (DOJ) informational letter dated October 26, 1992, regarding definitions and examples of assistance/service animals. Additional information is available from the DOJ website as listed in the attached ADA Information Services sheet. Again I request that you expand SB 2365 to include assistance animals and not limit the bill only to assistance dogs.

Secondly, I request you differentiate between assistance animals and therapeutic/companion animals. Assistance animals are usually defined as an animal that is trained to do work or perform a task for a person with a disability. These animals usually have the rights as noted in the above. An assistance animal may or may not also be a companion/therapeutic animal depending on if therapeutic assistance to the well being of the person with a disability. Therapeutic/companion animals may or may not necessarily be service animals. Therapeutic

animals may a cat, dog or other animal that is prescribed for a person with a physical or psychiatric disability because the animal provides a level or therapeutic assistance to the well being of the person with a disability. These animals are allowed to live with a person. Landlords cannot refuse to rent an apartment to a person with a therapeutic animal even if the landlord has a no pet policy because the Fair Housing Act section 804(3) b., requires landlords to make "reasonable accommodations in rules, policies, practices, or services" for persons with disabilities. This same requirement is stated in the North Dakota Human Rights section of the Century Code 14-02.5-06 section (3)b. Landlords also cannot charge a pet deposit to a person with a therapeutic animal because additional charges/fees cannot be charged to persons with disabilities for reasonable accommodations. The person with the animal is still responsible though for any damage done by the animal. Therapeutic animals may be allowed to travel on trains, planes or accompany a person in a hotel/motel. Documentation usually required for therapeutic animals by landlords include a physician's letter documenting the person's need for the therapeutic/companion animal. Therapeutic/companion animals are not necessarily required to be trained because the benefit a person with a disability derives from a therapeutic animal may be directly inherent to the animal's nature. For example, cats or dogs may calm a person with hyperactivity or a mental illness. Fish may lower the blood pressure of a person with heart problems. A cat or dog may also provide a sense of well-being and purpose for a person who is lonely and suffers from depression. The access level accorded to therapeutic/companion animals should be decided by the person and his/her physician regarding access to travel accommodations such as hotels/motels, trains, planes or buses or other public places under the reasonable accommodation requirement of the ADA.

Lastly, I request that caution be taken when expanding assistive animal or therapeutic/companion animal licensing or certification requirements and responsibilities to city councils and board of city commissioners under the North Dakota Century Code 40-05-02. Under the ADA, a business owner "may not insist on proof of state certification before permitting the service animal to accompany the person with the disability" from ADA handout. See previously noted technical assistance section, enclosures along with DOJ Letter dated June 26, 1997 DOJ and Settlement Agreement with Budget Rant a Car Systems, Inc. These documents clearly state that a state licensing/certificate program requirement is not necessary for assistive or companion animals.

Specificall. "how public accommodation will determine whether an accompanying animal is a service animal. The title III regulation does not permit public accommodation to require any type or identification of certification of status to be shown. Moreover, the fact that a particular State law may require the showing of identification is irrelevant for purposed of determining rights under the ADA." DOG letter dated October 26, 1992.

#### ATTACHMENT

"III-4.2300 Service animals. A public accommodation must modify its policies to permit the use of a service animal by an individual with a disability, unless doing so would result in a fundamental alteration or jeopardize the safe operation of the public accommodation. Service animals include any animal individually trained to do work or perform tasks for the benefit of an individual with a disability. Tasks typically performed by service animals include guiding people with impaired vision, alerting individuals with impaired hearing to the presence of intruders or sounds, providing minimal protection or rescue work, pulling a wheelchair, or retrieving dropped items. The care or supervision of a service animal is the responsibility of his or her owner, not the public accommodation. A public accommodation may not require an individual with a disability to post a deposit as a condition to permitting a service animal to accompany its owner in a place of public accommodation, even if such deposits are required for pets.

ILLUSTRATION: An individual who is blind wishes to be accompanied in a restaurant by her guide dog. The restaurant must permit the guide dog to accompany its owner in all areas of the restaurant open to other patrons and may not insist that the dog be separated from her.

A number of States have programs to certify service animals. A private entity, however, may not insist on proof of State certification before permitting the entry of a service animal to a place of public accommodation."

### Proposed Language Amendment to CFR 36.104

A coalition of assistance dog training providers, guide dog providers, and those partnered with these dogs has developed and agreed upon the following language. The language was developed at a meeting of the coalition in February and has been agreed upon by all parties as of March 6<sup>th. 2001</sup>

Assistance animal means an assistance dog, and may include other animals specifically trained to perform physical tasks to mitigate an individual's disability. Assistance dogs include: guide dogs that guide individuals who are legally blind; hearing dogs that alert individuals who are deaf or hard of hearing to specific sounds; and, service dogs for individuals with disabilities other than blindness or deafness. Service dogs are trained to perform a variety of physical tasks including but not limited to pulling a wheelchair, lending balance support, picking up dropped objects or providing assistance in medical crisis. The presence of an animal for comfort, protection or personal defense does not qualify an animal as being trained to mitigate an individual's disability and therefore does not qualify said animal as an assistance animal.

This language has not been adopted by the Department of Justice as of March 7, 2001. The language is currently being forwarded to the DOJ for consideration at this time. Members of the coalition which drafted this language are unanimously in support of the language presented.

The purpose of this document is soley for information to North Dakota legislative members. This language has not yet been made available to the general population. It is presented by Great Plains Assistance Dogs Foundation, Inc. to legislative committee this 7th day of March, 2001. Great Plains presents this information for consideration for adoption to amend Senate Bill 2365; Section 1.

Each schools has agreed to submit to on site annual inspection of its breeding center, and puppy raiser program, to ensure it is complying with IFGDS standards in all respects. The organization was launched by the Guide Dogs for the Blind Association in Great Britain in the 1990's and now has 61 members.
