#### Minutes:

The meeting was called to order. All committee members, except SENATOR ESPEGARD, present. Hearing was opened on SB 2432 relating to the privacy of workers' compensation records and hearings.

SENATOR LINDA CHRISTENSON, District 18, in favor. This bill relates to privacy in the context of workers' compensation. Overstrike the wording in lines 21 to 23, page 1, because "others" is considered too broad, in reading the statute it is evident that pertinent parties already have access to the information. We ask that the social security number also be struck. Regarding the idea that certain information may be released to a particular group of people: hen you are talking about a worker who has filed a claim for disability we are looking at people who need to reach out and need support. We are asking that their names and very limited information be released in aggregate form so that these groups may contact them and support them. This groups have to be approved by the board, won't be just any group. We urge do pass.

L CHRISTENSON: C.A.R.E.

SENATOR MUTCH: Individual has to sign a release?

L CHRISTENSON: Yes

DAVID KIMNITZ, ND AFL-CIO, under the law who the "other persons" are is not clear. It could be anybody. The Bureau and its agents have access to the files. To protect confidentiality this language should be stricken as well as the social security number. Compromise was reached to give access to legitimate interest group at the discretion of the board. No way of knowing who needs assistance, so we agreed to name and address being released in aggregate list. Urge do pass.

SEBALD VETTER, C.A.R.E.. Member of the board of customer service committee at Workers' Comp. We don't feel it is right for businesses to call and find out who is on workmen's comp. These people would not be hired, that is not right and this bill will correct this. Urge do pass. DAN FINNEMAN, on his own behalf. Paragraph one, claimant may not get information that others have access to, both the bureau and the claimant should be able to study records. I object to availability at the discretion of the bureau, it should also be at the discretion of the bureau and the claimant. If I want copy of my medical record, I have to pay for it and sign a waiver, if the bureau requests it they get it free of charge. I urge careful consideration of this bill and do pass. BRENT EDISON, VP, Legal and Special Investigations for ND Workers Compensation Bureau. Written testimony attached. In opposition to this bill. Summary of actuarial information and WC board of directors list included. Board supports HB 1153 which is more balanced than this one. SENATOR EVERY: Is the board unanimous in its opposition to this bill? Do they unanimously support HB 1153?

# Fifty-Seventh Legislative Assembly Before the Senate Industry, Business and Labor Committee February 12, 2001 Testimony of Brent J. Edison North Dakota Workers Compensation

Mr. Chairman, Members of the Committee:

My name is Brent Edison. I am the Vice President of Legal and Special Investigations for North Dakota Workers Compensation (NDWC) and I am here to testify in opposition to 2001 Senate Bill No. 2432. The Workers Compensation Board of Directors unanimously opposes this bill and requests a "DO NOT PASS" recommendation.

NDWC has responded to the privacy concerns of injured workers by introducing House Bill No. 1153. Like Senate Bill No. 2432, House Bill No. 1153 removes "social security number" from the items of information that may be released to the public. House Bill No. 1153 also limits employer access to an injured worker's claim file to a "need to know" basis and provides for criminal penalties if there is a violation.

NDWC believes House Bill No. 1153 strikes an appropriate balance between an injured worker's privacy interests and NDWC's need for access to information sufficient to properly adjudicate the claim. Unfortunately, Senate Bill No. 2432 does not take the same balanced approach. Senate Bill No. 2432 would forbid NDWC from making claim file information available to "persons ... rendering assistance to the bureau..." but would permit NDWC to release lists of injured workers' names and addresses to "claimant interest groups approved by the board." (Current law prohibits NDWC from making injured workers' addresses available to the public).

Section 65-05-32 allows NDWC "agents or employees [acting] in the performance of their official duties" to have access to claim file information. Subsection 4 of section 65-

objection 4 is removed, and persons in rendering assistance to the pureau at any stage of the proceedings on any matter pertaining to the administration of this title." If subsection 4 is removed, and persons rendering assistance are no longer given specific authorization to review claim file information, the result will be uncertainty and litigation as to whether persons rendering assistance to NDWC are "agents" or "employees." NDWC believes this would hamper NDWC in its ability to adjudicate claims. While persons rendering assistance could perhaps be designated "agents" for purposes of adjudicating the claim, NDWC believes it would be better to leave subsection 4 as it is than to risk the potential unintended consequences of a change.

NDWC also believes it would not be in the best interest of injured workers to allow lists of their names and addresses to be released to un-defined "claimant interest groups" for unspecified purposes. NDWC is concerned the lists could be used for purposes that have nothing to do with the Workers Compensation Act.

This concludes my testimony on Senate Bill No. 2432. I respectfully request a "DO NOT PASS" recommendation on this bill and I will be happy to respond to any questions at this time.

### **NDWC Board of Directors**

Legislation enacted in 1997 created a customer-based Board of Directors. The Governor appointed ten members to the Board in January of 1998. The Board consists of six members representing employers of different sizes, three members representing employees, and one member representing the medical association.

The role of the Board is to ensure continuity of leadership at NDWC and to ensure that NDWC operates efficiently and effectively, rather than like an unresponsive bureaucracy. The Board has adopted the Carver Model of Board governance, which provides a clear structure for Board leadership and organizational accountability to the Board. This structure includes regular performance monitoring reports and an internal auditor that reports to the Board so the Board can ensure continued improvements are being made in all key areas of NDWC operations and services.

While NDWC has achieved tremendous improvements, it also recognizes the need to ensure that every aspect of its operation meets or exceeds private industry standards. Recognizing that no competition exists in the North Dakota workers' compensation market that would force NDWC to "operate efficiently or cease to exist", NDWC and its Board believe they have a special obligation to maintain the highest standards of performance and efficiency.

Chairman Mutch and members of the Senate Industry, Businesses and Labor Committee. I am Chuck Peterson, a member of GNDA, and a North Dakota businessman. Thank you for the opportunity to provide testimony in regarding SB 2432.

The Greater North Dakota Association is the voice of business and the principle advocate of positive change in North Dakota. As a member of GNDA we represent over 1000 business and professional organizations from all areas of North Dakota. GNDA is governed by a 25 member Board of Directors elected by our membership.

I also speak for the Associated General Contractors, the North Dakota Petroleum Council, the North Dakota Retail Petroleum Marketers Association, the North Dakota Motor Carriers Association, and the Automobile Dealers and Implement Dealers Association.

This legislation will limit the ability of contractor for the Worker Compensation Bureau to have access to information that will enable them to provide service to the Bureau. This legislation will require a release from each claimant each time a vender receives information that will be needed to function in behalf of the Worker Compensation Bureau. We see this as having a negative impact on the ability of the Bureau to contract for third party services.

This legislation provides that the Bureau may not release the worker's social security number. Another bill entered in this session will eliminate the availability of the worker's social security number.

SB 2432 provides. ability of the board to release information in aggregate form, which includes names and address, to claimant interest groups. We question that the board will be able to determine if all of the claimants may want their names and address released in aggregate to parties alleged to be claimant interest groups. It is highly probable that all claimants would not wish this to occur.

We urge a no vote to this legislation.

I came across a notice of decision denying benefits for Betty Wagner dated January 17, 2001.

I have been Betty's physician for the work related injuries that she sustained dating bar: o 1989. I've seen her dozens of times since then. I am a Board Certified Physiatrist. I have excellent credentials and superior ethical standards. I am licensed by the state of North Dakota of which workers comp is an agency.

The letter in question dated January 17, 2000 regarding Betty Wagner unfairly describes her situation. It is so clear to me that whoever is making these statements has a bias opinion with the ultimate goal of saving costs to this agency. They have not examined Betty Wagner. They have not followed her over the course of her development of shoulder problems since the initial injury. The letter itself misrepresents my opinion.

In the letter that I wrote dated July 12, 2000. What should have been quoted was my summary at the end of that letter "in summary

it is my opinion that her right shoulder problem is <u>solely</u> or at a minimum <u>largely</u> related to her employment in the late 1980's and 1990. Anyone with any medical training would know that an initial injury could be the seeds for progressive deterioration of the tissues traumatized as is the case with Betty Wagner.

I therefore feel that it is unethical for another health care professional to simply review records and make these sort of judgments when I have cared for Betty as her current condition has evolved from the initial insults when they originated. With all the press that workers comp has been receiving regarding its unfair treatment of patients, I would have expected you to be more careful in Betty Wagner's case. I would, therefore, advise you to reconsider this denial and pay appropriate respect to my opinions.
