Minutes:

The hearing was opened on SB 2438; qualification for election to a political subdivision office that the officeholder not be delinquent in property taxes in the county.

SENATOR EVERY: I stand before you today with some conflict, that would be the case of a freshman legislator that was standing in the halfway and was asked to sponsor a bill, and under the advisement of some colleagues I did so. The conflict isn't with sponsoring the bill, the conflict is with the bill itself. With bill, after I got to thinking about if there is some litigation for. I'm thinking especially for folks in the Devils Lake area that have fand under water that maybe disputing the property taxes, there could be a conflict there. I want to protect those people there, so please take that into consideration when you hear this bill today. SENATOR FLAKOLL: Will you be forwarding any of the amendments to that affect? SENATOR EVERY: I don't think so. SENATOR TOMAC: I respect the comments made by Senator Every. This is really not a senate bill, the reason that it started in the Senate is because of the deadline for the House is passed and

so we dropped it on the Senate side. I feel I really emphasize with Senator Emery because I did pretty much the same thing. But I think the issue deserves discussion. My reason for co-sponsoring it because it does bring out a point that I think deserves discussion. I think in retrospect, after co-sponsoring the bill, one really believes that you know that if people run for political office maybe they should have their taxes paid. But, then again, we have laws that require everybody to pay their taxes and there are penalties. And if in fact the issue did come up in election, the information that comes to me after signing onto the bill. You know, its kind of an individual election thing. So I also received a memo from the Attorney Generals office. There are some concerns that Senator Every raised about delinquent taxes. It seems to me that the other question I would add to that other that if your taxes are in dispute, and obviously we're talking about property taxes, because sales tax is what you pay on the spot, and income tax records are confidential, so it is pretty much reads property taxes. This is public record, and it is common practice for those people in the development business to not pay property taxes until the lots are sold. Does that then disqualify anyone that is a developer and a common practice to do that, there are a number of issues here that in hindsight probably need to be addressed and its probably a good discussion. But, in all fairness, to the bill, all intentions are honorable, but when you look at the bill, there are some elements that need to be discussed. Mr. John Fox left some amendments with Senator Tomac for the committee to see. They are not in proper form, but they do outline the concerns the Attorney General had. I didn't have any intentions of looking at them because I didn't research, once I received the memo from that, after giving it some other thought. REPRESENTATIVE BOEHM: We are introducing a bill that I think is a good bill, it needs a fair hearing and its a simple bill. You have to have your taxes paid, your property taxes paid before you run for political office. Like it was mentioned earlier, there might be exceptions to where

individuals might not pay their taxes for a particular reason. I think that needs to be born out in the testimony, or in your deliberation. These amendments were sent to me by the Attorney General and I don't believe there is anybody here from that department. They are rather simple. Just states, that we take other responsible election officials after county auditor and the vacancy. probation and another. On Line 22, it says where it has to be put in to the Century Code. Those are rather simple amendments. SENATOR COOK: I'm noticing that these three sponsors are neighbors of mine. I figure pretty soon were going to hear something that happened, BILL KOCH: See written testimony. Association of Counties asked why legislators and elected officials are not included. First of all they would have to have an amendment to the Constitution and secondly, that's probably because they can't be elected without paying their taxes. This may not impact some of the counties, but then it may to others. SENATOR LEE: Why then, aren't people who might be opposing these officials for elected office not be bringing that up and if they have brought it up and the electors don't elect this person, why should we step in? BILL KOCH: A lot of the people have said they didn't check this out, before they voted. Now some of them say we've known this before the election but nobody exposed these people. SENATOR LEE: My point, is that the opposition candidate there might have the same opportunity as our opposition candidates to check those public records, BILL KOCH: Right, Lunderstand that, Right, but, everybody kind of wants to be Mr. Nice Guy, you know, until after the fact. SENATOR WATNE: (Example Meter # 11.8-12.3) There are people like us that would be hurt by this bill. and on the local level, I can think of a couple of our county commissioners who maybe hurt along this type of thing. This is a bill, like you said, that may hurt some people in Devil Lake. This seems like a bill to solve your problem locally, BILL KOCH: No, its not in just in my county. These is other, counties. SENATOR WATNE: That's my next question? BILL KOCH: Your talking like your taxes, now are you talking county taxes, or city taxes? SENATOR WATNE: With my property tax? BILL KOCH: The property that your talking about was that in the county or in the city? SENATOR WATNE: It was in the city and we built a 24 unit...BILL KOCH: This wouldn't, this bill doesn't cover the city taxes. SENATOR WATNE: Are you talking only counties? BILL KOCH: Only, counties and nothing to do with the city. SENATOR LYSON: When I read your bill, it sounds like you don't want anybody to be running for election if there taxes are delinquent? BILL KOCH: Right, SENATOR LYSON: Right, but then you bring in your statement, that Bismarck has one for default. Do you know the difference between the two? BILL KOCH: Yes, from I understand from Bismarck, I only illustrate the laws...SENATOR LYSON: I am asking you if you know the difference between the delinquency

SENATOR LYSON: North Dakota state law allows people to be delinquent on their tax, because all they do is pay a penalty for that delinquency. In default, after 5 years, when they take the property from you, now are you looking for delinquency or are you looking for default here? BILL KOCH: Delinquency. Well, to keep, what were saying is your taxes should be current. I think that is what were saying in the bill. SENATOR FLAKOLL: This in no way, really addresses, any problems if they are already in office and there delinquent? Correct? BILL KOCH: This will go into affect say, when the time is up into the next election. 

Sandi Tabor asked that I contact the sponsors of Senate Bill 2438. It may be helpful to add several amendments to clarify portions of the bill. I have attached the proposed amendments for your consideration. While the amendments are not critical, I think they would be useful in adding some pertinent language and cross references to related statutes.

The first amendment would add "or other responsible election official" after "county auditor" on line 8 of the bill. There are instances where political subdivision elections are not run in conjunction with a county election, for example, some school district or other special political subdivision elections.

The next amendment would add a cross reference to the main vacancy statute, N.D.C.C. § 44-02-01, on line 18 after "located."

The final amendment would be on line 22 providing that the state's attorney may use procedures from the removal statutes contained in N.D.C.C. chs. 44-10 or 32-13. These are more complete procedures for instituting removal actions and would offer some guidance to the parties and the court on how to proceed.



TESTIMONY IN SUPPORT OF SENATE BILL #2438

MY NAME IS BILL KOCH FROM RALEIGH, NORTH DAKOTA.

I AM HERE TODAY TO ASK FOR YOUR SUPPORT OF SENATE BILL #2438, WHICH IS A BILL FOR AN ACT TO PROVIDE THAT IT IS A QUALIFICATION FOR ELECTION TO A POLITICAL SUBDIVISION OFFICE THAT THE OFFICE HOLDER NOT BE DELINQUENT IN PROPERTY TAXES IN THE COUNTY.

MANY PEOPLE FROM VARIOUS COUNTIES HAVE ENCOURAGED US TO PURSUE THIS BILL AND ALL AGREE IT IS A GOOD BILL.

IN DISCUSSION WITH MEMBERS OF THE LEGISLATIVE COUNCIL AND AN OPINION FROM THE ATTORNEY GENERAL'S OFFICE, BOTH OFFICES STATED THAT THIS BILL IS LEGAL AND CONSTITUTIONAL.

IS IT RIGHT FOR PEOPLE TO BE ELECTED TO COUNTY GOVERNMENT POSITIONS WHEN IN FACT THEY ARF DELINQUENT IN THE PAYMENT OF THEIR OWN PROPERTY TAXES? YET THEY PAY THEMSELVES WITH OTHER TAXPAYERS MONEY, THEY RECEIVE MEDICAL INSURANCE WITH OTHER TAXPAYERS MONEY, AND REIMBURSE THEIR EXPENSES WITH OTHER TAXPAYERS MONEY, WHILE THEY ARE DELINQUENT WITH THEIR OWN PROPERTY TAX PAYMENTS, WHICH IN SOME CASES ARE QUITE SUBSTANTIAL AMOUNTS.

SHOULDN'T PEOPLE IN COUNTY GOVERNMENT LEADERSHIP POSITIONS BE SETTING AN EXAMPLE FOR OTHER PEOPLE WHOM THEY GOVERN? IF "COUNTY LEADERS" WOULD PAY THEIR TAXES ON TIME LIKE OTHERS DO, THE COUNTIES WOULD HAVE MORE MONEY TO OPERATE ON, TO PURCHASE FUEL, BE ABLE TO REPAIR COUNTY EQUIPMENT, FIX ROADS, PURCHASE GRAVEL, REMOVE SNOW ETC.

IN CHECKING THE QUALIFICATIONS FOR ALL CITY OFFICES, NDCC 40-13-01 STATES: "NO PERSON IN DEFAULT TO THE CITY SHALL BE ELIGIBLE TO ANY CITY OFFICE." THE CITY OF MANDAN HAS A LAW IN EFFECT THAT STATES A PERSON CANNOT EVEN GET A LIQUOR LICENSE IF HIS7HER TAXES ARE NOT PAID.

IF WE DON'T PAY OUR STATE AND FEDERAL TAXES, AREN'T WE PENALIZED FOR BREAKING THE LAW? SHOULDN'T COUNTY GOVERNMENT HAVE THE SAME STATUTES?

I HAVE BEEN TOLD THAT LEGISLATORS AND OTHER STATE ELECTED OFFICIALS MAKE SURE THEIR TAXES ARE PAID, OTHERWISE IT WILL BECOME A CAMPAIGN ISSUE. IT IS TIME FOR COUNTY GOVERNMENT OFFICIALS TO PAY THEIR TAXES TOO!

LEGISLATORS AND OTHER STATE ELECTED OFFICIALS ARE NOT INCLUDED IN THIS BILL BECAUSE THEY ARE PAID FROM THE STATE GENERAL FUND AND NOT DIRECTLY FROM LAND TAXES AS COUNTY GOVERNMENT OFFICIALS ARE. AN AMENDMENT TO THE CONSTITUTION WOULD NEED TO BE ADDED TO INCLUDE THEM.

PEOPLE HAVE A PROBLEM WITH HAVING TO PAY THEIR TAXES WHEN THEIR ELECTED LEADERS DO NOT PAY THEIRS.

VOTING AGAINST THIS BILL IS VOTING AGAINST PAYING TAXES!!!!!
