SENATOR CHRISTMANN; Sponsor, introduce the bill to the committee. People need to understand what effects anti competitive practices have on their lives. Across the state this is believed to be a big problem for our production agriculture. The profitability of the food industry is shifting to the manufactures and away from the produces of the commodities. We are just asking that Congress monitor these conditions and take whatever action is necessary.

SENATOR KROEPLIN; Could you explain lines 21 - 23? It doesn't seem to fit with the rest of the resolution.

SENATOR CHRISTMANN; It doesn't fit real well with our perspective of what the problem is, but it is in there as an acknowledgment.

WADE MOSER; ND Stockmen's Assoc., testified in support of this resolution. We have had on our policy a resolution for several years that identify a couple issues that this resolution addresses. One is that we request immediate action by USDA, especially in the packers and
