Minutes: Chairman Krebsbach opened the hearing on SCR 4025 which is a resolution relating to urging Congress to pass legislation that will lift the embargo on trade with Cuba. Senator Aaron Krauter, District 35, prime sponsor of the resolution appeared before the committee to explain the resolution. A copy of his written testimony is attached. Senator Dever inquired what the impact of something like this with the Federal Congress. Does something like this, as far as the legislature forwarding our opinion to Congress, does it make some impact? Senator Krauter indicated that it makes a big impact. North Dakota's economy is based upon agriculture. One of the commodities that we raise in the state is wheat. People in countries like Cuba need those type of food supplies. Currently we are not allowed to do any of this trade with those countries. A state like North Dakota could have one more market out there and add 10 cents to a bushel in North Dakota. That would probably add another \$10 million in the economy. Chairman Krebsbach asked Senator Krauter for his opinion of where Cuba is importing the billion dollars worth of grain from? Senator Krauter indicated that Cuba isn't so much importing it from

someplace else. He thinks the people in Cuba are being limited on the ability and supplies to have those things right now. Senator T. Mathern, District 11, indicated he wanted to add an experience that he had over this past year. A number of his colleagues that he had while attending the Kennedy School of Government at Harvard University went to Cuba. An issue of the study that they had was understanding the economy but making a recommendation regarding the issue of the embargo. It was interesting in that they came back and there was the debate in the student senate. The proponent of ending the embargo stated that the embargo was assisting Fidel Castro in maintaining power in that this was his way of whipping up anti American sentiment. Castro's power was the embargo and if the embargo was lifted in full they believe that that sentiment. It was the conclusion of these students that the number one issue maintaining Fidel regime would collapse. Lance Hagen, with the North Dakota Grain Growers appeared before the committee and indicated that he and his organization support this resolution. There was nothing further. The hearing was closed on SCR 4025. Chairman Krebsbach commented on the resolution and it's value to the state of North Dakota. A motion for a Do Pass was made by Senator C. Nelson, seconded by Senator Dever. Roll Call vote indicated 6 Yeas, 0 Nays, and 0 Absent or Not Voting. Senator T. Mathern will carry the bill.

Testimony to SCR 4025 February 15, 2001

Chairman Krebsbach and members of the Senate Government and Veteran Affairs. For the record I am Aaron Krauter State Senator from District 35, which represents four rural agricultural counties.

Agriculture is the heart of the North Dakota economy. There is no higher priority for many North Dakotan's than keeping farmers and ranchers in business. As our farmers and ranchers work their long days in the fields and on the prairies, we must think globally about how our trade policies have affected their agricultural business.

Bad habits are hard to break. A sorry example is the way the federal government continues to embargo sales of food and medicine to nations with despotic leaders. These embargoes do absolutely no good. They hurt the people we are trying to help and they deprive our family farmers of markets they desperately need.

We have no quarrel with economic sanctions against the trouble makers of the world. The United States should take a stand against the governments of countries such as Cuba and Libya, Iran and Iraq, which suppress their own people and foment turmoil elsewhere. When foreign governments are training terrorists or committing blatant violations of human rights then, as a nation, we have a moral duty to act.

It is one thing to stop sales of weapons technology, surveillance devices and deals by which U.S. based corporations enrich the leaders of such nations. It is another thing to entirely withhold the food and medicine that the citizens of these countries need. Embargoes of food and medicine accomplish absolutely nothing. Neither Fidel Castro nor Muammar Qaddafi has ever missed a meal because of a U.S. trade embargo. They have never been denied the medicine they need. In case someone hasn't noticed, they are still in power, despite deades of embargoes against their countries that included food and medicine.

The only people hurt by these policies are the ordinary citizens who suffer greatly under these regimes already and North Dakota Farmers.

SCR 4025 urges Congress to pass legislation that will lift the embargo on trade with Cuba. North Dakota needs open market for our agricultural trade to move freely.

Last year, Senator Dorgan won passage of legislation that ended the 40 year old U.S. embargo on food and medicine sales to Cuba, as well as unilateral U.S. food and medicine embargoes against Iran, Libya, Sudan, and North Korea, new markets with the potential for more the \$6 billion in sales annually. However, congressional foes of any trade with Cuba amended the legislation to prohibit U.S. financing - even private sector financing of sales to Cuba. The practical impact of that change was to keep the \$1 billion Cuban market closed to U.S. farmers.

The key to this resolution is found on line 12, to repeal all restrictions. We need to send a message to Congress taht will show support for our farmers and ranchers of North Dakota. Task for a Do Pass on SCR 4025.
