1 A BILL for an Act to amend and reenact paragraphs 30, 33, 34, 35, and 36 of subdivision a of
2 subsection 3 of section 39-06.1-10 of the North Dakota Century Code, relating to the point
3 demerits for driving in excess of the speed limit.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Paragraphs 30, 33, 34, 35, and 36 of subdivision a of
6 subsection 3 of section 39-06.1-10 of the North Dakota Century Code are amended and
7 reenacted as follows:
