1 A BILL for an Act to amend and reenact subsection 1 of section 20.1-03-07, section
2 20.1-03-07.1, and subsections 2, 7, 8, 37, 38, and 39 of section 20.1-03-12 of the North Dakota
3 Century Code, relating to nonresident hunting and fishing licenses and fees; and to provide an
4 effective date.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** Subsection 1 of section 20.1-03-07 of the 1999
7 Supplement to the North Dakota Century Code is amended and reenacted as follows:

8 1. Hunt, catch, take, or kill any small game without a nonresident small game license.
9 The nonresident small game license entitles the nonresident to hunt small game
10 for any period of fourteen consecutive days or any two periods of seven
11 consecutive days each. The hunting period for which the license is valid must be
12 designated on the license. A nonresident small game license is not required to
13 hunt waterfowl under section 20.1-03-07.1. A nonresident may purchase more
14 than one nonresident small game license per year.

15 **SECTION 2. AMENDMENT.** Section 20.1-03-07.1 of the 1999 Supplement to the
16 North Dakota Century Code is amended and reenacted as follows:

17 **20.1-03-07.1. Nonresident waterfowl hunting license required.** Except as provided
18 in sections 20.1-03-07.2 and 20.1-03-07.3, a nonresident may not hunt waterfowl unless that
19 person first obtains a nonresident waterfowl hunting license, ~~in addition to a nonresident small~~
20 ~~game hunting license.~~ The nonresident waterfowl hunting license entitles the nonresident to
21 hunt waterfowl for any period of fourteen consecutive days, any period of seven consecutive
22 days, or any two periods of seven consecutive days each. A license authorizing the
23 fourteen-day hunting period allows hunting in a specified waterfowl hunting zone. A license
24 authorizing one 7-day hunting period allows hunting statewide. A license authorizing two 7-day

1 hunting periods allows hunting in a specified zone during each period. The governor, in the
2 governor's proclamation, shall specify various waterfowl hunting zones for which nonresident
3 waterfowl hunting licenses will be available, and may specify the number of licenses which may
4 be issued in each zone and the manner in which they are to be issued. A nonresident is
5 entitled to purchase only one nonresident waterfowl hunting license per year.

6 **SECTION 3. AMENDMENT.** Subsections 2 and 37 of section 20.1-03-12 of the 1999
7 Supplement to the North Dakota Century Code are amended and reenacted as follows:

8 2. For a nonresident small game hunting license, ~~seventy-five~~ eighty-five dollars.

9 37. For a nonresident waterfowl hunting license, ~~ten~~ eighty-five dollars.

10 **SECTION 4. AMENDMENT.** Subsections 7, 8, 38, and 39 of section 20.1-03-12 of the
11 1999 Supplement to the North Dakota Century Code are amended and reenacted as follows:

12 7. For a nonresident fishing license, ~~twenty-five~~ thirty-two dollars.

13 8. For a nonresident short-term seven-day fishing license, ~~fifteen~~ twenty dollars.

14 38. For a nonresident husband and wife fishing license, ~~thirty-five~~ forty-five dollars.

15 39. For a nonresident short-term three-day fishing license, ~~ten~~ fifteen dollars.

16 **SECTION 5. EFFECTIVE DATE.** Section 4 of this Act becomes effective on April 1,
17 2002.
