4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. APPROPRIATION. The funds provided i	n this section, or so much of the	
6	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		
7	treasury, not otherwise appropriated, and from special funds derived from federal funds and		
8	other income to the North Dakota state university extension service, the northern crops institute,		
9	the upper great plains transportation institute, and the North Dakota agricultural experiment		
10	station for the purpose of defraying the expenses of their various divisions, for the biennium		
11	beginning July 1, 2001, and ending June 30, 2003, as follows:

13	SECTION 2. ADDITIONAL INCOME - APPROPRIATION. Any additional income				
14	including funds from federal acts, private grants, gifts and donations, or from other sources				
15	received by the North Dakota agricultural experiment station, northern crops institute, upper				
16	great plains transportation institute, and the North Dakota state university extension service,				
17	except as otherwise provided by law, is appropriated for the purpose designated in the act,				
18	grant, or donation for the biennium beginning July 1, 2001, and ending June 30, 2003.				
19	SECTION 3. TRANSFER AUTHORITY. Upon approval of the state board of higher				
20	education and the state board of agricultural research and education, the director of the North				
21	Dakota agricultural experiment station may transfer appropriation authority from subdivision 4 to				
22	subdivision 5 and within subdivision 5 of section 1 of this Act and shall notify the office of				
23	management and budget within ten days following the transfer.				
24	SECTION 4. LEGISLATIVE INTENT - FULL-TIME EQUIVALENTS. The board of				
25	higher education is authorized to adjust or increase full-time equivalent positions as needed,				
26	subject to availability of funds. The board shall report any adjus-	tments to the office of			
27	management and budget prior to the submission of the 2003-05 budget request.				
28	SECTION 5. UNEXPENDED GENERAL FUND - EXCESS INCOME. Any unexpended				
29	general fund appropriation authority to and any excess income received by entities listed in				
30	section 1 of this Act are not subject to the provisions of section 54-44.1-11, and any

- 1 unexpended funds from these appropriations or revenues are available and may be expended
- 2 during the biennium beginning July 1, 2003, and ending June 30, 2005.
