1 A BILL for an Act to amend and reenact section 64-02-10 of the North Dakota Century Code,
2 relating to fees for testing or calibrating weighing and measuring devices.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 64-02-10 of the 1999 Supplement to the North
5 Dakota Century Code is amended and reenacted as follows:

6 **64-02-10. Fees to test or calibrate weighing and measuring devices.** The

7			When a rejected weighing or measuring device has been reconditioned or replaced by		
8			new equipment, it must be retested and certified before being put into use except as otherwise		
9			provided by rule. The fee for retest and certification is the same as for the first test and		
10			certification.		
11			When a test of a weighing or measuring device is required in addition to the regularly		
12			scheduled annual test, the commission shall charge a fee equal to the cost of operating the		
13			motor vehicle used in conducting the test. The mileage charges, as determined by the		
14			commission, must be in addition to the regular test fee and calculated to cover the costs of the		
15			additional travel. Where a test has been requested and the person requesting it fails to appear		
16			or to have the weighing or measuring device ready for testing at the arranged time, there is a		
17			charge of nine <u>ten</u> dollars a quarter hour for the time between the arranged time and the time at		
18			which the test can begin.
