1 A BILL for an Act to amend and reenact sections 58-06-02, 58-07-01, 58-08-01, and 58-09-02
2 of the North Dakota Century Code, relating to compensation of township officers.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 58-06-02 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **58-06-02. Compensation of supervisors.** A township supervisor ~~shall~~ is entitled to
7 receive as compensation for services ~~fifteen~~ twenty dollars a day for each day necessarily
8 devoted to the work of ~~the~~ a supervisor's office not exceeding six hundred dollars in a calendar
9 year. Additional compensation over six hundred dollars may be provided for reimbursement of
10 expenses and twenty cents per mile [1.61 kilometers] mileage at a rate not exceeding the
11 allowable mileage rate accepted by the United States internal revenue service for each mile
12 [1.61 kilometers] necessarily traveled in the performance of a supervisor's duties, but the
13 compensation may not exceed four hundred fifty dollars in any one year.

14 **SECTION 2. AMENDMENT.** Section 58-07-01 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **58-07-01. Compensation of clerk.** The township clerk ~~shall~~ is entitled to receive as
17 compensation for services ~~fifteen~~ twenty dollars a day for each day necessarily devoted to the
18 work of the clerk's office not exceeding six hundred dollars in a calendar year. The clerk shall
19 receive as reimbursement for expenses twenty cents per mile [1.61 kilometers] Additional
20 compensation over six hundred dollars may be provided for reimbursement of expenses and
21 mileage at a rate not exceeding the allowable mileage rate accepted by the United States
22 internal revenue service for each mile [1.61 kilometers] actually and necessarily traveled in the
23 performance of the clerk's duties. The clerk may not receive more than four hundred fifty
24 dollars in any year. In those townships in which the offices of township clerk and treasurer

1 have been merged, the person elected to fill the new office ~~shall~~ is entitled to receive
2 compensation as township clerk only.

3 **SECTION 3. AMENDMENT.** Section 58-08-01 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **58-08-01. Compensation of treasurer.** ~~Each~~ The township treasurer shall is entitled
6 to receive as compensation for services ~~fifteen~~ twenty dollars a day for each day necessarily
7 devoted to the work of the treasurer's office not exceeding six hundred dollars in a calendar
8 year. Additional compensation over six hundred dollars may be provided for reimbursement of
9 expenses and ~~twenty cents for each mile [1.61 kilometers]~~ mileage at a rate not exceeding the
10 allowable mileage rate accepted by the United States internal revenue service for each mile
11 [1.61 kilometers] necessarily traveled in the performance of ~~such~~ the treasurer's duties. The
12 township treasurer may not ~~receive more than four hundred fifty dollars in any year nor be~~
13 ~~allowed a percentage on the balance turned over to the treasurer's successor in office.~~

14 **SECTION 4. AMENDMENT.** Section 58-09-02 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **58-09-02. Compensation of assessor.** The township assessor ~~shall receive as is~~
17 entitled to compensation for services ~~a~~ in the sum determined by the board of township
18 supervisors for the time actually and necessarily employed in making and completing the
19 assessment of the township and ~~twenty cents per mile [1.61 kilometers]~~ mileage at a rate not
20 exceeding the allowable mileage rate accepted by the United States internal revenue service
21 for each mile [1.61 kilometers] necessarily traveled in the performance of the duties of office.
22 The compensation must be paid out of the township treasury upon an itemized statement
23 setting forth the actual time spent in the work of assessor, approved by the board of township
24 supervisors.
