# **REQUEST**

**REP. BELTER REQUESTED** that his remarks be printed in the Journal, which request was granted.

Martin Luther King Jr. was one individual who dedicated his life to racial equality like few others before or since.

He lost his life in that quest in 1968, however his dream lives on.

In 1954 he stated, "I decided to give my life to something eternal and absolute; not to these little gods that are here today and gone tomorrow, but to a god who is the same yesterday, today, and tomorrow."

In 1963; in his most noted speech at the Washington Monument he said, "I have a dream that my four little children will one day live in a nation where they will not be judged by the color of their skin, but by the content of their character."

I don't think it could be put better.

Much progress has been made in the years since, however we must still continue to plant racial equity in our personal lives, before it can grow in our nation.

I wish to share a story related by former President Jimmy Carter: His boyhood friends were all black on his father's Georgia farm; They played together. . . Boarded trains, but sat in different cars. They walked together sometimes hand in hand. They bought their tickets together, but he sat on the first floor, they on the third.

At the age of 14 they were playing together in a pasture, and as they left they opened the gate but let him walk through first.

At that point he knew that life would never be the same, he realized that their parents had now suggested it was time to fall under the rules of segregation imposed upon them.

Let's use this day to evaluate our personal prejudices and beliefs. Martin Luther King Jr. gave his life to open the gate. Let us lead our lives so that we will inspire others, only then, can we walk through that gate together.

**SCR 4006:** A concurrent resolution urging Congress to enact legislation to allow farm and ranch risk management (FARRM) accounts and to consider limiting the size of the accounts rather than the time funds may be held in the accounts.

**SCR 4007:** A concurrent resolution designating Senate and House employment positions and fixing compensation.

Was read the first time and referred to the Committee.
