## ENGROSSED HOUSE BILL NO. 1001

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the  
2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota  
3 Century Code, relating to the salaries of the governor and lieutenant governor.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
6 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in  
7 the state treasury, not otherwise appropriated, to the office of the governor for the purpose of  
8 defraying the expenses of the governor, for the biennium beginning July 1, 2001, and ending  
9 June 30, 2003, as follows:

17 **SECTION 2. APPROPRIATION - AUTHORIZATION - GOVERNOR'S OFFICE.** The  
18 governor's office may receive and expend any federal or private funds which are hereby  
19 appropriated which become available during the biennium beginning July 1, 2001, and ending  
20 June 30, 2003.

21 **SECTION 3. AMENDMENT.** Section 54-07-04 of the 1999 Supplement to the North  
22 Dakota Century Code is amended and reenacted as follows:

23 **54-07-04. Salary of governor.** The annual salary of the governor is ~~seventy-six~~  
24 eighty-five thousand eight five hundred seventy-nine six dollars through June 30, ~~2000~~ 2002,

1 ~~seventy-eight and eighty-seven thousand four hundred seventeen sixteen~~ dollars through  
2 ~~December 31, 2000, and eighty three thousand thirteen dollars~~ thereafter.

3 **SECTION 4. AMENDMENT.** Section 54-08-03 of the 1999 Supplement to the North  
4 Dakota Century Code is amended and reenacted as follows:

5 **54-08-03. Salary of lieutenant governor.** The annual salary of the lieutenant  
6 governor is ~~sixty-three~~ sixty-six thousand ~~one~~ three hundred ~~eighty-three~~ eighty dollars through  
7 June 30, ~~2000~~ 2002, and ~~sixty-four~~ sixty-seven thousand ~~four~~ seven hundred ~~forty-seven~~ eight  
8 dollars thereafter.
