1 A BILL for an Act to create and enact section 23-27-04.5 of the North Dakota Century Code,
2 relating to the creation of a quick-response unit service conversion pilot program; to amend and
3 reenact sections 23-27-01, 23-27-02, 23-27-03, 23-27-04, 23-07-04.1, 23-27-04.2, 23-27-04.3,
4 and 23-27-04.4 of the North Dakota Century Code, relating to licensure of emergency medical
5 services operations; to provide an appropriation; and to provide an expiration date.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Section 23-27-01 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **23-27-01. Licensing of ambulance services - Exception - Waiver.** ~~No surface~~
10 ~~ambulance~~

11 1. The state department of health shall license emergency medical services
12 operations. After June 30, 2001, the department may limit the issuance of a
13 license for any new emergency medical services operation based on the needs of
14 the service area.

15 2. Emergency medical services, as hereinafter defined, may not be advertised or,
16 offered, or provided to the public unless the operator of such service the services
17 is licensed as an emergency medical services operation by the state health council
18 department. A license for operators an operator of ambulance service an
19 emergency medical services operation is nontransferable and the operator must be
20 separately licensed for each ambulance service which he operation that operator
21 operates. Each ambulance service which operation that is headquartered or
22 dispatched from a separate location must be considered a separate ambulance
23 service operation; however, an operation with a single headquarters site may
24 dispatch vehicles and personnel from more than one location if calls requesting

1 services are received and orders for vehicle dispatch are made at the single
2 headquarters site.

3 3. The provisions of this chapter do not apply to an operator from another state who is
4 headquartered at a location outside of this state and transports patients across
5 state lines, but ~~no such~~ the operator will be permitted to may not treat patients
6 within this state or pick up patients within this state for transportation to locations
7 within this state, except as provided ~~through regulations~~ by rule.

8 4. The state health council shall ~~provide through regulations~~ adopt rules for special
9 licenses and waiver provisions for an operator of ~~a surface ambulance service~~ an
10 emergency medical services operation intended for industrial sites not available to
11 the general public.

12 **SECTION 2. AMENDMENT.** Section 23-27-02 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **23-27-02. Definition of ~~surface ambulance~~ emergency medical services.** For the
15 purpose of this chapter, "~~surface ambulance~~ emergency medical services" means ~~any use of a~~
16 ~~publicly or privately owned vehicle upon the streets or highways of this state for the~~ medical
17 stabilization or transportation of persons who are sick, injured, wounded, or otherwise
18 incapacitated or helpless by any person who ~~either holds himself out to the public for such a~~ as
19 being in that service or who regularly provides ~~such a~~ that service. The term includes basic life
20 support ambulance services, advanced life support ambulance services, and quick-response
21 unit services.

22 **SECTION 3. AMENDMENT.** Section 23-27-03 of the 1999 Supplement to the North
23 Dakota Century Code is amended and reenacted as follows:

24 **23-27-03. License fees.** The fee for a license to operate an emergency medical
25 services operation and perform ~~ambulance~~ emergency medical services must be set by the
26 state health council at a sum of not more than twenty-five dollars annually, as may be required
27 to defray the costs of administration of the licensing program. All license fees must be paid to
28 the state department of health and deposited with the state treasurer and credited to the state
29 general fund.

30 **SECTION 4. AMENDMENT.** Section 23-27-04 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **23-27-04. Standards for operators.** ~~No surface ambulance service~~ An emergency
2 medical services operation within this state may ~~be operated~~ not operate unless the ~~service~~
3 operation is licensed in accordance with this chapter and ~~regulations promulgated~~ rules
4 adopted by the state health council. The ~~regulations~~ rules must include, ~~but not be limited to,~~
5 ~~the following:~~

- 6 1. Time when ~~ambulance service shall~~ operator's services must be available.
- 7 2. Type of driver's license needed for drivers of ~~ambulance~~ ground vehicles.
- 8 3. Training standards for ~~ambulance driver and attendant~~ operation personnel.
- 9 4. Equipment ~~needs and equipment certification~~ and ground vehicle standards.
- 10 5. Annual license fees.
- 11 6. Number of personnel required for each ~~ambulance~~ run.
- 12 7. Such other requirements as may be found necessary to carry out the intent of this
13 chapter.

14 **SECTION 5. AMENDMENT.** Section 23-27-04.1 of the 1999 Supplement to the North
15 Dakota Century Code is amended and reenacted as follows:

16 **23-27-04.1. Emergency care or services rendered by officers, employees, or**
17 **agents of ~~prehospital~~ emergency medical ~~service~~ services operations - Physician**
18 **medical direction.** ~~No~~ Any officer, employee, or agent of ~~any prehospital~~ an emergency
19 medical ~~service~~ services operation and ~~no~~ any physician licensed in this state who provides
20 medical direction to ~~any prehospital~~ an emergency medical ~~service~~ services operation, who is a
21 volunteer, who in good faith renders emergency care, services, or medical direction, is not
22 liable to the recipient of the emergency care, services, or medical direction for any civil
23 damages resulting from any acts or omissions by the person in rendering the emergency care,
24 services, or medical direction provided the person is properly trained according to law. For the
25 purpose of this section, "volunteer" means an individual who receives no compensation or who
26 is paid expenses, reasonable benefits, nominal fees, or a combination of expenses, reasonable
27 benefits, and nominal fees to perform the services for which the individual volunteered,
28 provided that the fees do not exceed twenty-four hundred dollars in any calendar year. For a
29 volunteer ~~physicians~~ physician providing medical direction to ~~prehospital~~ an emergency
30 medical services operation, the twenty-four hundred dollar maximum fees amount is ~~to be~~
31 calculated separately for each ~~prehospital~~ emergency medical ~~service~~ services operation for

1 which the physician volunteered medical direction. This section does not relieve a person from
2 liability for damages resulting from the intoxication, willful misconduct, or gross negligence of
3 the person rendering the emergency care or services.

4 **SECTION 6. AMENDMENT.** Section 23-27-04.2 of the 1999 Supplement to the North
5 Dakota Century Code is amended and reenacted as follows:

6 **23-27-04.2. ~~Prehospital-emergency~~ Emergency medical services - State**
7 **assistance.** The state department of health shall assist in the training of personnel of certain
8 ~~prehospital~~ emergency medical services operations as determined by the department and
9 financially shall assist certain ~~prehospital~~ emergency medical services operations as
10 determined by the department in obtaining equipment. Assistance provided under this section
11 must be within the limits of legislative appropriation. The department shall adopt criteria for
12 eligibility for assistance in the training of personnel of various types of ~~prehospital~~ emergency
13 medical services operations. To qualify for financial assistance for equipment, ~~a prehospital an~~
14 emergency medical ~~service~~ services operation shall certify, in the manner required by the
15 department, that the ~~service~~ operation has fifty percent of the amount of funds necessary for
16 identified equipment acquisitions. The department shall adopt a schedule of eligibility for
17 financial assistance for equipment. The schedule must provide for a direct relationship between
18 the amount of funds certified and the number of responses during the preceding calendar year
19 for the purpose of rendering medical care, transportation, or both, to individuals who were sick
20 or incapacitated. The schedule must require that as the number of responses increases, a
21 greater amount of funds certified is required. The schedule must classify responses and the
22 financial assistance available for various classifications. The department may establish
23 minimum and maximum amounts of financial assistance to be provided ~~a prehospital to an~~
24 emergency medical ~~service~~ services operation under this section. If applications for financial
25 assistance exceed the amount of allocated and available funds, the department may prorate the
26 funds among the applicants in accordance with criteria adopted by the department. No more
27 than one-half of the funds appropriated by the legislative assembly each biennium and
28 allocated for training assistance may be distributed in the first year of the biennium.

29 **SECTION 7. AMENDMENT.** Section 23-27-04.3 of the 1999 Supplement to the North
30 Dakota Century Code is amended and reenacted as follows:

1 **23-27-04.3. Emergency medical services personnel training, testing, certification,**
2 **licensure, and quality review.** The state health council shall adopt rules prescribing minimum
3 training, testing, certification, licensure, and quality review standards for emergency medical
4 services personnel. Rules adopted must include a definition of minimum applicable standards,
5 a definition of emergency medical services personnel, provide for a mechanism for certifying or
6 licensing persons who have met the required standards, and provide a mechanism to review
7 and improve the quality of care rendered by emergency medical services personnel. Quality
8 review and improvement information, data, records, and proceedings are not subject to
9 subpoena or discovery or introduction into evidence in any civil action.

10 **SECTION 8. AMENDMENT.** Section 23-27-04.4 of the 1999 Supplement to the North
11 Dakota Century Code is amended and reenacted as follows:

12 **23-27-04.4. Supervision of certified or licensed emergency service hospital**
13 **personnel.** Certified or licensed emergency medical technicians-intermediate and paramedics,
14 who are employed by a hospital and who are working in a nonemergency setting are under the
15 supervision of the hospital's patient services management.

16 **SECTION 9.** Section 23-27-04.5 of the North Dakota Century Code is created and
17 enacted as follows:

18 **23-27-04.5. (Effective through June 30, 2003) Quick-response unit service**
19 **conversion pilot program.** The department shall create and implement a pilot program that
20 creates incentives for basic life support ambulance services and advanced life support
21 ambulance services to convert to quick-response unit services. The program is limited to a
22 maximum of twenty ambulance service participants and must provide for an annual financial
23 incentive of a five thousand dollar equipment grant for each participating ambulance service.

24 **SECTION 10. APPROPRIATION.** There is appropriated out of any moneys in the
25 general fund in the state treasury, not otherwise appropriated, the sum of \$200,000, or so much
26 of the sum as may be necessary, to the state department of health for the purpose of funding
27 the quick-response unit service conversion pilot program, for the biennium beginning July 1,
28 2001, and ending June 30, 2003.
